Pursuant to Section 1128 and Section 1902(a)(39) of the Social Security Act, the Medicaid Program will not reimburse a provider for any services rendered or that were ordered/prescribed by a sanctioned (e.g., suspended, terminated, excluded) provider. The effect of the provider's exclusion precludes them from furnishing, ordering, or prescribing items or services to any Medicaid beneficiary. Claims for services ordered/prescribed by a sanctioned provider with dates of service or dispensing after the effective date of this bulletin, or subsequent updates, will be rejected with an edit code of 364. Refills of prescriptions written by a sanctioned provider must not be dispensed beyond the effective date of the bulletin. Claims for services ordered/prescribed by a provider for whom sanctions have been removed will be honored retroactively to the end-date of the sanction period.

Special Billing Instructions

For customized durable medical equipment, the equipment must be authorized and/or ordered prior to the effective date of the notifying bulletin. When billing for these items, the order date must be indicated as the date of service and the delivery date noted in the remarks area of the invoice.

List of Sanctioned Providers

In order to assure providers receive timely notification regarding sanctioned providers, a notifying bulletin including a cumulative list of sanctioned providers will be printed twice a year. Other notifying bulletins showing additions and deletions to the sanctioned provider list will be issued on a monthly basis. A cumulative list of sanctioned providers is attached to this bulletin.

A copy of the cumulative list is also available on the MDCH website at: www.michigan.gov/mdch. That list will also be updated semi-annually.

Manual Maintenance

Retain this bulletin for future reference.

Discard the list of Sanctioned Providers issued as bulletin MSA 05-46, dated October 2005. Providers should also discard bulletins MSA 06-03 and MSA 06-13.
