Subject: Update to Physician Primary Care Rate Eligibility

Effective: January 1, 2018

Programs Affected: Medicaid, Healthy Michigan Plan, MI Child

NOTE: Implementation of this policy is contingent upon approval of a State Plan Amendment by the Centers for Medicare & Medicaid Services.

This bulletin is being issued in response to the Michigan Department of Health and Human Services (MDHHS) Fiscal Year (FY) 2018 budget appropriations of Public Act 107 of 2017. In compliance with the language and intent of Section 1801 of the Act, physicians with the primary specialty designation of general medicine will be eligible to qualify as a primary care provider for the purpose of increased payment.

For dates of service on and after January 1, 2018, MDHHS will apply an increased payment rate to eligible primary care services provided by qualified physicians whose Community Health Automated Medicaid Processing System (CHAMPS) Provider Enrollment profile is reflective of the primary specialty designation of family medicine, general internal medicine, pediatric medicine and general medicine. Payment will be made on the qualified procedure codes as published in a separate fee schedule on the MDHHS website at www.michigan.gov/medicaidproviders >> Billing & Reimbursement >> Provider Specific Information >> Physicians/Practitioners/Medical Clinics. Other provider eligibility criteria remain unchanged.

For additional information related to provider eligibility and primary care physician services subject to the enhanced primary care rate, refer to the Practitioner Chapter of the Medicaid Provider Manual, Practitioner Reimbursement Appendix.
