**Subject:** Increased Fee Screens for Preventive Medicine Visits and Specific Newborn Care Codes

**Effective:** October 1, 2008

Programs Affected: Medicaid, Adult Benefits Waiver, Children's Special Health Care Services, Plan First!

This bulletin is being issued in response to Sections 1636 and 1791 of the Michigan Department of Community Health's (MDCH) fiscal year 2009 budget boilerplate contained in Public Act 246 of 2008.

In response to these requirements, the department will increase Medicaid fee screens for preventive medicine visits and specific newborn care codes. Effective for dates of service on or after October 1, 2008, the following fee screen increases will be implemented:
