Subject: New Service Coverage for the Plan First! Program

Effective: July 1, 2008

Programs Affected: Plan First!

The Michigan Department of Community Health (MDCH) recently received approval from the Centers for Medicare and Medicaid Services to add a new covered service to the Plan First! Program. Effective for dates of service on or after July 1, 2008, the Plan First! Family Planning Waiver will begin covering the Current Procedural Technology (CPT) code 58340, which is defined as the catheterization and introduction of saline or contrast material for saline infusion sonohysterography or hysterosalpingography. This procedure can be completed for the purpose of verifying the sterilization status 90 days after the completion of the Essure procedure.

When billing family planning services for Plan First! beneficiaries, providers must include at least one of the appropriate diagnoses in the V25 diagnosis code series range on the claim. A claim that does not include a V25 diagnosis code will not process for payment. For more information regarding the Plan First! Program, providers may review the Plan First! Family Planning Waiver Chapter in the Medicaid Provider Manual.

The Plan First! Program covers family planning services only. A list of current billable codes are available on the MDCH website at www.michigan.gov/mdch. Click on the Plan First! logo at the bottom left hand side of the page. On the Plan First! page, click on the "Plan First! Family Planning Codes" link located in the Covered Services section. In addition, this website also contains a direct link to the new on-line beneficiary application, eligibility information, and other Plan First! program related information.
