Dear Provider:

Pursuant to Section 1607 of Public Act 246 of 2008, the Medicaid Services Administration (MSA) has recently promulgated new policy concerning the mandatory enrollment of pregnant women into managed care (Bulletin MSA 08-42). Effective October 1, 2008, pregnant women who become eligible for Medicaid will be required to enroll in a Medicaid Health Plan (MHP) operating in their county. Women who do not choose a health plan will be automatically assigned to an MHP in their county.

As Medicaid managed care has grown and developed in Michigan, MHP provider networks have become more extensive and sophisticated. MHPs have developed clear and concise policies for the provision of out-of-network services to maintain continuity of care. With these changes, the Michigan Department of Community Health (MDCH) determined that pregnant women can be made a mandatory managed care population without impairing the doctor-patient relationship.

MDCH is contacting you because of the vital role that obstetrical providers play in the implementation of this policy. In order for Medicaid beneficiaries to establish and maintain a consistent relationship with their prenatal care provider through the duration of the pregnancy, it is important that you work collaboratively with the MHP in your area. In the event a pregnant beneficiary wishes to seek and/or continue prenatal care with a physician not in their MHP network, the MHP will reimburse claims for prenatal care (including delivery fees) submitted by out-of-network providers. However, it will be necessary for the out-of-network physician to provide the MHP with minimal information necessary to process the claim without interruption.

If a beneficiary is newly eligible for Medicaid and not enrolled in an MHP, you may encourage her to enroll in a plan that you participate with as an in-network provider. If you have an established doctor-patient relationship with a pregnant woman who is enrolled with an MHP that you do not contract with, please contact the MHP.
