Dear Provider:

The purpose of this letter is to remind providers that they must use a diagnosis code from the V25 diagnosis code series (Encounter for contraceptive management) from the International Classification of Diseases 9th Revision, Clinical Modification (ICD-9-CM), as the primary diagnosis for services provided to Plan First! beneficiaries.

For professional claims billed, a V25 diagnosis must be the primary diagnosis on the claim and the first diagnosis pointer on the claim line must point to a V25 diagnosis code on the claim in order to receive reimbursement for each service. For Institutional claims billed, a V25 diagnosis must be the principle diagnosis on the claim. Without a V25 diagnosis code as the primary/principle code, the Plan First! claim will reject.

On the Plan First! page, click on the "Plan First! Family Planning Codes" link located in the Covered Services section. In addition, the Plan First! website also contains a direct link to the new on-line beneficiary application, eligibility information, and other Plan First! program related information.

Plan First! services are limited to those family planning services as identified in the Family Planning Waiver Chapter of the Medicaid Provider Manual. Should a beneficiary need additional services beyond what is covered under Plan First!, you may either provide the services and work with the beneficiary to identify payment options, or refer the beneficiary to access primary care services at the nearest community health center, or Federally Qualified Health Center (FQHC). A list of FQHC's can be found on the Plan First! web page located on the MDCH web site.
