## CSHCS Local Advisory Council (CLAC)

LHD professional staff members are appointed to work with CSHCS to develop, implement, evaluate and revise components of the CSHCS program. It is comprised solely of staff members from local health departments. The members represent various geographic areas of the state, as well as rural, urban, small and large. This committee meets every other month via teleconference.*
