Designation Subcommittee Meeting Minutes Tuesday, March 5, 2019 Bureau of EMS, Trauma and Preparedness

Call to order in open meeting at 9:07 a.m. and public notification was posted.

Approval of Minutes: The minutes from the January 8, 2019 meeting were approved.

New Business:

- Currently 85 facilities are designated, 8 site visits are scheduled, three of which are focused visits, and 31 hospitals have submitted a request for verification and are in the queue for a site visit.
- The May 7, 2019 Designation Subcommittee meeting will include three in-state verification/designation applications, two focused visit reports and up to 4 ACS verified designation applications.
- The State Trauma Advisory Committee (STAC) and the Department have approved revised criteria for CD 11-3. Previously, the criteria required a physician anesthesiologist to be the liaison to the trauma program for level III trauma facilities. The revised criteria now states that a "provider of anesthesia" must be the liaison in level III trauma facilities. All relevant documents have been updated and the site reviewers have been notified.
- A level IV trauma facility asked if the Trauma Medical Director (TMD) is required to work in a clinical setting. When the question came in, there was no published documentation stating the TMD must work in a clinical setting for a level IV trauma facility. At the January meeting, STAC was presented with a draft recommendation which stated, "The Trauma Medical Director is required to participate in the care of trauma patients at the facility." This statement was approved by STAC and is now posted on the state trauma website under FAQ.
- ➤ The Division of EMS & Trauma are planning an MCA and Trauma conference. The MCA conference will be on October 22nd and the Trauma conference will be on October 23rd. There will be a Regional Leadership Summit held as a dinner event on the evening of the 22nd. The location for the conferences is Crystal Mountain in Thompsonville.

A motion was made and approved to move into closed session at 9:13 a.m. and public notification was posted.

Review of Designation Applications: The Designation Subcommittee reviewed and discussed the designation applications during the closed session.

A motion was made and approved to move into open session 10:03 a.m. and public notification was posted.

Vote: The committee moved back into open session where a motion was made and seconded for the subcommittee's recommendation regarding designation. The facilities are listed below:
