Statewide Summary

Overview

The data that are presented in this section were provided by CMHSPs as required by the FY 2014 MDCH/CMHSP contract. Cost data were collected for the reporting period October 1, 2013 to September 30, 2014 and submitted to MDCH by March 2, 2015. The data in this section represent the total statewide CMHSP costs for each of the three consumer populations (Adults with Mental Illness, Children with an Emotional Disturbance, and Persons with Developmental Disability) by service category. All Department approved services are included.
