## What is the SUD Health Home?

A “health home” is not a place to live—it’s a model of care that coordinates your health and social needs. You’ll receive enhanced recovery-centered services, as well as a personalized plan for your team of providers. Participation is voluntary.

### What are the objectives?

Through the delivery of core health home services, the program’s overarching goal is to:

- Improve patient outcomes and long-term recovery.
- Provide efficient, coordinated, and integrated behavioral and physical health care.
- Increase access to health care.
- Increase hospital post-discharge follow-up.
- Create a continuum of care.
- Reduce health care costs.
- Reduce unnecessary hospital admissions and readmissions.
- Reduce unnecessary emergency room visits.
- Increase the use of health information technology.

## Am I eligible for the program?

You may be eligible for the SUD Health Home if:

- You have been diagnosed with Opioid Use Disorder, Alcohol Use Disorder or Stimulant Use Disorder.
- You have Medicaid, Healthy Michigan Plan, Freedom to Work, Healthy Kids Expansion or MICHild.

Should you need to opt out of the SUD Health Home, you can do so at any time with no impact on your current health care coverage.
