Dear Tribal Chair and Health Director:

**RE:** Submission of a Medicaid State Plan Amendment (SPA) for Psychiatric Residential Treatment Facilities (PRTF)

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a Medicaid SPA and Alternative Benefit Plan (ABP) amendment request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of the SPA request is to allow coverage of PRTFs for individuals up to and through age 21. MDHHS expects this change will have a positive impact on Native American children and adolescents who require state hospital-level behavioral health care but who do not require the safety and security of an inpatient setting. The anticipated effective date of this SPA is November 1, 2022.

There is no public hearing scheduled for this SPA request. Input regarding these amendments is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss these SPAs, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
