Dear Tribal Chair and Health Director:

RE: State Plan Amendments Regarding Targeted Case Management Services for Recently Incarcerated Individuals

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment (SPA) and a corresponding alternative benefit plan (ABP) SPA request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of the SPAs is to provide targeted case management services for any individual who is 19 years of age and older; meets Medicaid eligibility requirements; has at least one chronic or complex physical or behavioral health care need; and was a recent inmate or was involuntarily residing in a prison, jail, detention facility, or other penal setting. The SPAs will affect Native Americans who were a recent inmate or were involuntarily residing in a prison, jail, detention facility, or other penal setting by potentially improving access to care. The anticipated effective date of the SPAs is January 1, 2020.

There is no public hearing scheduled for the SPAs. Input regarding the SPAs is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the SPAs, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
