MDHHS is required by MCL 330.2072 to endorse a training curriculum for mental health professionals other than psychiatrists or psychologists who provide juvenile competency exams. Courts ensure that qualified juvenile forensic mental health examiners meet legislative standards to perform juvenile competency evaluations.
