Dear Tribal Chair and Health Director:

RE: Notice of Intent to Submit a State Plan Amendment (SPA) to Allow Tribal 638 Pharmacies to Receive the All-Inclusive Rate for Prescriptions

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a Medicaid SPA request to the Centers for Medicare & Medicaid Services (CMS).

The proposed SPA would allow Tribal 638 pharmacies to be reimbursed at the Indian Health Services (IHS) per visit outpatient rate published annually in the Federal Register. Reimbursement at the IHS rate (also known as the all-inclusive rate) would be allowed for each prescription provided to Native American and non-Native American Medicaid and Healthy Michigan Plan beneficiaries served at the Tribal 638 pharmacy. This SPA positively impacts Native Americans by increasing access to pharmacy services. The anticipated effective date of this SPA is October 1, 2021.

There is no public hearing scheduled for this SPA. Input regarding this SPA is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the SPA, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
