1. **Welcome & Introductions** - Kelli welcomed everyone. Everyone introduced themselves. Kelli says the recorders have been sent to Anthony Muller.
Review Minutes - The minutes of February 19, 2021, are approved.

2. **Updates – Angie Smith-Butterwick**
 - **COVID-19** – Return to work has been approved and mask wearing guidelines were explained.
 - **Supplemental Block Grant Notice of Award** – Covid-19 Supplemental Block Grant received and approved. Must follow the usual Block Grant rules, such as priority populations, and corrections, to name one. Other areas include:
 - ✓ **Opioid Health Homes** has been expanded to include additional areas, to a substance use disorder (SUD) health home in general. Working to implementing some pregnant and parenting health homes.
 - ✓ **Prevention Outreach**, purchasing the OPI safe application (APP) called OPI rescue record when Naloxone is being used.
 - ✓ **Recovery Capital** assessment in recovery housing, which will assist in updating; deficits and improvements to help funders to determine technical assistance needs to recovery homes in which courses are also being designed.
 - ✓ **McBAP Certification Exams** for prevention and treatment and working with the *Michigan Certification Board for Addiction Professionals (McBAP)* to create/develop these text preps for exams for both prevention and treatment.
 - ✓ **Grandfathering Program:** this program is in a holding pattern due to the loss of their Executive Directors.

 - **American Recovery Act** – Received an additional 46 M dollars in Block Grant funds. The plan is due July 2, 2021. Working with *PIHPs* and other stakeholder groups to determine

how those funds will be used. They also follow Block Grant rules and *Code of Federal Regulation (CFR) Guidelines*. More to come.

- **COVID Supplemental Block Grant** – We have until March 15, 2023, to spend the COVID supplemental funds and September 1, 2025, to spend the ARPA Supplemental Block Grant. Also explained was the Block Grant reshuffling and what is taking place during the process.
- **Medicaid Telehealth** – Explained what has taken place regarding Medicaid Telehealth. Allowances will be taking place after COVID. Mentioned the various types of telehealth hubs that will be available, as well as other features.
- **Naloxone Tracking** – For Naloxone tracking, an OPI Rescue APP has been created which we will be purchasing for the SOM for users who use Naloxone. This APP will track Naloxone use.
- **No Cost Extension** – When the *MYTIE* grant is over, we will be able to apply for a no-cost extension that will be due at the end of July 2021. Other aspects of this were also communicated.

3. Provider Updates

- **Great Lakes Recovery** – *Derrick DePietro*
In the middle of therapists getting trained. We were able to hire another therapist. Seeing post pandemic, calls are coming in for various service needs. Looking to improve on *Global Appraisal of Individual Needs (GAIN)*.
- **Macomb** – *Steffanie Boudreau-Thomas - N/A*
- **Wedgewood** – *Jen Tornga*
Slow in terms of *Government Performance and Results Act (GPRA)*. Looking forward to more Face-to-face visits, as the client feels more engaged.
- **Catholic Human Services (CHS)** – *Sara Hegg*
Steady. Referrals are down since April. Limited referrals due to probation.
- **Detroit Recovery Center** - *Crystal Dussia*
Mr. Kanzoni said Crystal is going through training. Crystal explains we have partnered with *Alternative for Girls*. Waiting for the recorders to finish the GAIN. Kelli said the recorders will be sent out tomorrow.

4. Updates – Peer Recovery/FAN Meetings – *Lauren Mo*

Not much going on. If anyone knows of any recovery information, please let Lauren know. Recovery Walk: Crystal says it will take place September 11, 2021.

5. Curriculum – *Lauren Mo*

Timeline is being set up for the training. We have contracted with KWB Strategies and are working with Kelly, who has extensive training experience developing student and training manual components. Plan to complete the peer coach application and exam; to be complete by mid to late July. Will keep everyone posted.

6. Recovery High - Kelli Dodson

Received letter of interest and keeping a list of frequently asked questions (FAQ) and will send to those of you who are interested. Angie explains what *Recovery High* is and how it will be used; including funding, used by the end of September. Those interested, please send your requests to Kelli at Dodsonk@michigan.gov. There is 600K for interested entities. Unspent MYTIE funds to be used for Recovery community centers for young people and writing in the proposal that is due in July. Inquiry about the Letter of Interest and an answer was communicated.

7. EGrAMS - Kelli Dodson
