## Work Plan Objective Progress and Highlights:

### Injury Prevention

**Objective:** By December 2020, the Region 7 Trauma Network will have re-assembled the Education and Injury Prevention Committee membership with a goal of ensuring representation from all hospitals in the Region and will have created and published to its membership an annual schedule of committee meetings.

**Progress:** Completed

**Objective:** By December 2020, the Region 7 Education and Injury Prevention Committee will have created, and published to its membership, an annual schedule of committee meetings. By June 2021, the Region 7 Education and Injury Prevention Committee will create a resource document identifying evidence-based injury prevention programs available in the Region.

**Progress:** Completed

**Objective:** By June 2021, the Region 7 Education and Injury Prevention Committee will create a resource document identifying evidence-based injury prevention programs available in the Region.

**Progress:** Draft completed for presentation at June 2021 RTC meeting. Item moved to October 2021 agenda.

### Communications

**Objective:** By December 2020, the Region 7 Infrastructure and Medical Oversight Committee will have established an ad hoc “communications committee” composed of representatives from hospitals, life support agencies, the EMS system, the Region 7 Health Care Coalition, and the Region 7 Trauma Network.

**Progress:** Plans in place to build committee in concert with Region 7 Health Care Coalition as part of their proposed MCA/EMS subcommittee allowing RTN physicians and surgeons more time to focus on the RPSRO. Ongoing.

**Objective:** By December 2021, the Region 7 ad hoc communications committee will have drafted a regional communications procedure for arranging patient inter-facility transfers which will include redundant procedures in the event of communication system failure.

**Progress:** On schedule to complete by due date.

### Infrastructure

**Objective:** By December 2021, the Infrastructure and Medical Oversight Committee will have established a written process for enhancing and ensuring collaboration of MCA directors and trauma medical directors in the development and periodic review of protocols for pre-hospital providers providing care to trauma patients.

**Progress:** Infrastructure and Medical Oversight Committee placed within the RPSRO as an ad hoc group tasked with this objective. Plan for protocol review on December 2021 agenda.

### Regional Performance Improvement

**Objective:** By June 2021, the RPSRO will begin utilizing routine reports generated using regional trauma data and other databases to analyze and evaluate performance measures.

**Progress:** RPSRO template review was made a part of the quarterly RPSRO agenda.

### Continuum of Care

**Objective:** By March of 2021, the RTN will have extended invitations to rehabilitation services to participate as members of the Region 7 RTAC.

**Progress:** Partners are in the process of developing a list of SNFs and ECFs in the Region with hopes of reaching out with invitations to participate in R7 activities by conclusion of 2022.

### Trauma Education

**Objective:** By June 2021, the Region 7 Injury Prevention and Education Committee will have an approved process to inform or educate all personnel on new protocols and/or treatment modalities in Region 7.

**Progress:** Draft document completed for review at 4th quarter meeting.

### Other relevant information:

The RTN, RTAC, and RMCAN continue to meet every other month. Attendance since beginning of pandemic steady. Still many competing priorities for most hospitals.
