Dear Tribal Chair and Health Director:

RE: Disproportionate Share Hospital (DSH) Process Consolidation

This letter, in compliance with Section 1902(a)(73) and Section 2107(e)(1)(C) of the Social Security Act, serves as notice to all Tribal Chairs and Health Directors of the intent by the Michigan Department of Health and Human Services (MDHHS) to submit a State Plan Amendment (SPA) request to the Centers for Medicare & Medicaid Services (CMS).

The purpose of this SPA is to consolidate the DSH process into two steps. Eliminating the interim settlement step of the existing DSH process will allow MDHHS to complete the final DSH calculation with greater timeliness and accuracy. MDHHS expects this change to have little or no impact on Native American beneficiaries, tribal health clinics, and urban Indian organizations. The anticipated effective date of this SPA is December 1, 2021.

There is no public hearing scheduled for this SPA. Input regarding this SPA is highly encouraged, and comments regarding this notice of intent may be submitted to Lorna Elliott-Egan, MDHHS Liaison to the Michigan tribes. In addition, MDHHS is offering to set up group or individual consultation meetings to discuss the Amendment, according to the tribes' preference. Consultation meetings allow tribes the opportunity to address any concerns and voice any suggestions, revisions, or objections to be relayed to the author of the proposal.
