1. **Welcome & Introductions** - Kelli welcomed everyone and Brooke from maternity leave. Everyone introduced themselves.
 - a. Kelli says the recorders have been sent to Anthony Muller.
 - b. The minutes of May 21, 2021 were approved.
2. **COVID 19 update** – *Angie Smith-Butterwick- Tabled*
3. **No Cost Extension** – *Kelli Dodson*
Due the end of next week. Used for a six-month extension to finish the *Government Performance and Results Act (GPRAs)* to meet the goal set. Waiting to hear if MYTIE will be offered again from the *Substance Abuse and Mental Health Services Administration (SAMHSA)*. Andrea from SAMHSA will keep us updated on the progress as to the continuation of MYTIE. Will inform every one of the status as information becomes available. As of now, finish your GPRAs. No questions.
4. **Provider Update**
 - a. **Great Lakes** - *Derrick DePietro*
Progress is slow. Working to get caught up. Fewer kids than were MYTIE eligible and now we have waitlists. Working with the therapist to get caught up. Follow-ups are coming along.
 - b. **Macomb** - *Stephanie Budreau-Thomas*
A few more clients to complete; 21 out of 25. Conducting adolescent outreach through the Summer due to the backlog of kids coming in.
 - c. **Wedgewood** - *Jennifer Tornga*
Through June Intensive Outpatient Treatment (IOP) groups start in person. Conducted strategies for getting kids to come in for Jennifer to come in and do intake. Two in July; working to increase numbers.
 - d. **Catholic Human Services** - *Tabled*
 - e. **Growth Works** – *Deleted*
 - f. **Detroit Recovery Center** - *Zakiya Aniapam*
Gathering resources and collaborations. Partnerships working with Children’s Center, Southwest Housing Solutions, among others. Looking to connect with food pantries, churches, Detroit Public Schools, et al. Still conducting clinical work with adults. Kelli says to please let her know if assistance is needed.
5. **GPRAs** – *Brooke Rodriguez*

- a. Updates: Reporting numbers 47 intakes FY four; 40 percent on the lower side, at 51 percent for follow-up rates. Encourages everyone to keep doing follow-ups. Spoke on gift cards and their status. Spend all gift cards. No more cards will be ordered.
- b. Quarter three infographic is ready and will be sent to everyone by e-mail. This will be the last quarterly infographic.
