

# REPORT ON THE DISTRIBUTION OF RURAL AND SOLE COMMUNITY BASED HOSPITAL FUNDING

(FY2015 Appropriation Bill - Public Act 252 of 2014)

**April 1, 2015**

**Section 1866:** (1) From the funds appropriated in part 1 for hospital services and therapy, \$10,000,000.00 in general fund/general purpose revenue and any associated federal match shall be awarded to hospitals that meet criteria established by the department for services to low-income rural residents. One of the reimbursement components of the distribution formula shall be assistance with labor and delivery services. (4) The department shall report to the senate and house appropriations subcommittees on community health and the senate and house fiscal agencies on the distribution of funds referenced in subsection (1) by April 1 of the current fiscal year.
