Current Legislation Review

- [HB 4242](#) – Storage of Medical Records Tab 2
  - This was previously looked at in 2023. This is regarding the offsite storage of electronic medical records and mandates this would need to be in the United States or Canada. EMSCC took no action last time. This would be an issue between the agency and the ePCR vendor. The group discussed. It was suggested that this should go to the data subcommittee for their review.
  - **Motion to refer to EMSCC with no specific action and recommend it go to the data committee for further review (Cummings, Warnemuende). Approved.**
- [SB 154 & 155](#) – Access to Health Care Facilities Tab 3a-b
  - This is intended to focus on issues related to reproductive health. CIP protocols were discussed.
  - **Motion to take no action (Cummings, Sundberg). Approved.**
- [HB 4249](#) – Ambulance Provider Funding for Corrections Tab 4
  - This is retrospective only. It would compensate providers who have already provided services to the Department of Corrections. The group discussed.
  - **Motion to support (Nye, Warnemuende). Approved.**
- [HB 4368](#) – Safe Delivery of Newborns – Safety Device Tab 5
  - No action taken.

- [HB 4417](#) – EMS Access to Opioid Antagonists Tab 6
  - Bruce gave the history of the bill and why it was opposed in the past.
  - **Motion to oppose (Nye, Cummings). Approved.**
