1. **Call to Order:** The meeting was called to order 10:02 a.m. by Bruce Trevithick.
2. **Approval of Agenda and Minutes from November 13, 2023 – Motion to approve (Sundberg, Madden). Approved.**
3. **Current Legislative Review**
  - a. HB 5072 – Storage of Medical Records Tab 2
    - Bruce advised the bill states the records have to be stored in the U.S. or Canada. Alyson asked the group about sending the EPCR to the hospital and if that becomes part of the record and wanted to know if they keep the reports. Ken advised they do keep them, but it still goes in the hospital record. Ken advised these are stored in the cloud. Bruce asked if the cloud is outside the US or Canada. Ken advised it is. The group discussed.
    - **Motion to take no action (Sundberg, Cummings). Approved.**
      - Ken suggested everyone check with their vendors to see where the records are stored.
      - To be forwarded to EMSCC for review.
  - b. HB 5341 & 5342 – Definition of Emergency Vehicle Tab 3a-b
    - This is focused on vehicles responding to MABAS.
    - The group discussed.
    - **No action taken.**

- c. HB 4520 & 4521 – Violence Against Health Care Workers Tab 4a-b
- These bills are law now and Bruce discussed. There is confusion about the language and how it would affect EMS. There is a section on page 6, item 4, that talks about signage. EMS falls under the health care facilities act. It's unclear how the department will enforce but everyone should be prepared. Angela advised she didn't believe EMS was included.
