ACP reflects adults who cannot live independently residing in licensed adult foster care and homes for the aged at end of month.

HH reflects services and payments to individuals who require services to support functioning in a home or independent living facility. **The title Independent Living Services (ILS) has been changed to Home Help (HH) on the Fact Sheet to reflect the change of the program's title from ILS to HH.

APS assists persons age 18 or older who have been or are at risk of being abused, neglected or exploited and who are vulnerable and unable to take the necessary steps to correct their situation

*New referrals refer to a count of unique case numbers with a referral date any time during the month being reported and entered into the system by the 15th of the month being reported.

Child Support Program (For the quarter ending Dec. 31, 2024)

- Child support cases totaled 711,412 at the end of Dec. 31, 2024, which included 792,732 children. Since Dec. 31, 2023, the caseload has decreased by 32,372 cases.
- From Oct. 1, 2024, through Dec. 31, 2024, \$251,052,568 was distributed directly to families; \$18,868,262 was distributed to cover
 medical costs for children; and \$4,097,408 was collected to reimburse federal and state governments for public assistance provided to
 families.
- Past due support that was distributed from Oct. 1, 2024, through Dec. 31, 2024, totaled \$64,142,770, which is a decrease of \$4,423,468 over the same period in the preceding year.
- From Oct. 1, 2024, through Dec. 31, 2024, total child support distributions in Michigan totaled \$281,872,927, which is a decrease of \$3,384,849 over the same period in the preceding year.
