

CHALLENGES & NEEDS

- Drug shortages
- Contaminated bone allograft outbreak (#2)
- Patient support
- Language translation/interpretation
- Clinical consultation

DRUG SHORTAGES

- Isoniazid, Rifampin, Rifapentine, Pyrazinamide.
- 5 requests to CDC Stockpile (*Free*)
 - ✓ 4 bottles INH
 - ✓ 111 bottles RIF
 - ✓ CDC *does not* stock Rifapentine
- At least 6 requests to MI Pharm. Assoc.
 (*Retail*)
 - ✓ 35 bottles PZA
 - ✓ 1 bottle INH
- ??? Requests to R & S. (<u>340B</u>) Many LHDs switched to order from R & S but State doesn't get copies of invoices.



CONTAMINATED BONE ALLOGRAFT OUTBREAK #2

- MDHHS TB + CA DPH helped alert CDC of potential outbreak in early July.
- 2 MI pts affected. 1 died, 1 completed treatment.
- Prior outbreak in 2021. MI 8 pts, no deaths.



Second Nationwide Tuberculosis Outbreak Caused by Bone Allografts Containing Live Cells In July 2023, CDC was alerted to a potential tuberculosis (TB) disease outbreak from surgical procedures using bone allograft material contaminated with TB bacteria.




ALLOGRAFT OUTBREAK FALLOUT

- 7/13: Aziyo Biologics Announces Voluntary Recall of Viable Bone Matrix Products
- 8/17: US Rep Debbie Dingell <u>sends formal letter</u> to Directors of FDA and CDC requesting detailed response to outbreak and death of MI patient.
- 8/29: <u>Peters, Stabenow, Moolenaar, Dingell Urge FDA to Issue New Bone Graft Guidance After</u> <u>Tuberculosis Outbreak and Patient Deaths</u>
- 9/6: <u>Aziyo Biologics Rebrands as Elutia to Reflect Strategic Focus on Drug Eluting Biomatrices</u>. Buried in 'Forward Looking Statements': discontinued sales of brand name FiberCel product....market withdrawal of all viable bone matrix products....bankruptcy of Surgalign Holdings, Inc., significant customer....
- 12/12: Moolenaar, Dingell, Correa Introduce Bipartisan Legislation to Stop Tuberculosis Outbreaks
- 2/1/2024: <u>Stabenow, Peters, Moolenaar, and Dingell Introduce Bill to Help Prevent Tuberculosis</u> <u>Infections in Surgical Transplants</u>


PATIENT SUPPORT: INCENTIVES/ENABLERS

- I/E can only be requested / provided by Local Health Departments.


REASONS FOR REQUESTS AND TYPE REQUESTED, FY2023


I/E TRENDS & INDIVIDUAL CASES VS CONTACTS SERVED, PER FISCAL YEAR



CLINICAL CONSULTATION


- 4 TB-expert physicians serving 2-week rotations.
- 34 consultation requests.
- 31 individual patients.
- 12 requests (35%) from Hospital or Health System. 22 requests from Local Health Departments (65%).
- Requests submitted through online short survey, then assigned to consultant on-call.
