- 2. Welcome and Sharing Opportunity
 - a. Members introduced themselves and completed a icebreaker/sharing activity.
- 3. Presentation by Doula Liaison Community Partners: Black Mothers Breastfeeding Association, Focus: HOPE, and Milgwech
 - a. The Community Partners are working with MDHHS on a grant with the Michigan Health Endowment Fund to support doula navigation in the Medicaid program. The project provides numerous supports for doulas including a web-based toolkit for doulas which will include billing resources, frequently asked questions, training, and continuing education opportunities.

 - c. Milgwech shared some additional outreach and support activities that are being done with Indigenous doulas throughout the state including the Upper Peninsula.

- 4. DAC Workgroup Report Out
 - a. Legislative Action and Advocacy

 Workgroup met in December and connected with doulas in Oregon that successfully advocated to increase their Medicaid reimbursement rate to discuss strategies used in that state. The group will assess what can be used in Michigan.

b. Community and Health Plan Relations

- i. The workgroup met in December and met with MDHHS Doula Initiative staff to discuss what staff current efforts include so the workgroup can possibly gap fill and work complementary. The workgroup has been focused on how to strengthen relationships and collaboration between doulas and hospitals, health care providers and community organizations.
- ii. The group met with Priority Health to discuss their current doula enrollment process and provide feedback/make recommendations for improvement.

c. Bylaws & Structure

- The workgroup met in January and is discussing the ongoing structure of the DAC including term limits, size, equitable representation, new members, etc. The workgroup plans to present final recommendations to the full DAC at the March meeting.
- ii. The workgroup is also reaching out to current DAC members who have not been able to attend meetings regularly to see if they are still interested in being part of the council.

d. Doula Mentorship

- i. The workgroup is brainstorming ideas to mentor new doulas to be successful at becoming Medicaid enrolled and being a doula in general. Necessary supports include setting up a successful business, self-care, learning from other doulas, a "day in the life" of a doula education session, skill building, and other ideas. Support could be either 1:1 or group support.
- ii. The "Day in the Life" of a doula presentation could be part of the MDHHS continuing education sessions and be available for all newly trained doulas or people considering a career as a doula.

Background of Doula Initiative

MDHHS is collaborating with Black Mothers Breastfeeding Association, Focus: Hope, and Miigwech Inc., to support doula navigation in the Medicaid program, increase beneficiary access to doula services, and make progress in decreasing infant mortality. These community partners, represent Black and Indigenous communities, and will work alongside MDHHS to develop web-based toolkits that include step-by-step billing resources, frequently asked questions, training and continuing education opportunities, and state department contact information.

Supports & Activities

Develop Doula Medicaid Program Tool Kit

- In 2023 Partners started out Identified barriers with Doula registry application including:
 - the need for doula registry applicants to have access to Microsoft Word to complete the application
 - the burden of the doula's provider information being accessible to the public
 - the usage of unknown acronyms
 - drafted a doula survey to engage doulas to use their experiential knowledge to further identify barriers in the application process
 - created a document that will better help to support community of doulas through the application process
- In 2024 we are in the process of finalizing the toolkit that will include information for training, enrollment, information regarding the MDHHS Doula Initiative and various doula specific resources.

Engage Medicaid Health Plan and make Doula Connections

- Partners attended the Medicaid Health Plan meeting facilitated by the State of Michigan and shared our ongoing efforts with the project and barriers we've heard from doulas around the credentialing & billing process.
- In 2023 Partners had multiple meetings and/or correspondences with Molina, UnitedHealthcare Community Plan, Aetna, Mae and The Doula Network. A Molina & Aetna representative presented accreditation information at the Detroit Community-based Doula Taskforce meeting hosted by BMBFA.
- We are hosting an upcoming Lunch & Learn with Meridian for Doulas to learn about how to becoming credentialed and bill with Meridian.

Supports & Activities

Stakeholder Engagement

- Monthly meetings were held for the Detroit Community-based Doula Taskforce. In these meetings, BMBFA and Focus: HOPE have helped Doulas to better understand the doula registry, SIGMA, NPI, and Medicaid Health Plan Accreditation Packages.
- Partners are in ongoing communication with the community:
 - Miigwech has met with birth workers to provide tech support and tech supplies to community doulas with access barriers and established contacts for information and resources.
 - BMBFA & Focus: HOPE have presented on Medicaid Reimbursement at SEMPQIC's Q3 meeting in 2023.
 - Phone call support to troubleshoot various issues
- Partners have facilitated opportunities for Doulas to network at the '23 MIH Summit, and BMBFA's Motown Experience: Birth & Breastfeeding Conference.
- Focus Hope helped facilitate a watch party with BMBFA. The
 watch party was of the webinar the state of Michigan teaching
 doulas how they could bill and become credentialed through the
 state for Medicaid reimbursement.
- Miigwech shared resources at Indigenous Birth Equity Day in collaboration with Munson Health, Sacred Waters and Emmet & Charlevoix Great Start Collaborative






