 - Languages offered other than English.

Doula Registry Map

- Published January 2024.
- Rationale for not publicly sharing:
 - Specialties.
 - No mechanism to verify licensing, certification, expertise, etc.
 - Information would be shared with families via doula interview or website.
 - Special populations served:
 - Question was misleading and open to broad interpretation.

Addition to Doula Registry Application

Application Revision

• June 2025.

Annual Registry Update

- All doulas on the MDHHS Doula Registry will be offered the opportunity to add this identity to their registry information during annual update in December 2025.
- Full implementation will be complete by February 2026.

Hospital Integration

- Hospital education on doula scope of practice.
- Barriers to serving clients OR, triage, etc.

MDHHS Doula Training Organization Approval Process







Medicaid Doula Policy

 MDHHS, with community input, will continue to review doula training programs, including those created for specific populations such as community-based doula programs, to support cultural and community needs.

Doula Training Expansion (2023)



- Nine organizations written in original policy.
- Need for additional training options was voiced by doula community – prioritized in 2023 expansion.
 - Michigan recognizes the broadest range of doula training organizations nationally.
- Intentional focus on equity and inclusion.
 - Doulas across Michigan and the MDHHS Doula Initiative greatly appreciate the effort of the DAC in this expansion.
- 17 additional organizations approved.
 - Process was paused in October 2023.

Application Window 2025



- MDHHS Doula Initiative shared the application process with all organizations that requested review between 2023 and 2024 (approximately 50 organizations).
- 14 doula training organizations completed the enhanced application and are eligible for review.

Organization Application/Review



Enhanced Application

- Demonstrate meeting or exceeding Medicaid requirements and nondiscrimination statement/policies (requirement implemented, July 2023).
- Organizations that offer in-person trainings, are Michigan-based, multilingual and communityfocused will be prioritized.

DAC Review/Approval

- Maximum of three training organizations will be approved each application window.
 - May 2024 DAC Vote.
- Next application window determined in December 2025.

Request for Application Reviewers



• Reviewer responsibilities:

- Review all 14 applications and complete Reviewer Report.
 - Applications will be measured based on prioritized criteria.
 - Applications and Reviewer Report will be shared via email with all reviewers (Excel format) by April 18.
- Attend Reviewer Discussion.
 - May 13 (Microsoft Teams) from 1-3 p.m.
 - Intention of meeting will be to determine which three trainings will be presented to full DAC for vote in June 2025.
