- Invoicing Process
 - The new process for council members to track their time for reimbursement was presented which includes using an Excel spreadsheet and additional options for returning signed invoices. Comprehensive instructions will be sent to council members on the new spreadsheet and invoicing process.

- Call for MDHHS-Sponsored Doula Trainings FY24
 - MDHHS Doula Initiative is seeking applications to sponsor doula training organizations across the State of Michigan. Trainings must be on the MDHHS-approved doula training list. Applications must include a curriculum outline, trainer verification, budget proposal, promotion of trainings, among other items. Approved training applications will receive funding to support trainer fees, registration fee per person, venue rental, training materials and meals provided during the training. Training participants are eligible to receive a stipend of \$20 per hour of training (maximum of 30 hours). Applications must be submitted by October 31, 2023.
