#### **Nursing Home Leadership Roundtable**

These virtual meetings are intended for nursing home administrators, directors of nursing and infection preventionists. Each one-hour call is split between a 30-minute education session and 30 minutes for open discussion and questions. The Nursing Home Leadership Roundtable is held on the second and fourth Wednesday of each month from 12-1 p.m. CT/1-2 p.m. ET.





#### **IPCWell**

IPCWell provides virtual and in-person infection control training, education and technical assistance to long-term care facilities. Onsite visits include a facility tour and meeting with staff to learn about current infection prevention programming. Following this visit, the IPCWell team will provide a detailed report with feedback for the facility. Learn more about onsite visits from IPCWell's video overview. ### **CDC Infection Prevention Training**

The Center for Disease Control and Prevention's (CDC) Nursing Home Infection Preventionist Training course is a free and flexible training course including 23 modules and submodules addressing various infection control topics. This training is designed for individuals responsible for infection prevention and control programs in nursing homes. Continuing education credits are available for users who complete every module and an assessment.





- Distribution options are limitless!


# Step 3: Each Participant Scans QR Code, Registers, and Completes Program
