Approval of Minutes: The minutes from the March 7, 2023, meeting were approved.

Old Business:

- Eileen reported that the discussion around non-designated/non-participating hospitals was discussed at the April STAC meeting. The discussion at STAC led to a suggestion to develop a policy on non-designated/non-participating hospitals and how they will be managed.

New Business:

- There are 104 designated trauma hospitals, 10 virtual visits are scheduled through August 2023. 14 hospitals are in the queue awaiting initial verification visits.
- Eileen discussed SB-249 and the potential system implications. The bill would require the state to develop their own test for EMS licensure which would forgo the current National Registry test.
