Work Plan Objective Progress and Highlights:

Injury Prevention

Objective: Looking at the top three MOI, The Injury Prevention/Education committee will provide a regional action plan for facilities to follow, addressing one of the top three MOI for the region by fourth quarter of 2022.

Progress: The Injury Prevention and Education committee has discussed options for the implementation of the action plan for community outreach events and educational events. The Trauma website is located on the 5DMRC website. The committee has developed this website and continues to add links, educational material/info, calendar of events. The committee has also discussed the possibility of providing a regional educational/injury prevention activity for late 2022. This will be an in person activity and will be dependent on the Covid environment at that time. May meeting has been rescheduled for June 2022.

Communications

Objective: The RTN will distribute laminated cards to all Region 5 facilities citing the resources (MedCom and EMresource as identified in 302.10) available in the event of a failure in hospital communication systems by November 1, 2021. The laminated card will contain the MedCom contact number and disaster communications protocol, EMResource information. The RTN will ask each hospital in Region 5 to develop a backup plan in the event of a failure in hospital communication systems incorporating the MedCom and EMresource information found on the laminated card by November 1, 2021.

Progress: The Communications subcommittee has developed an action plan which includes the distribution of laminated cards, education process of MedCom. A survey has been sent to gather the regional hospitals' back up plan information. No further updates on this objective for the first quarter of 2022. May meeting rescheduled for June, 2022

Infrastructure

Objective: The RTAC will develop a map of region 5 which includes each hospital, designation level and expiration of designation by fourth quarter of 2021.

Progress: The Infrastructure subcommittee has developed an interactive map (google) for EMS personnel to access identifying hospital locations (map), and trauma level. This map will also contain other pertinent information for each facility. This is being shared at MCA meetings, posted on website, and provided to EMS agencies. No further updates on this objective for the second quarter of 2022. May meeting was rescheduled for June.

Regional Performance Improvement

Objective: The RPSRO will identify regional system gaps, supported by available data, beginning with the first quarter 2021

Progress: The RPSRO continues to review and discuss the RPSRO Inventory. Specific data has been identified as needing to be further evaluated for possible regional gap. The committee has included

data entry/registrars to become members of this group. The committee has also discussed pre-hospital death data with the regional ME. The ME will begin working on obtaining this data.

Continuum of Care

Objective: Rehabilitation case manager(s), and/or physician (s) will have representation on the RTAC and Injury Prevention/Education committee by first quarter of 2021.

Progress: A rehab physiatrist has joined the RTAC beginning May 20, 2021. No further updates on this objective for second quarter of 2022.

Trauma Education

Objective: The Injury Prevention/Education committee will develop a guideline/reference document outlining available education for EMS, nurses, and physicians that currently is in place for Region 5 by fourth quarter of 2021. The Injury Prevention/Education committee will develop an education calendar for Region 5 and place this on the 5DMRC website by fourth quarter of 2021.

Progress: The IP/Education committee has developed a tab on the 5DMRC website. This will contain the links for educational calendar, and various trauma information/articles. Committee continues to update and add to website. Meeting held with website administrator to update and add to website.

Other relevant information:

Region 5 RTN has developed subcommittees to address all of the indicators including developing action plans for each objective. The subcommittees report to the RTAC, RTN quarterly to show their progress, receive feedback, etc. These subcommittees will meet and report to RTN at the May 2022 meeting.
