I. OPENING REMARKS, ROLL CALL, and PLEDGE OF ALLEGIANCE

The March 20, 2024, MAC meeting was called to order by Chair Brian Smith at 10:02 am.

Chair Smith welcomed all to the meeting and thanked all in attendance. He also thanked Jackson County Reynolds Field for hosting the Commission.

Chair Smith asked everyone to join in reciting the Pledge of Allegiance.

Chair Smith asked for a formal roll call. Roll call was taken by Alicia Morrison. It was announced all nine (9) Commissioners were present in person for a quorum.

II. WELCOME PRESENTATION

Juan Zapata, Airport Manager, Jackson County Reynolds Field Airport welcomed the Commission and community members present and thanked them for attending. He then spoke about current and future projects taking place at the airport, highlighting the new tower project funded with Bipartisan Infrastructure Legislation (BIL) grant.

III. STUDENT HIGHLIGHT

Chair Smith introduced Reece Blackgrove who spoke about his experiences as an aviation student and instructor at Flight School Jackson.

III. COMMISSION BUSINESS

A. Minutes of the January 25, 2024, Meeting

Chair Smith asked if there were any revisions to the minutes of the meeting held on January 25, 2024. There were none. Chair Smith entertained a motion to approve the minutes. The motion was moved by Commissioner Russ Kavalhuna and seconded by Commissioner Kelly Burris to approve the minutes as presented. **All voted in favor. Chair Smith announced the motion is carried.**

B. Ownership Transfer of Linden Prices Airport, Linden (9G2)

Chair Smith called on Bryan Budds to present on the ownership transfer of Linden Prices Airport (9G2). Vice Chair Carter asked about the current status of the taxiway and runway. Bryan Budds answered that the PCI is below 50, which indicates poor condition. Vice Chair Carter then asked if maintenance would be required to keep the taxiway and runway in working condition if ownership reverted. Bryan Budds replied yes. Chair Smith asked if there were any further questions. There were none. He then asked for a motion to approve the ownership transfer as presented. The motion was moved by Commissioner Rick Fiddler and seconded by Commissioner Kelly Burris to approve the motion. All voted in favor. Chair Smith announced the motion is carried.

Chair Smith asked if there were any questions. There were none. He then asked for a motion to approve items 1-21 of the State Block Grant Program Airport

Sponsor contracts as presented. The motion was moved by Vice Chair Ben Carter and seconded by Commissioner Bryan Teff. **All voted in favor. Chair Smith announced the motion is carried.**

Chair Smith asked if there were any questions.

Commissioner Kavalhuna stated he had much interest in the success of the Air Service program and therefore had several comments and questions. He began by noting the substantial increase in Air Service Program funding. He asked to confirm there were eight (8) airport requests being approved today. Alissa VanHoof clarified the approval was for up to \$750,000 for 8 airport requests. Final applications and any reimbursement adjustments needed would be brought to a future MAC meeting. Commissioner Kavalhuna then asked when the airports could start using this funding. Alissa VanHoof stated not until they were under contract. Commissioner Kavalhuna asked what sort of monitoring or metrics would be used to ensure proper use of funding and what MDOT's involvement will be. Alissa VanHoof answered the reporting would be driven by Federal Relief Funding metrics, which currently looks at increases in enplanements and passengers. She noted MDOT was willing to review these as needed or requested by the Commission. Commissioner Kavalhuna continued by asking if progress would be reported back to the MAC. Alissa VanHoof responded there would be quarterly metric reporting as noted above and a close out report which would be shared with the Commission. Commissioner Kavalhuna asked if there was a local match required and what the contract length was. Alissa VanHoof stated no financial match, but documented local support was requested as part of the final application process and the contract would be for one (1) year. Commissioner Kavalhuna concluded by asking what the ask in future fiscal years would be. Alissa VanHoof replied the ask would be for \$5M again, noting MDOT Aeronautics had \$17M in requests showing need.

Commissioner Kelly Burris asked what project descriptions were given and if they were mainly routes going south. Alissa VanHoof replied that the pre-applications did not require detailed information on routes, and the final applications did require a detailed discussion of origin and destination of specific routes being sought after.

Vice Chair Ben Carter noted that the increase from \$50,000 to \$5M was significant and continuity on how it is spent would be important.

Chair Brian Smith commented the additional Air Service Program money was greatly appreciated and encouraged tourism in the state, including partnerships with those promoting aviation, such as air shows.

Chair Smith then asked for a motion to approve items 1 and 2 of the State/Local Program and Air Service Program as presented. The motion was moved by Vice Chair Ben Carter and seconded by Commissioner Rick Fiddler. Commissioner Kelly Burris abstained from voting. All others voted in favor. Chair Smith announced the motion is carried.

II. SPECIAL PRESENTATION

Chair Smith welcomed Dean George Pavey from the West Michigan Aviation Academy who presented on aviation education programs available at the academy and how to bring those to community airports. Dean Pavey was accompanied by David, an aviation student who spoke about his surreal experience becoming a pilot. Dean Pavey discussed initiatives started in Oklahoma that paved the way for nationwide initiatives in aviation education and workforce development.

Commissioner Burris asked if they employed a full-time position within their Commission for these initiatives. Dean Pavey answered it started at the district level and grew into a larger full-time position.

III. DIRECTOR'S REPORT

Chair Smith called on Director Trout who presented his Director's Report.

Director Trout began by honoring notable women of aviation in celebration of March as Women's History Month. He also provided current statistics and resources for information on women in aviation.

Director Trout gave a legislative update noting the Federal Government had passed a Continuing Resolution extending transportation funding through May 10, 2024. He also noted the State Block Grant Memorandum of Agreement was signed by MDOT Aeronautics. In the state legislative update, Director Trout highlighted the following legislative initiatives being worked on for 2024: Aero Code Revisions, UAS Task Force Revisions, Aircraft Registration Fee Changes and Tax Credit for Sustainable Aviation Fuel Use.

Director Trout provided further information on the proposed Aircraft Registration Fee Increase. He discussed State Aeronautics Fund revenue sources and uses, highlighting what registration modifications would be used for.

Director Trout recapped details on the Air Service Program emphasizing final application dates.

Director Trout provided current Excise Fuel Tax and Sales Fuel Tax data.

Jackson County Reynolds Field was highlighted by Director Trout for their Contract Tower Project. The project amount was \$3,573,932 and was completed by contractor Sorenson Gross. Paul Nicastri is the Aero Project Manager and Mead & Hunt is the Consultant on the project.

Director Trout welcomed new Aero employees Patrick Murphy and Dylan Drumheller. He also noted the FY 2023 Annual Report was completed and published.

Director Trout discussed current uncrewed aerial systems (UAS) and advanced air mobility (AAM) initiatives.

Director Trout discussed recent good news items including the following stories:

Director Trout concluded by offering his congratulations to the winners of the 2024 NASAO International Art Contest.

IV. COMMISSIONER COMMENTS

Chair Smith thanked MDOT Aeronautics for their work in putting together the MAC meetings and their excellent customer service to the airports.

Commissioner Kevin Jacobs asked if there was a deadline to submit for the Crack Sealing/Paint Marking Programs. Alissa VanHoof responded there was a call for projects in the fall.

Vice Chair Carter thanked Jackson County Reynolds Field Airport and their staff for hosting the Commission. He noted the work being done to better Michigan aviation. He commented on the proposed increase in aircraft registration fees, noting input from pilots and aviators should be considered. He stated the funds were essential revenue but worried the 10-fold increase may not be received well and encouraged ongoing communication on any changes.

V. PUBLIC COMMENTS

Steve Tupper made comments in support of the Traverse City Air Show. Sarah Pagano made comments in support of the air show. Dean Greenblatt made comments in support of the Traverse City Air Show.

Commissioner Kelly Burris noted her dismay at the disagreement between parties regarding the air show. Director Trout stated MDOT Aeronautics was aware of the issues and is continuing to engage with both parties to find an equitable solution.

VI. CLOSING

The next MAC meeting is scheduled for 10:00 am on Wednesday, May 22, 2024, at Big Rapids Roben-Hood Airport, Big Rapids Michigan.

Traverse City Joint Airport Zoning Ordinance - Airport Approach Plan

ISSUE STATEMENT

Section 12 of the Airport Zoning Act, Michigan Public Act 23 of 1950, provides that the Michigan Aeronautics Commission shall formulate, adopt and revise, when necessary, an airport approach plan for each publicly owned airport in this state. This plan determines the extent of the airport hazard area and defines what height of structures and land uses may be airport hazards.

DISCUSSION


Airport Approach Plans adopted under Section 12 of the Airport Zoning Act are to be used to develop Airport Zoning Ordinances by local municipalities. Traverse City Airport Authority would like to adopt an Airport Zoning Ordinance under Section 17 of the Airport Zoning Act. The Airport Zoning Act provides that an airport zoning ordinance shall be based upon a Commission approved Airport Approach Plan that includes height and land use protections. Staff has worked for several months with interested parties of Grand Traverse County, Leelanau County, and the Traverse City Airport Authority to develop their Airport Approach Plan.

RECOMMENDATION

Staff will recommend the adoption of the Airport Approach Plan to be used in the Traverse City Joint Airport Zoning Ordinance.
