Gordie Howe International Bridge Project
Reporting Period FY24

Public Act 121 of 2024, Section 385 (1)

The department shall submit monthly reports to the standard report recipients, the speaker of the house of representatives, the house of representatives minority leader, the senate majority leader, and the senate minority leader on all of the following:

- a) All expenditures made by this state related to the Gordie Howe Bridge.
The Michigan Department of Transportation (MDOT) expended \$19,162,875.67 related to the Gordie Howe International Bridge (GHIB) project during Fiscal Year (FY) 2024.

- b) All reimbursements made by Canada under section 384(1) of this part to this state for expenditures for staff resources used in connection with project activities.
Within this reporting period, MDOT received reimbursement of \$19,190,037.03 from the Windsor-Detroit Bridge Authority for funds spent previously in connection with project activities.

- c) All eminent domain and condemnation powers used, the related real estate involved in any governmental taking, the price paid for those properties, and the beneficiary's name or associated corporation.
MDOT filed four condemnation cases for the GHIB project in April 2024 due to title issues. The amounts shown below reflect what MDOT paid in just compensation for the parcels, with final amounts to be confirmed or determined by the court(s).
