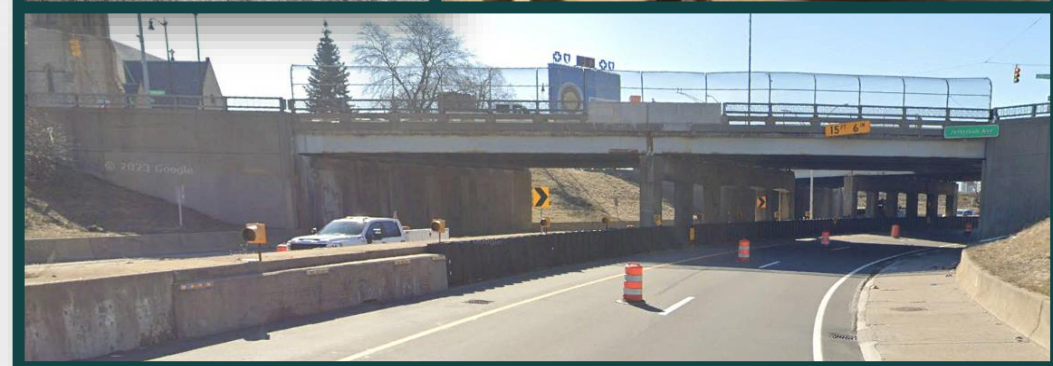
PURPOSE AND NEED

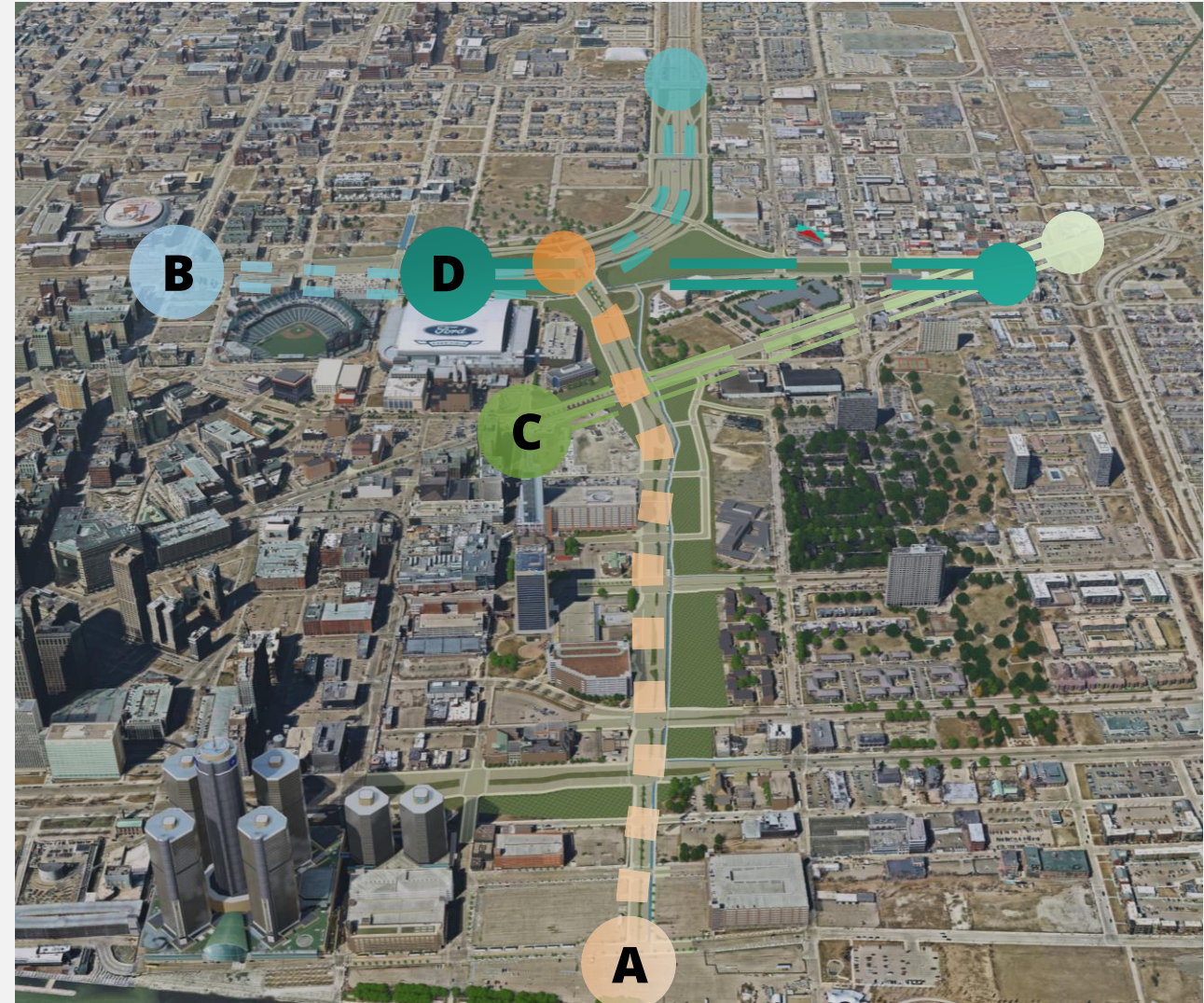

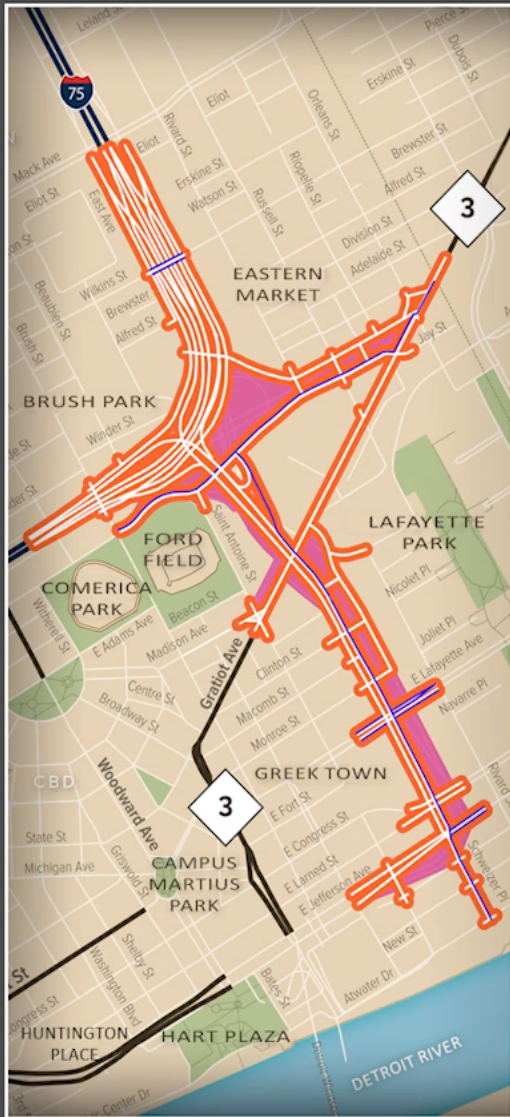
- A. I-375 from the Detroit River to the I-75 Interchange

I-375 RECONNECTING COMMUNITIES PROJECT



This video begins at Mack Avenue going south on I-75 and highlights the new interchange configuration where the far right lane will be used to access the new boulevard, while you stay left to stay on I-75 South. The path follows the new boulevard down to the Detroit Riverfront.

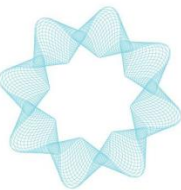
Building Renovations

- Late-Stage Pre-Development - Late-Stage Pre-Development Loans bridge the gap between early stages of pre-development investments or loans and before a project qualifies for construction financing.
- Eligible borrowers must:

Have experience with rehabilitating homes and have a proven track record of timely rehab projects

Provide a portion of their own capital upon acquisition of the property

Sell or rent the complete project/property at affordable rates to low to moderate-income residents.

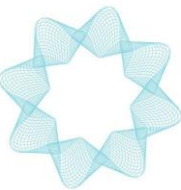
