I. Introduction

<u>Purpose</u>

Instructions

- 1. These Guidelines provide information, procedures, and a checklist to assist with a vehicle purchase.
- 2. Contact the dealer under "Ordering Information" (section II) to order a vehicle.
- 3. After receiving the vehicle, complete the Post Delivery Audit Work Sheets (section IV) and MDOT forms 3188 and 3189 (available on the MDOT website https://www.michigan.gov/mdot/travel/mobility/pub-transit/state-vehicle-contracts-and-procurement).








3+2 Modified Chassis Vehicle with ramp and one double fold-away seat (vinyl).
