DESCRIPTION

Effective 2/1/2024, the second option year available on this contract is hereby exercised. The revised contract expiration date is 3/31/2025. In addition, the following amendment is hereby incorporated into the contract, inserted in Standard Terms and Conditions as section 8:

8. Extended Purchasing Program. This contract is extended to MiDEAL members. MiDEAL members include local units of government, school districts, universities, community colleges, and nonprofit hospitals. A current list of MiDEAL members is available at www.michigan.gov/mideal. In addition, other States (including governmental subdivisions and authorized entities) are permitted to separately contract with the Contractor for the purchase of buses using the Technical Specifications and Pricing in this Contract, by way of a separate agreement between any such State(s) and Contractor. The separate contract(s) between State(s) and Contractor(s) allows for modifications upon mutual agreement by both parties. Any such separate agreement that Contractor may enter into does not alter this Contract in any way, and the State of Michigan does not become a party to any such agreement and does not assume any liability or responsibilities pertaining to any such separate agreement. With respect to any such contract, Contractor will pay the State of Michigan .25% of all amounts Contractor invoices or bills under that separate contract, regardless of whether Contractor is paid for such invoiced amounts. Contractor will make such payments within 30 calendar days from the last day of each calendar quarters. Contractor must submit invoices to, and receive payment from,

extended purchasing program members on a direct and individual basis.
