INSTRUCTIONS FOR SUBMITTING SOFTWARE OR HARDWARE FOR APPROVAL

The following list includes the minimum information required by the Michigan Gaming Control Board Gaming (MGCB) Laboratory for the approval of software or hardware requests as they relate to electronic gaming devices, computerized accounting systems, and any other systems or associated equipment as required by the MGCB.

- All necessary MGCB forms.
- Independent Test Laboratory Certification Letter
- All current technical documentation for the submitted product including schematics, technical drawings, software and hardware descriptions, etc.
- Documentation on microprocessor or microcontroller utilized for device.
- All software source code listings and executables.
- Binary images of all compiled code.
- All "program storage media," such as EPROMS, CD's, hard drives, etc., including but not limited to main, personality, data table, graphics, sound and character generator software.
- Upon request, a compiler, or access to, for building applicable code modules.
- A detailed written description of all aspects of operation, to include, but not limited to, the random number generator (RNG), breakpoints, pay evaluation routines, bonus features, rules of play, table layouts, etc.
- Upon request, a complete mathematical analysis of the RNG implementation used asserting compliance with applicable MGCB Administrative Rules and Technical Standards must be provided.
- All source code, executables, and binary images for any programmable devices.
- Upon request, any specialized hardware or testing equipment needed to complete the evaluation, which may include an emulator for a specified microprocessor, PCs, extender cables for CPU board, target reel strips and door defeats.
- Upon request, a representative prototype delivered to:

All software submissions are to be documented and submitted on separate software submission forms. Individual hardware pieces may be submitted together on one hardware submission form if they are part of a kit or related to the same modification. All forms must be completed in their entirety, signed and dated. Any items not applicable may be answered with N/A or left blank. Omissions may result in delayed processing or denial of the submission.

Page 2 of this document explains the individual data fields on both the software and hardware submission forms.

Skill Based Features	Does the game utilize skill-based bonus games or features?	
Group Play Features	Does this game have group play functionality, where the game plays a shared feature or bonus round with other connected gaming devices?	
RNG Code	Does this program use a new or previously unapproved RNG implementation? Has the RNG code been modified in any way from the previously approved submission or implementation?	
Detailed Description of Modification	Complete technical description of the modification to the device as well as the reasons the modification(s) is being requested.	
Agreement and Certification	Signature of the authorized company official accepting the agreement and certification terms. Company name must be included.	
Date	Date of signature must be included to process the form.
