**ORDER GRANTING APPLICATION FOR  
THIRD-PARTY FACILITATOR LICENSE**

Xpressbet, LLC (Xpressbet) has applied for a third-party facilitator license, in the manner and form prescribed by the Executive Director, pursuant and in accordance with the requirements of the Horse Racing Law, as amended (Law), MCL 431.301, *et seq.*, and the Horse Racing General Rules (Rules), Mich Admin Code R 431.1001, *et seq.*

The Board's staff conducted the required background investigation of Xpressbet and its key persons in order to determine their suitability for licensure pursuant to the licensing standards of the Law and Rules.

The Deputy Director prepared and submitted a written report to the Executive Director summarizing the staff's background investigation and pertinent findings regarding Xpressbet and its key persons. The written report recommends Xpressbet and the key persons be found suitable for licensure.

Having considered the Deputy Director's Report, I find Xpressbet and its key persons suitable for licensure as a third-party facilitatory under the Law and Rules.

IT IS THEREFORE ORDERED that Xpressbet and its key persons, as listed below, are determined to be suitable for licensure pursuant to the licensing standards and requirements of the Law and Rules:
