**ORDER GRANTING RENEWAL OF  
THIRD-PARTY FACILITATOR LICENSE**

Churchill Downs Technology Initiatives Company d/b/a TwinSpires (Churchill Downs TIC) having been previously issued a third-party facilitator license; and

Churchill Downs TIC having, thereafter, timely filed its required license renewal fee and application in the manner and form prescribed by the Executive Director, pursuant and in accordance with the requirements of the Horse Racing Law of 1995, as amended (Law), MCL 431.301, *et seq.*, and the Horse Racing General Rules (Rules), Mich Admin Code R 431.1001, *et seq.*; and,

The Board's staff having conducted a renewal background investigation of Churchill Downs TIC and its key persons to determine whether Churchill Downs TIC and its key persons have maintained suitability for licensure pursuant to the licensing standards of the Law and Rules; and,

The Deputy Director having prepared and submitted a written report to the Executive Director which summarizes the renewal background investigation and pertinent findings regarding Churchill Downs TIC and its key persons, and recommends Churchill Downs TIC and its key persons be found suitable for licensure; and,

Having considered the Deputy Director's Report, I find Churchill Downs TIC and its key persons continue to be suitable for licensure as a third-party facilitator under the Law and Rules.

IT IS THEREFORE ORDERED that Churchill Downs TIC and its key persons, as listed below, continue to be suitable for licensure pursuant to the licensing standards and requirements of the Law and Rules:

Churchill Downs TIC's third-party facilitator license is valid until 12:00 AM on December 31, 2024, unless Churchill Downs TIC's joint contract expires or is terminated as to any race meeting licensee or certified horsemen's organization, or the license is suspended or revoked pursuant to the Law and Rules by the Executive Director.
