**ORDER GRANTING RENEWAL OF
THIRD-PARTY FACILITATOR LICENSE**

Xpressbet, LLC (Xpressbet) having been previously issued a third-party facilitator license; and Xpressbet having, thereafter, timely filed its required license renewal fee and application in the manner and form prescribed by the Executive Director, pursuant and in accordance with the requirements of the Horse Racing Law of 1995, as amended (Law), MCL 431.301, *et seq.*, and the Horse Racing General Rules (Rules), Mich Admin Code R 431.1001, *et seq.*; and,

The Board's staff having conducted a renewal background investigation of Xpressbet and its key persons to determine whether Xpressbet and its key persons have maintained suitability for licensure pursuant to the licensing standards of the Law and Rules; and,

The Deputy Director having prepared and submitted a written report to the Executive Director which summarizes the renewal background investigation and pertinent findings regarding Xpressbet and its key persons, and recommends Xpressbet and its key persons be found suitable for licensure; and,

Having considered the Deputy Director's Report, I find Xpressbet and its key persons continue to be suitable for licensure as a third-party facilitator under the Law and Rules.

IT IS THEREFORE ORDERED that Xpressbet and its key persons, as listed below, continue to be suitable for licensure pursuant to the licensing standards and requirements of the Law and Rules:
