**A Board Resolution And Order Approving
And Formally Adopting The Administrative Rules
Of The Board, R 432.1101 through R 432.11503**

WHEREAS, the Michigan Gaming Control Board ("the Board") on December 2, 1997, developed and approved a comprehensive draft of proposed Administrative Rules for promulgation under The Michigan Administrative Procedures Act, MCL 24.201 *et seq.*, pursuant to the Board's statutory duty and authority under The Michigan Gaming Control and Revenue Act, as amended, MCL 432.201 *et seq.*; and,

WHEREAS, the proposed Rules were subsequently revised on May 12, 1998, to address certain concerns expressed by the Michigan Legislature's Joint Committee on Administrative Rules and correct certain typographical errors in the prior draft of the Rules; and,

WHEREAS, the May 12, 1998 revised draft of the Board's proposed Administrative Rules was reviewed and certified by the Legislative Service Bureau as being proper in form, classification, numbering and arrangement on May 12, 1998; and,

WHEREAS, the May 12, 1998 revised draft of the Board's proposed Administrative Rules was also reviewed by the Office of Regulatory Reform and certified as being legal and consistent with the Michigan Gaming Control and Revenue Act, as amended, MCL 432.201 *et seq.* on May 12, 1998; and,

WHEREAS, the Michigan Legislature's Joint Committee on Administrative Rules on May 13, 1998, reviewed and approved the May 12, 1998 revised draft of the Board's proposed Administrative Rules for formal promulgation, in accordance with the Michigan Administrative Procedures Act; and,

WHEREAS, the Board has reviewed and considered the May 12, 1998 revised draft of its proposed Administrative Rules, which are attached hereto and incorporated herein by reference; and,


WHEREAS, the Board finds that the attached Proposed Administrative Rules of the Michigan Gaming Control Board, R 432.1101 through R 432.11503, are necessary and appropriate to properly implement, administer and enforce the Michigan Gaming Control and Revenue Act, MCL 432.201 *et seq.*; **NOW THEREFORE**,

IT IS RESOLVED AND ORDERED that the attached Proposed Administrative Rules of the Michigan Gaming Control Board, R 432.1101 through R 432.11503, dated May 12, 1998, shall be and are hereby approved and formally adopted by the Michigan Gaming Control Board; and,

IT IS FURTHER RESOLVED AND ORDERED that Board Resolution No. 1998-03 adopting the previous March 12, 1998 draft of the Board's Proposed Administrative Rules shall be and is rescinded.
