The Michigan Department of Health and Human Services (MDHHS) maintains a 24-hour toll-free helpline, 800-270-7117, to call if you or someone you know has a gambling problem. Trained professionals under contract with MDHHS answer the helpline calls, coordinate the initial consultations with qualified counselors, provide financial assistance information, and oversee ongoing treatment of clients when necessary.

DISASSOCIATED PERSONS LIST UNDER THE MICHIGAN GAMING CONTROL & REVENUE ACT

(Excerpted from Section 432.225)

To help those who believe they have a problem with gambling, the Michigan Gaming Control Board (MGCB), with the assistance of Detroit's commercial casinos, has developed a list of Disassociated Persons, pursuant to Michigan law (MCL 432.225). Participation in the Disassociated Persons program is completely voluntary - no one but the voluntary participant may be added to the list. Persons placed on the list voluntarily pledge never to visit a Detroit casino.

HOW CAN I ADD MY NAME TO THE LIST?

To participate in this voluntary program, please contact the MGCB at 313-456-4100 to schedule an appointment to complete the application process in either our Detroit or Lansing office.

WHAT KIND OF INFORMATION IS ON THE APPLICATION?

- Full name and aliases
- Physical description, including height, weight, hair and eye color, skin color, and any other noticeable physical characteristics
- Current home and work address and phone numbers
- Social Security number
- Date of birth

The application also requires:

- Statements that you believe you are a problem gambler and are seeking treatment
- Your photograph (the MGCB will take photos for identification purposes)
- Other information that the MGCB considers necessary

WHAT HAPPENS AFTER I SUBMIT MY APPLICATION TO MGCB?

The MGCB Responsible Gaming Representative will verify the application.

You will be asked to:

- Sign an affidavit in which you affirm that you wish to be placed on the list of Disassociated Persons.
- Authorize the MGCB to release the contents of your application to all Detroit casinos.
- Sign a form releasing the State of Michigan, the MGCB, and the Detroit casinos from any injury suffered as a consequence of participating in the Disassociated Persons program.

WHO GETS A COPY OF THE LIST?

The list will be shared with the Board, each Detroit commercial casino, the Department of Attorney General, the Department of State Police, and affected MGCB personnel.

WILL MY NAME BE RELEASED TO THE PUBLIC?

No. Your name and information contained in the application are exempt from public disclosure and not open for public inspection.

WHAT IF I VIOLATE MY PLEDGE NOT TO VISIT A DETROIT CASINO?

If you voluntarily participate in the Disassociated Persons program and are observed on the premises of a Detroit commercial casino, you will be charged with criminal trespassing and will be immediately removed from the casino premises. Criminal trespassing is punishable by imprisonment for not more than one year, a fine of not more than \$1,000, or both.

Additionally, if you win any money, your winnings will be confiscated by the MGCB and deposited into the State of Michigan Compulsive Gaming Prevention Fund.

DOES THIS INCLUDE MICHIGAN'S TRIBAL CASINO?

No. Only Detroit's commercial casinos participate in this program.

CAN I GET OFF THE LIST ONCE I'M ON IT?

There is an opportunity to be removed from the list after five years.
