- 1. Nathan Hamilton AM Champions
 - Nathan Hamilton reported cohort 5 for the AM Champion program began on August 1 with 120 participants. Cohort 6 of the program will begin in January 2023.
 - Iain Cranston, consultant and lead trainer, gave a brief overview of the AM Champion program and objectives and discussed future educational opportunities for the MIC.
 - Aaron Keatley, EGLE, discussed efforts working with WAMC to develop low-cost asset management plan templates for drinking water systems.
- 2. Kathleen Lomako 30-Year Strategy
 - Kathleen Lomako provided a 30-Year Strategy update detailing additional action items and policies to be incorporated into the Strategy.
 - Nilmino Roberts, WSP lead strategist for the 30-Year Strategy, provided a brief overview of 30-Year Strategy progress with next

deliverables including a 60% Strategy draft to be delivered by September 15. Also, a 90% draft will be submitted to the MIC in late October. Lastly, a final submission will be completed in late November.

- 3. Ryan Laruwe MIC Project Portal
 - Beverly Watts reported Project Portal 2.0 continues work in the system security plan phase to mitigate security risks to SOM systems which will likely be completed by December 2023.

7. Executive Director Report

- FY23 Annual Report Ryan Laruwe provided an overview of the MIC's work from FY23 and discussed the development of the annual report due on September 30th to the legislature.
 - Ryan requested professional photos from the membership to complete the annual report.
- FY23 Budget Update Ryan Laruwe gave an overview of the FY23 budget and reported the MIC have spent 65% of its budget.

- 1. MIC & MIO MOU
 - 1. Ryan Laruwe informed the Council of an opportunity to develop a strategic partnership with the Michigan Infrastructure Office (MIO) through a transfer of funds. The MOU as detailed in the packet's memorandum of understanding which would entail the MIC collaborating with MIO to operate a Technical Assistance Center to provide local and tribal governments grant consulting services, MIC and MIO would coordinate strategic communication efforts, and the MIC and MIO would collaborate to create a local infrastructure dashboard to assist utility managers and local officials with benchmarking system performance. The proposed MIC and MIO MOU transfers funds of \$1,250,000 of the MIC's dollars to MIO for expanding program and services. The partnership allows the MIC to support local governments develop and implement improved asset management.

2. TAMC Partnership IRT

 Joanna Johnson informed the Council that the Investment Reporting Tool (IRT) needs a "substantial upgrade" costing approximately \$250,000. The \$250,000 amount is approximately 14% of the TAMC annual budget allocation. TAMC was informed by the Department of Technology, Management, and Budget (DTMB) in the summer of 2023 that the IRT would be no longer supported with vendor updates for functionality and security. Therefore, to ensure continued support of the IRT the DTMB Center for Shared Solutions (CSS) has proposed a FY24 special project to transition the IRT to a modern framework. Joanna stated that TAMC is requested assistance from the MIC with funding the effort to modernize the IRT framework which would cost the MIC \$250,000.

The fifth cohort of AM Champions concluded in November. We had 101 graduates complete this cohort, which is the largest to date. The MIC has now graduated over 400 AM Champions from across the State of Michigan. This continues to support our priorities in creating a culture of asset management. Staff is in the process of promoting and accepting nominations for the next cohort scheduled to begin in January 2024. To date a total of over 150 nominations have been received. Staff and committee members continue to have discussions regarding ideas to better market the champions program and develop a more formalized promotional strategy. As a result, an AM Champions Program Overview webinar is scheduled for Thursday, November 30.

To continue bringing AM Champions together and continue their education, a total of three webinars have been held since this summer. Average attendance for these webinars averaged between 30-60 participants. These webinars continue to foster a culture of asset management by offering networking opportunities at the end of each event. These webinars have received very positive feedback from participants.

MIC Project Portal 2.0 - Program Update

Dear MIC Members,

We are pleased to provide you with an update on the progress of the MIC Project Portal 2.0 development. We are making significant progress towards completing the project and launching the new portal in early 2024.

Security Plan and Action Plans

We are currently finalizing the security plan for the MIC Project Portal 2.0. This plan has been developed in collaboration with the Treasury security team and addresses all identified security concerns necessary for implementing a new system on the SOM servers. As we wrap up our security plan, we will finalize the plan by including proposed action plans to address any remaining concerns before the new portal is launched to the public.

Testing and Deployment

While we wrap up the security plan, we are simultaneously testing the system internally with the assistance of the Treasury security team and the GIS team at SEMCOG. This testing is ensuring that the portal functionality is working properly and the system is intuitive to incoming users. These tests will be the basis for developing future guidance for users on how to properly utilize the system and all the new features

Project Staffing and Vendor Training

We have encountered some setbacks related to project staffing and vendor training on State of Michigan security procedures. These setbacks have impacted our project timeline, and we are now looking at a preliminary release date of February or March 2024.

Conclusion

We are committed to delivering a high-quality and secure MIC Project Portal 2.0 that will meet the needs of our stakeholders. We will continue to work diligently to complete the project and launch the new portal as soon as possible.



Cross-Council Coordination

As defined by Public Acts 323, 324, and 325 of 2018, the MIC, the Transportation Asset Management Council (TAMC), and the Water Asset Management Council (WAMC) were purposefully designed to support statewide, integrated asset management. While the MIC is charged with leadership across all asset types, TAMC and WAMC share similar roles within their respective subject expertise. Both sub-councils serve in an advisory role to the MIC, providing guidance on statewide transportation and water asset management strategies and the processes and tools needed to implement these strategies.

In June 2023, the MIC hosted a cross-council strategic planning session to align the statewide transportation and water asset management strategies with the 30-Year Integrated Infrastructure Strategy (Strategy). Participants shared their insights and experiences, and they worked together to identify areas for future collaboration. This built trust and rapport among the participants, and it laid the foundation for future cooperation. The councils are focused on implementing the Strategy and the planning for a joint integrated infrastructure conference.

30-Year Integrated Infrastructure Strategy

One of the defining tasks of Public Act 323 of 2018, is the delivery of a 30-Year Integrated Infrastructure Strategy (Strategy). In 2022, the MIC began the process of developing the Strategy with the selection of WSP Michigan and the creation of the steering committee, led by Kathleen Lomako. The Strategy will encourage community discussion, guide prioritization, promote sound investments, and minimize citizen inconvenience through more coordination and collaboration. The overriding goal of the Strategy is to enhance infrastructure performance and improve quality of life for Michigan's residents.

The investment gap in Michigan's infrastructure systems has developed over decades and will take decades to overcome. The Strategy will lay out a long term, comprehensive approach to statewide infrastructure policy that makes the most of what we have and proactively addresses the risks to our residents, businesses, and environment.

A strong culture of asset management integrated across infrastructure assets will enable Michigan's public and private asset owners to get more out of their investments in infrastructure and realize more value over the lifetime of each asset. By spending where and when it is necessary, rather than making expensive repairs when emergencies arise, asset owners can provide more reliable service and keep costs more affordable for rate payers. As asset owners' collective ability to coordinate and collaborate grows, Michigan will be able to tackle more complex challenges, allowing it to enhance the scope of the Strategy in future years. The release of the inaugural Strategy is December 2023.



As a part of the development of our 30-year infrastructure strategy we are identifying actions that need taken to enhance the reliability, efficiency and quality of infrastructure services. Actions focus on infrastructure owners and operators, state and local policy makers and individual infrastructure users. We all have a role to play!

Asset Management Education

Michigan's infrastructure is complex, not only because asset ownership extends over 3,350 public agencies and utility providers but the assets exist in silos managed independently from each other. This results in our infrastructure being managed reactively and has led to cascading and expensive issues upon asset failures. The MIC is working to change the asset management culture statewide to be more proactive in how public and rate payer money is used by focusing on coordination and collaboration among infrastructure providers. However, building an asset management culture begins with aligning our mission, values, and language across the state. The Asset Management Champions program (AM Champions) helps asset owners "speak the same language" of asset management and establish a network of professionals and organizations to help strengthen and "champion" best practice asset management statewide.

Infrastructure is a pillar of our society, and resilient and sound infrastructure fundamentally benefits all communities. The role of education serves as a cornerstone of cultivating an asset management culture. The MIC sees providing trusted information to infrastructure owners and managers, policymakers, and residents as necessary to navigate complex decision-making, especially considering constraints to funding resources and construction timelines.



It is so exciting to see the continued success and impact of the AM Champions Program across the state. With over 300 graduated champions and another 120 participants in the most recent class, we are beginning to see a change in the culture of how we manage our assets in Michigan.


AM Champions Program

Since 2021, the AM Champions Program has set out to establish a network of talented individuals and organizations to help strengthen and "champion" best practice asset management across Michigan's complex infrastructure environment. Proper asset management allows asset owners to make informed decisions about their infrastructure by utilizing data. Asset management identifies strategic investments in preventive maintenance, repair, and rehabilitation of infrastructure, which is more cost-effective. The MIC has been actively pursuing our education goals of providing accurate and trusted information to support effective infrastructure decisions.

By the end of 2023, the AM Champions program will have graduated over 400 Champions! Cohort 5 in 2023 will host its largest class of approximately 120 professionals, including elected officials, tribal representatives, planners, engineers, GIS analysts, public works directors, finance directors, and ground operators and staff. With over 400 asset management champions spread across the state professionals are equipped to foster an organization's infrastructure system's transition to a more comprehensive and strategic approach. The AM Champion program helps implement asset management best practices within organizations and creates more efficient systems one infrastructure asset at a time.



AM Champions Webinar Series

AM Champions and those actively enrolled in the program have the unique and valuable opportunity to participate in monthly webinars hosted by the MIC. These webinars provide professionals across asset classes a chance to participate in an educational environment that imparts international industry best practices to participants and introduces case studies. Participants engage with these industry leaders and apply methods to their newly learned skills to better their communities. Also, program participants network with peers and the industry leaders. Conversations with program peers help to foster solutions to improve integrated asset management across the state. Within FY23, the MIC conducted over eight webinars to help Champions with their day-to-day operations. The following topics were discussed during the webinars with some webinars having an international focus and others being local.

Asset Management in the Morning (AM in the AM)

Often due to a lack of staffing and funding, local communities and smaller infrastructure owners cannot commit resources to asset operations and maintenance. Therefore, these communities turn to engineering consultants for partnerships to increase efficiencies. With this understanding, the MIC views engineering consultants as pivotal stakeholders and allies in building a statewide asset management culture.

In AM in the AM sessions, engineering consultants are educated on the MIC's asset management resources. Equipped with the MIC's asset management programs and resources, engineering consultants can increase local clients' capacity by connecting them to help. Over the years, the MIC has developed relationships with many engineering consultants which helps advance asset management best practices in the state.

The MIC will host the fourth installment of the AM in the AM in FY23. Sessions are designed specifically for the infrastructure consultant community. During the session, participants focus on the Asset Management Readiness Scale (AMRS), which is a FREE tool developed by the MIC to help infrastructure owners understand, measure, and advance their asset management proficiency by providing a standard methodology that can be applied across transportation, water, utilities, and communications assets to produce quantifiable outcomes.



AMRS Benchmarking 2023

Public Act 323 requires that the MIC provide an annual assessment of asset management practices in Michigan that measures progress towards established performance goals. The MIC developed the Asset Management Readiness Scale (AMRS) to fulfill this requirement and provide local governments a methodology for assessing the maturity of their asset management and financial planning processes. By measuring current processes against industry best practice in key performance areas, users gain an understanding of tangible steps that can be taken to improve their asset management practice. Completed AMRS assessments are submitted anonymously to the MIC as part of a statewide benchmarking effort. In aggregate, AMRS results help the MIC understand the short-term training needs of our infrastructure owners and design future programming. Aggregated results also help participating communities understand how their performance compares to their peers statewide helping them keep pace with the statewide transition to best practice asset management. Benchmarking includes a statewide average in each AMRS category compared to the 3-year performance goal provided by participating communities.



Project Portal 2.0

In 2020, the MIC launched a proof-of-concept experiment to develop a process by which public and private infrastructure owners can coordinate infrastructure work in the public right-of-way. The project focused on digitizing capital improvement plans (CIPs) developed for local and regional planning purposes, to support improved inter-agency coordination and collaboration. Today's MIC Project Portal utilizes geographic information systems (GIS) to aggregate CIPs from public and private infrastructure owners into a secure interface where infrastructure developers can better understand the impact their work has on other planned projects in the area. Infrastructure owners can use the system to proactively identify and resolve conflicts before encountering delays and cost overruns. The system also allows infrastructure owners to identify opportunities to align upcoming work in the public right-of-way. By modernizing the way infrastructure owners plan, analyze, and coordinate construction and maintenance activities across assets, and asset owners, we can build a future where we dig less and achieve more with our infrastructure investments.

Based upon the success of the proof-of-concept phase, the MIC took action in December 2022 to upgrade the system to support statewide deployment. The MIC is partnering with SADA Systems, a leader in GIS coordination software, to deliver on the vision of Project Portal 2.0. The upcoming release will feature new functionality including the ability to send messages to project owners, schedule meetings, and share files within the system. New users will also have access to an on-demand training and a full-time help desk to ensure an excellent customer experience. The Project Portal 2.0 statewide release is tentatively scheduled for the first quarter of 2024.



In a continued effort to improve regional coordination for both public and private users, I'm very excited Project Portal 2.0 will enhance coordination, communication, and efficiency. Working together just works!

Michigan Infrastructure Office

The Michigan Infrastructure Office (MIO) is responsible for organizing and executing Governor Whitmer's vision for infrastructure, coordinating across state government, marshaling resources, and partnering with local officials, federal partners, and outside stakeholders to ensure resources sent to Michigan through the Bipartisan Infrastructure Law (BIL), also known as the Infrastructure Investment and Jobs Act (IIJA), are used efficiently and effectively. This year the MIC entered into a strategic partnership with the MIO to align our efforts and ensure our Michigan communities have the knowledge, tools, and resources they need to compete for federal infrastructure dollars. This partnership will provide communities technical assistance for asset management activities and integrated infrastructure planning in 2024.

TAMC Investment Reporting Tool

The Investment Reporting Tool (IRT) is the procedure developed by the TAMC to allow public road agencies to comply with the legislative requirements of Public Act 499 of 2002 and subsequent amendments. The IRT was developed in 2006 and has been a cornerstone of the TAMC transportation planning process for regional planning organizations, metropolitan planning organizations, and local road agencies. The IRT as it stands today provides a multitude of services to stakeholders across Michigan including:

- Statewide roadway inventory and PASER ratings
- Statewide bridge inventory and ratings
- · Statewide culvert inventory and ratings
- · Historic project cost tracking and reporting
- 3-Year Capital Improvement Plans

In the Summer of 2023, the TAMC was provided an estimate of the costs to modernize the system and bring it up to industry standards. The project would have accounted for approximately 15% of the TAMC's annual budget and required cutting funding to local and regional agencies for transportation inventory and ratings work. To avoid this outcome, the MIC voted to transfer funding to the TAMC to support the necessary upgrades to the system while preserving asset management funds for local and regional entities. The MIC and TAMC will take this opportunity to ensure the updated system is interoperable with the MIC Project Portal 2.0 and the MIC's future integrated infrastructure dashboard.



Michigan Planners Association

One of MIC's key strategies is to utilize strategic partnerships with industry associations to expand its messaging within the infrastructure community that can benefit from improved asset management. In 2023, MIC partnered with the Michigan Planning Association (MPA) to publish an article outlining the connection between community planning and asset management. The article, titled "Michigan Infrastructure Council: Advancing the Conversation on Asset Management," was published in January/February edition of, the Michigan Planner. The article discusses how asset management and community planning can complement each other to improve the performance and sustainability of infrastructure assets.

The partnership between MIC and MPA is an example of how MIC is working to expand its reach and impact by working with other organizations that share its goals.

Education - Total Budget - \$800,000

To meet the growing demand for asset management awareness training among our local, regional, and tribal stakeholders, the MIC plans to offer two annual AM Champions cohorts annually. The MIC will also develop educational programs for elected officials, local leaders, and the general public to improve awareness of the asset management business case.



Collaboration - Total Budget - \$1,500,000

The MIC Project Portal 2.0 release in 2024 will provide every infrastructure owner statewide access to GIS collaboration software for work occurring in the public right-of-way. The MIC will also begin its work with state agencies to develop a dashboard that displays state, regional, and local system performance across asset classes.



Coordinate - Total Budget - \$1,250,000

The implementation of integrated infrastructure strategies will require leadership and coordination across all levels of government. In 2024, the MIC will look to develop regional coordination hubs supporting the planning, coordination, and execution of infrastructure projects of regional importance.



Prioritize - Total Budget - \$500,000

The MIC will work with the TAMC, WAMC, and asset owners to create common definitions, inventories, and assessments of Michigan's infrastructure and its condition. Through lifecycle infrastructure asset management and proper prioritization, we can maximize limited resources to realize the greatest benefit.



Invest - Total Budget - \$1,500,000

Through a joint endeavor with the MIO, the MIC will operate the State Technical Assistance Center (TAC). The TAC will provide pre-development support to communities seeking grant funds from the federal government.

Moving Forward

The MIC looks forward to engaging with stakeholders to build a shared understanding of the importance of infrastructure asset management and get their input on improving our practices. By joining forces, organizations can achieve more than they could on their own. Partnerships can help organizations share resources, expertise, and knowledge, leading to improved products, services, and outcomes for our citizens. Overcoming our infrastructure investment gap will require effective and inclusive long-term strategies. The MIC's 30-Year Integrated Infrastructure Strategy will begin this journey.
