CALL TO ORDER AND WELCOME

Commissioner Eid, Chair, called the meeting of the Michigan Independent Citizens Redistricting Commission (MICRC) to order at 10:08 a.m.

MDOS staff called roll. A quorum was met.

Commissioner Eid, Chair, put a motion "to begin public comment pertaining to agenda topics portion of the agenda" forward without objection, which was adopted.

UNFINISHED BUSINESS

a. House and Senate Remedial Commission Report

Commissioner Eid, Chair, requested that Executive Director Woods facilitate this topic. Executive Director Woods indicated that the House and Senate Remedial Commission Report is available in today's meeting materials available on the MICRC website. Executive Director Woods indicated that the Commission Report identifies the remedial mapping process, identifies compliance with the Court order, includes the resources used, includes the dissenting report, and includes a legal review. Nate Fink provided a legal analysis of the Commission Report and the Dissenting Report.

MOTION: To consider the House and Senate Remedial Commission Report and the Dissenting Report as two unique documents for publication. Moved by Commissioner Eid. Supported by Commissioner Weiss. Commissioner Eid, Chair, held a vote, by show of hands. **MOTION APPROVED.**

MOTION: To approve the House and Senate Remedial Commission Report as presented by Executive Director Woods. Moved by Commissioner Eid. Supported by Commissioner Weiss. Commissioner Eid, Chair, held a vote, by show of hands. **MOTION APPROVED.**

b. Archives Update

Commissioner Eid, Chair, requested that Executive Director Woods facilitate this topic. Executive Director Woods provided an overview of the archival process, including where the archives will be housed. Executive Director Woods introduced Cynthia Gehring from the Department of Technology, Management, and Budget. Cynthia Gehring provided an in-person presentation about where the Commissioners and the public can find archived MICRC materials online and in-person.

c. Contract Best Practices Review Update

Commissioner Eid, Chair, requested that Executive Director Woods facilitate this topic. Executive Director Woods introduced Matt Grossman, from Michigan State University. Matt Grossman provided an in-person presentation on how the 2024 maps performed.

b. Lessons Learned Report

Commissioner Eid, Chair, requested that Executive Director Woods facilitate this topic. Executive Director Woods indicated that he distributed the Lessons Learned Report for the Commission to review and did not receive any requests for changes.

MOTION: To accept and publish the Lessons Learned Report as presented by Executive Director Woods. Moved by Commissioner Orton. Supported by Commissioner Weiss. Commissioner Eid, Chair, held a vote on the motion, by show of hands. **MOTION APPROVED.**

c. September/FY 24 Financial Report

f. Dormancy

Commissioner Eid, Chair, requested that Nate Fink facilitate this topic. Nate Fink indicated that section 3.3 of the Amended Rules of Procedure indicates that the Commissioners' appointment lasts until the next Commission is appointed for the subsequent census cycle; however, at such time that all litigation filed against the Commission and/or the members is completed, and no further action is required of the Commission or its members, the Commission will vote to move to dormant status. Nate Fink provided additional information regarding actions the Commission must take when moving into dormant status. Nate Fink also indicated that in the event of litigation being filed after going into dormancy against the Commission or its members or staff regarding Commission business, the Commission shall reactive and return to active status to address said litigation.

MOTION: Designate the Chair (Commissioner Eid) and Vice Chair (Commissioner Orton) to be contact persons for the Commission when they enter dormancy. Moved by Commissioner Lett. Supported by Commissioner Weiss. Commissioner Eid, Chair, held a vote on the motion by show of hands. **MOTION APPROVED.**

MOTION: To extend the 30-day wrap up period for the Commission to last until the end of February 2025. Moved by Commissioner Lett. Supported by Commissioner Weiss. Commissioner Eid, Chair, held a vote on the motion by show of hands. **MOTION APPROVED.**

MOTION: To pay Executive Director Woods for work done to wrap up the Commission through January 31, 2025. Additionally, approve an advance payment to Executive Director Woods for work done in February 2025, to be paid on the last pay date of January 2025. Moved by Commissioner Lett. Supported by Commissioner Weiss. Commissioner Eid, Chair, held a vote on the motion by show of hands. **MOTION APPROVED.**

MOTION: Pay for all Commissioners will cease after the week ending December 22, 2024. Moved by Commissioner Lett. Supported by Commissioner Orton. Commissioner Eid, Chair, held a vote on the motion by show of hands. **MOTION APPROVED.**

MOTION: To authorize Commissioner Eid (Chair) and Commissioner Orton (Vice Chair) to continue to approve and sign necessary documentation or expenditures that are required during the dormancy period, without additional compensation. Moved by Commissioner Lett. Supported by Commissioner Orton. Commissioner Eid, Chair, held a vote on the motion by show of hands. **MOTION APPROVED.**

MOTION: For the MICRC to enter dormancy at the conclusion of the December 19th Commission meeting. Moved by Commissioner Orton. Supported by Commissioner Muldoon. Commissioner Eid, Chair, held a vote on the motion by show of hands. **MOTION APPROVED.**
