



Re: Whether the Retiree Protection Fund Investment Advisory Committee is Subject to the Open Meetings Act.

The Office of the Chief Financial Officer ("OCFO") has requested an opinion on whether the Retiree Protection Trust Fund Investment Advisory Committee ("Committee") is subject to the Open Meetings Act ("OMA").¹

SHORT ANSWER

The Committee is not subject to the OMA because it is not a "public body" as defined in the statute or Michigan courts. The Committee was created pursuant to the Retiree Protection Trust Fund Ordinance and the Retiree Protection Trust Fund Agreement between the City of Detroit and Bank of New York Mellon Trust Company, N.A. It functions as an investment advisory committee to the Chief Financial Officer and is not acting as a "legislative" or "governing" body with "decision-making authority." Furthermore, the Committee's actions (advise CFO regarding the investment of Retiree Protection Trust Fund assets) are advisory in nature and do not constitute "decisions" or "recommendations" that should be made by a public body.

LAW & ANALYSIS

Open Meetings Act

The OMA applies to all public bodies, which have been identified as having two requirements: (1) the entity at issue must be a "local legislative or governing body, including a board, commission, committee, subcommittee, authority, or council..." and (2) the entity must be empowered by "state constitution, statute, charter, ordinance, resolution, or rule" to exercise a "governmental or proprietary authority or perform a governmental or proprietary function."

Retiree Protection Trust Fund

The Retiree Protection Trust Fund ("Fund") was created pursuant to amendments of Chapter 47 of the 1984 Detroit City Code, *Retirement Systems*, by Ordinance No. 21-17⁵ and adoption of the City of Detroit Retiree Protection Trust Fund Agreement ("Agreement"). Under the terms of the Agreement, the City will fulfill its obligations to fund the General Retirement System (GRS) and the Police and Fire Retirement System (PFRS) through deposits into a Retiree Protection Trust Fund. The Fund was established as a permanent and irrevocable Trust Fund under Sections 115 and 414(d) of the Internal Revenue Code, which will "receive, maintain and invest" funds deposited by the City into the Trust Fund, in order to ensure that the GRS and PFRS pension systems are sufficiently funded. The Bank of New York Mellon Trust Company was appointed Trustee of the Fund, with authority to invest, reinvest, and distribute the Trust Fund assets to the GRS and PFRS. The Trust Fund Assets will be periodically distributed by the Trustee to the GRS and PFRS only upon written direction of the CFO, in amounts and at times directed by the CFO.

Investment Advisory Committee

Both Ordinance No. 21-17⁷ and the Agreement authorize the creation of the Committee and provide as follows:

Section 6.01 <u>Investment of Trust Fund</u>.

- (a) The Trustee shall invest and reinvest the assets of the Trust in Permitted Investments in accordance with written instructions received from the Chief Financial Officer. The Chief Financial Officer shall chair an eight-member investment advisory committee (the "Advisory Committee") which shall be established to advise him or her regarding the investment of Trust assets. The Advisory Committee shall be comprised of:
- (i) the Chief Financial Officer, who shall chair the Advisory Committee;
- (ii) three individuals who shall also be three of the Independent Members (as defined in the pension governance requirements of the Contribution Agreement dated as of October 17, 2014 among the Michigan Settlement Administration Authority, GRS, PFRS and the City) of the Investment Committee for the GRS Plan designated by the chair of that Investment Committee;

(iii) three individuals who shall also be three of the Independent Members of the Investment Committee for the PFRS Plan designated by the chair of that Investment Committee; and

(iv) one member appointed by the City Council.

In the event an insufficient number of Independent Members agrees to serve on the Advisory Committee, as an alternative, the Chief Financial Officer shall appoint other independent individuals with comparable qualifications to those of the Independent Members to fill that role on the Advisory Committee. With the recommendation of the Advisory Committee, the Chief Financial Officer may appoint one or more

qualified independent investment professionals to assist in the

The Committee is not a public body subject to the OMA because it does not exercise any governmental or proprietary authority, meaning it is not a "legislative body" empowered to make or enact law, nor a "governing body" empowered to make or administer public policy, exercise independent authority, or render decisions. Although the term "committee" is included in the OMA definition of a public body, the plain meaning of the language of the Ordinance and Agreement does not empower the Committee to function as a legislative or governing body. The sole function of the Committee is to advise the CFO regarding the investment of assets. It should be noted that the CFO is not bound to accept or act upon such advice.

CFO Administrative Order No. 2018-101-009, regarding the Retiree Fund Investment Advisory Committee, effective March 29, 2018, provides further guidance on the operation of the Committee. It states in Sec. 6.2 that the Committee shall "at a minimum, meet annually during the month of September to conduct its business and review the Annual Statement submitted to the CFO by the Trustee." Sec. 6.3 of the Administrative Order requires the Committee to submit an annual report to the CFO to include its recommendations. This report must be submitted by the end of October. Therefore, the Administrative Order does not contain any additional requirements that would shift the role of the Committee outside of an advisory capacity.

In *Davis vs. City of Detroit Financial Review Team*, ¹¹ Robert Davis asserted that the state-appointed financial review team for the City of Detroit violated the OMA by failing to hold public meetings, keep minutes, and post meeting notices. ¹² Under the Local Government and School District Fiscal Accountability Act, now repealed, review teams were authorized to

meet with local governmental officials, review the books and records of local governments, negotiate consent agreements with local governments for approval by the State Treasurer, report team findings to the Governor, and make recommendations to the State Treasurer and Governor regarding the financial condition of the local governments. The Governor used this information to assist in determining whether to declare a local unit of government in a state of financial emergency.¹³

The Court held that the law did not empower a financial review team to independently govern through "decision-making that effectuates or formulates public policy" and that the review team could "not act on its recommendations; it can only *make* such recommendations." The Court clarified that a "recommendation" is a "decision" only when (1) members of a *public body*, (2) *vote or act upon*, (3) a recommendation, (4) to effectuate or formulate public policy. In regards to a public body making a decision, the *Davis* court noted the following:

[W]e find it significant that the definition [of a decision] does not merely refer to a recommendation alone. Rather, it refers to a "determination, action, vote, or disposition *upon* a motion, proposal, recommendation, resolution, order, ordinance, bill or measure"—the operative word here being "upon."¹⁶

Similarly, neither the Ordinance nor the Agreement grants the Committee any decision-making authority, nor can it act or vote upon any recommendations to effectuate or formulate public policy. The sole mandate of the Committee is providing recommendations to the CFO. The Committee is not empowered to act independently to invest Trust Funds or make any decisions which would impact such investments.

CONCLUSION

The Retiree Protection Trust Fund Investment Advisory Committee functions as an investment advisory committee to the Chief Financial Officer and is not empowered to act as a "legislative" or "governing" body with "decision-making authority." Furthermore, the Committee's actions (advise CFO regarding the investment of Retiree Protection Trust Fund assets) is all advisory in nature and do not constitute "decisions" or "recommendations" that should be made by a public body. Therefore, the Committee is not serving a proprietary function to make decisions and effectuate public policy; therefore, it is not subject to the Open Meetings Act.
