

COMMISSIONER SALARY REVIEW



- Starting the week of Jan. 15, the Commission engages in mapping for three full weeks.
- During the mapping phase, the Commission received 35 percent of the Governor's salary versus the Constitutional minimum of 25 percent of the Governor's salary.
- Move that the Commission approves the increase of commissioner salaries from \$746.63 to \$1072.21 per week until the Commissioner is dissolved.



EXECUTIVE DIRECTOR CONTRACT



- Commission voted to return the Executive Director to **full time** status effective, Jan. 1, 2024.
- In preparation for the Agee Case in October to the present, the Executive Director has frequently lost hours due to the weekly cap of 30 hours and holiday pay.
- The Chairperson and Vice Chairperson met with the Executive Director to identify a solution for recommendation.
- Modify the Executive Director's contract to full time status retroactive to Nov. 27, 2023. This is not a pay increase.

REQUEST ADDITIONAL STATE FUNDING




- Due to the pending litigation, the MICRC will need to request additional funding from the Michigan Legislature.
- The recent court order from the United States District Court Western District of Michigan Southern Division requires the Commission the costs and expenses of the Reviewing Special Master and the Mapping Special Master, and their respective teams subject to the Court's approval.
- In addition, the Commission's budget did not consider in-person meetings and increased legals costs for pending litigation.




