The example I provided does demonstrate that redrawing the districts in question without an overly adverse effect on partisan fairness is possible. My advice to the Commission is to pay more attention to the forest, less attention to the trees, and try not to make it any more complicated than it has to be.

In hindsight, perhaps I should've requested to speak. I realize you have voted to appeal the ruling. That's perfectly fine with me, as I thought the lawsuit was unnecessary to begin with..

However, should you wish to redraw the current map at some point, you might want to look at the attached link. It might give you some ideas toward that end. The attached link is something I did on Dave's Redistricting wherein I rearranged the House districts in question, and did so without having to modify too many other districts.

The bottom line is, the attached link, contains 11 majority Black districts instead of the current 7. And, it does so without big changes to the other metrics.

Dem seats in this link are 54.51 as opposed to 55.12 in the current map, so it does a pretty good job of maintaining partisan balance.

As for the other metrics, like efficiency gap, partisan bias, mean-medium, etc., it does change them, but not by a lot.

P.S. I could go through the whole map and tweak a few other things, like unnecessary splitting for example, but for the purposes of redrawing the map to satisfy the lawsuit, this might come close to fixing that problem.
