

PROPOSED SCHEDULE TO DRAFT SENATE REMEDIAL PLAN

April 12—The parties must meet and confer—and jointly submit, no later than this date—a proposed timeline for preparing a Senate remedial redistricting plan.

April 18—Draw Senate Maps and Commission Meeting (10:00 am.- 3:00 p.m., lunch from 12:30-1:30 p.m.)

April 25—Draw Senate Maps (4:00-7:00 p.m.)

May 2—Draw Senate Maps (10:00 a.m.-3:00 p.m., lunch from 12:30-1:30 p.m.)

May 9 and 10—Draw Senate Maps (In-Person Meeting) (10:00 a.m.-3:00 p.m., lunch from 12:30-1:30 p.m. and 4:00 p.m.-7:00 p.m., and 10 a.m.-1:00 p.m.)

May 16—Draw Senate Maps and Commission Meeting (10:00 a.m.-1:00 p.m.)

May 30—Draw Senate Maps (4:00-7:00 p.m.)

June 6 and 7—Draw Senate Maps (In-Person Meeting) (10:00 a.m.-3:00 p.m., lunch from 12:30-1:30 p.m. and 4:00-7:00 p.m., and 10:00 a.m.-2:00 p.m.)

June 11—Draft Proposed Maps due to the U.S. District Court

June 20—Host a Virtual Public Hearing and Commission Meeting (10:00 a.m.-1:00 p.m. and 5:00-7:30 p.m.)

July 16—Host a public hearing in metro Detroit. (10:00 a.m.-3:00 p.m., lunch from 12:30-1:30 p.m. and 4:00-7:00 p.m.)

July 17—Host a public hearing in metro Detroit. (10:00 a.m.-3:00 p.m., lunch from 12:30-1:30 p.m. and 4:00-7:00 p.m.)

July 18—Host a public hearing and Commission Meeting in metro Detroit. (10:00 a.m.-3:00 p.m., lunch from 12:30-1:30 p.m. and 4:00-7:00 p.m.)

July 25—Senate Maps Deliberation (10:00 a.m.-1:00 p.m. and 4:00-7:00 p.m.)

July 26—45 Day Public Comment Period Ends

July 29—Senate Maps Deliberation (10:00 a.m.-5:00 p.m., lunch from 1-2 p.m.)

July 30—Senate Maps Deliberation (10:00 a.m.-5:00 p.m., lunch from 1-2 p.m.)

Aug. 2—Senate Map due to the U.S. District Court

Aug. 9—Plaintiffs file any objections to the Senate plan with the court.

Aug. 16—The defendants' responses to any objections by the plaintiffs.

Aug. 16—The Reviewing Special Master submits review of the commission's work.

Aug. 23—The parties may each file briefs commenting on the Reviewing Special Master's report no later than this date.

Aug. 30—The court will approve a remedial house districting plan no later than this date.
