>> CHAIR EID: Good morning everyone. As Chair of the Commission, I call the meeting of the Michigan Independent Citizens Redistricting Commission to order at 10:03 a.m.

- >> YVONNE YOUNG: We will catch her when she comes back in you currently have 11 Commissioners present and you have a quorum.
  - >> CHAIR EID: Thank you, Ms. Young.
  - >> YVONNE YOUNG: You are welcome.

- >> CHAIR EID: Move to adopt the agenda. As a reminder to the public watching you can view the agenda at www.Michigan.gov/MICRC. I see Commissioner Kellom has rejoined.
- >> YVONNE YOUNG: Yes. Commissioner Kellom, good morning. And please share you are present and where you are attending front, ma'am.
- >> VICE CHAIR KELLOM: Good morning. Present and attending from Detroit, Michigan.
  - >> YVONNE YOUNG: Thank you.
  - >> CHAIR EID: I will entertain a motion to approve today's agenda.
  - >> COMMISSIONER SZETELA: So moved.
  - >> COMMISSIONER WEISS: Second.
- >> CHAIR EID: There is a motion by Commissioner Lett and a second by Commissioner Weiss to approve today's agenda. Is there any discussion on the motion? Seeing none we will move to vote. All those in favor of the motion to adopt the agenda please raise your hand and say aye.
  - >> Aye.
- >> CHAIR EID: Any opposed please raise your hand and say nay. The ayes have it and the agenda is adopted. Next up on the agenda is public comment if there is no objection. Is there objection to moving on with public comment? All right, is there any objection Commissioners? Hearing none we will move on.

Individuals who have signed up and indicated they would like to provide live remote public commentary to the Commission will now be allowed. I will call your name and our staff will unmute you. If you are on a computer you will be prompted by the Zoom app to unmute your microphone and speak. If you are on the phone a voice will say the host wants you to speak and prompt you to press star six to unmute. I will call you by your name and please note if you are experiencing technical or audio issues or do not hear from you for three to five seconds we will move to the next person in line and return to you after you are done speaking. If your audio still does not work e-mail redistricting@Michigan.gov and we can help you trouble shoot to participate during the next public comment period at a later meeting.

Today you will have 90 seconds to address the Commission and please conclude your remarks When you hear the timer.

Today we have six public comment speakers and the first being Mr. James Galant.

>> Hello, James Galant, Marquette, these are opinions. Chair Eid, consensus decision making is a slippery slope. You made the girls cry and that made me cry. You multiply that by a hundred thousand today across the State of Michigan and that's the pain that guided me here like the star over Bethlehem. Please fix this by unanimous consent Chair Eid and go back to what Brady instructed you Robert's Rules of Order, no motion, no debate before a motion is second to approve a specific action. Your new friend Juanita does not understand what Robert's Rules are and doesn't know what it

means. The old man attorney probably just forgot the rules. We let President Biden do that every day. Please fix this by unanimous consent, by unanimous consent issue an RFP for a parliamentarian to get this fixed around. And you know all the other stuff I've been asking you for. Robert's Rules of Order is the only way that you can personally protect everybody's rights all at the same time. You said you were trained by Arizona. This Commission was not trained by Arizona you were trained by Arizona. These sideways rules are abusive and contradict your oath of office. And are increasing the risk of suicidal behavior in our community of interest. The entire State of Michigan. Which you have now recognized. Now please help me to fix this because you will be the one who will be dangling out there at the Supreme Court trying to explain how these sideways rules work by consensus. Because nobody else understands, that's why Carl Marx couldn't tell you what communism looks like because he would not be here today. Got it?

- >> CHAIR EID: Thank you. Yes, trying my best over here, next up to speak is Mr. Chris Andrews.
  - >> Good morning, can you hear me?
  - >> CHAIR EID: We can Mr. Andrews.
- >> I'm Chris Andrews from Haslett. In 2021 the message that you heard most often from voters was create fair statewide maps. Michiganders have not changed their minds. As you all know the Linden map has a moderate republican bias, you now have the choice of making fairer maps or not. Every Michigan voter has a huge stake in the changes that you make in Southeast Michigan that determine whether the party that wins the most votes is likely to win the most seats and be able to govern.

  Commissioner Szetela has provided a remarkable public service by building a collaborative map that addresses the race equities and inequities in Linden and creates what she has described as an almost perfect partisan fairness. I urge the Commission to adopt this map which I believe is 429 version 1 or perhaps make improvements that retain the fairness that Commissioner Szetela has demonstrated is achievable. There are those who suggest that intentionally drawing fair maps is gerrymandering. It is just the opposite. And if the new maps are more biased than the ones we have now, I think there is a good chance that you will end up back in Court again. Thank you.
  - >> CHAIR EID: Thank you, Mr. Andrews. Next up to speak is Gary Morehead.
  - >> Am I coming through?
  - >> CHAIR EID: Yes, we can hear you Mr. Morehead good morning.
- >> Good morning Commissioners and thank you all for your service. I'd like to point out some positive examples. One, I live in District 7, it is I prefer it as it is, but it must be altered to remedy 6 and 8. Adding Rochester, Birmingham and Bloomfield to the northern part is good redistricting Oak Park and Huntington Woods to the southern part also makes a lot of sense. Number two accommodating COIs in Senate districts is easier that in house districts but important to note them otherwise you may seem to be

focusing mainly on municipalities which have their own lower priority. Number three, your aim should be always to improve on Linden's partisan proportionality. You already have one example of this. You may be able to make more. Number four please stop talking about pay until July. Anyone opposed can follow Commissioner Lange's good example and number five if the Commissioner loses the mojo for redistricting they owe it to the people of the state to follow Rothhorn's good example and finally six why is an experienced public commenters should be particularly able to time their comments to the rules especially if their subject is rule following. If I can they can. They should not be granted additional time. Thank you.

- >> CHAIR EID: Thank you Mr. Morehead. Next up to speak is Samantha Mullet Forsyth.
  - >> Hello good morning.
  - >> CHAIR EID: Good morning.
- >> This Commissioner was approved by orders in order to fix the problem of partisan gerrymandering. Sick of giving unfair advantage to specific parties. The map started last Thursday was a big step in the right direction. With much improved mean median score. So I encourage you to monitor partisan fairness as you continue the step for mapping. The Constitution does not prohibit you from intentionally drawing maps to achieve the best possible score. It plainly gives partisan fairness a higher criteria than municipal boundaries, that's all, thank you.
- >> CHAIR EID: Thank you for your comments. The final speaker today is Mr. Anthony Scannell.
  - >> All right can you hear me.
  - >> CHAIR EID: We can good morning.
- >> Good morning I did not know I was the final, I thought there was a sixth, joining remotely from Lincoln Park and not affiliated with democrats or republicans and probably will never be even though I used to. I enjoyed the discussion about the constitutional language that was had about public submissions, and you know being received and how those should be received, and it does not say how those should be received but should so thank you for bringing that up last week or last couple days. I think I will enjoy the Commission about Commissioner pay even though I really don't have a strong opinion about that either way I like the point that was just made about Commissioner Lange. Great example. The issue that is coming up for me already is the naming issue. It's just I don't know not too hard to keep track. It's just you know, I don't know, maybe there is three or four completed ones, I would go on the website but if they had all an unique name I could think of it off the top of my head but the other side I have heard argument for that it gets people to mobilize for a map just based off the name so I don't know maybe you have the right approach. Joining from Lincoln Park I don't really like the District 1 and District 2 configurations that you seem to be learning

towards but that is already and understand why you are doing it and eager to see this process unfold and the final results as they come forward. Thank you.

>> CHAIR EID: Thank you, Mr. Scannell. That concludes our public comment for today. Please feel free to e-mail comments to the Commission or use the public comment portal at www.Michigan/mapping.org which can also be found on the website. We appreciate everyone who offers public comment in whatever way you choose and invite you to keep sharing your thoughts especially in any way you would like to share.

Ms. Schaar, I see your hand.

- >> MEGHAN SCHAAR: I'd like to note for the record that Commissioner Curry has joined the meeting. She joined at 10:15. Commissioner Curry can you tell us where you are joining remotely from?
  - >> COMMISSIONER CURRY: Detroit, Michigan.
  - >> MEGHAN SCHAAR: Thank you very much.
- >> CHAIR EID: Thank you, Ms. Schaar. Welcome Commissioner Curry. Okay next up on the agenda are items for consideration first being 5A mapping processes and procedures. Without objection I will ask our local counsel Nate Fink to facilitate this item. Mr. Fink please proceed.
- >> NATE FINK: Thank you Mr. Chairman good morning everyone. I believe we have some proposed revisions that are to the Commissions mapping and procedures that were offered by Commissioner Szetela. I have an overall comment, which is sort of reiterating what I said I believe at the last meeting which is the remedial process for the House worked and so to the extent that we can stick to that process I think would be advisable. That said some of the suggestions that Commissioner Szetela has proposed here looks like just sort of formalizing some of the processes that the Commission has already been sort of following generally. But I suppose the Commission can engage in some discussion on this. And I don't know if it's proper to be voted on yet, but Commissioner Szetela has her hand up so to the extent that she wants to speak to her proposal, it may make sense to have someone pull it up on the screen. I can do that or if Director Woods has it at his fingertips he can do it too. There we go.
  - >> CHAIR EID: Wonderful, thank you Mr. Fink, Commissioner Szetela?
- >> COMMISSIONER SZETELA: Yeah I just kind it curious that every time since I testified at trial I have an agenda item that I ask for rather than being allowed to present it it's given to Mr. Fink to do an introduction about what my agenda item is. I find it really offensive. I mentioned this already, I would like to present my own agenda items rather than letting Mr. Fink give his spin on what he thinks I'm asking for. Moving to the actual request I made as Mr. Fink indicated I'm trying to memorialize what our practices are because we have a bunch of gaps in our policy that were creating some issues in terms of how map drawing is going so I think probably best for the Commission to have a discussion and decide what we want the policy to be rather than just having it be arbitrary based on who is doing the drawing so if you could scroll down to where the first

changes are. A little higher, a little higher. Okay so I just wanted to have a rule put in with respect to what happens when a Commissioner passes a turn so that it's clear so that there is no confusion because as the rules are written it says a Commissioner may pass a turn but it does not say anything what that actually means so I'm just adding some clarification if you pass your turn then you have to wait until the next time you are called in alphabetical order to take that turn. However you're not prohibited from helping other Commissioners who may be on their turn if they are calling out a request for assistance so that is the first one just clarifying the policy and practice that we've used all along.

Number three, I'm adding this in specifically because of Anthony Scannell's map last week that a selected Commissioner may bring in a map or community of interest that way we don't have to have a vote if somebody wants to do that. That is my other request for a change. If we can control them.

Number four, clarify people can assist and collaborate with other Commissioners who are drawing. Richard had a turn yesterday and asked for help. That's perfectly appropriate. Even if that Commissioner who is helping may have passed a prior turn they can still collaborate and cooperate. And then number five is what happens if someone is not available. As you know we have 13 people on this Commission. You know, how are we going to handle it if someone gets up to go to the bathroom for five minutes, can they take their turn if they happen not to be sitting there when they come back? I don't have a particular preference on this one way or another. I put in a language around what happens if that person still wants to take a turn and they did not intend to miss their turn. That they would be allowed to take their turn when they come back if they so indicate however we could also put in language saying that if someone is not available at the time their name is called that it's treated as a pass. I mean I don't have a particular I'm pretty agnostic about this one way or another but think we should have clear rules on it. Then we can scroll down a little more? Oops, a little too far. Anything else above that or is it the Section we are up to? Roman two we have never followed the practice of having the Chair or the Vice Chair instruct EDS. It's always been the Commissioner who is drawing the map, so I just want to make that clear that you know the Commissioner who is actually having the Chair and the Chair or Vice Chair goes to EDS and the Commission does it directly. That is aligning the rules with the practice. Scroll down a little bit more.

And then under A and B I just clarified that individual Commissioners can draw a District or districts. Again that has been our practice all along. That second one should be or districts as well. Because people don't just draw one District. At least at this point when we are working on trying to do remedial maps, some people have drawn multiple districts or one District. Either way it should be the Commissioner's choice to choose whose turn it is. Can we scroll down a little bit further? And this is to address Anthony Scannell that an individual Commissioner may if they choose to follow their own naming

convention in addition to their name to avoid confusion with the public. However, that Commissioner cannot use the same naming convention as is selected for collaborative maps. So those are the clarifications and changes I am requesting that we consider. I also think it would not be a bad idea to consider a time limit on Commissioner turns. Half an hour, an hour, I think an hour is more than fair. Just so that people have equal opportunities to map but I did not currently put that in there, but I think it would be a good thing to add as well.

Any questions I will gladly take them?

- >> CHAIR EID: Thank you Commissioner Szetela. Questions? Comments? Commissioners?
- >> COMMISSIONER SZETELA: All right what I will do then is add that additional change that I think we should consider about limiting mapping turns to one hour and have the secretary post it and at a later date I can move to potentially adopt this if the Commission so desires, thank you.
- >> YVONNE YOUNG: District Chair, Commissioner Lange has had her hand up for a bit.
- >> CHAIR EID: Have you? Okay you are on a different screen. I will hold my comments then until after. I see Commissioner Lange and Commissioner Kellom, Commissioner Lange you have the floor.
- >> COMMISSIONER LANGE: Thank you Chair Eid, Commissioner Szetela I just have one question about and proposed language and everything when it states if a Commissioner is not available you used the reference as if they went up and went to the bathroom or what have you. So I'm just curious does that include when they are not present, if they are absent that would not be included in that, right, because the first time I read that, that is kind of how I took it, that if somebody is absent then on the next time they are there they can just come in and jump ahead of the next person who has waited in line. So can I get clarification on that? What the intent was.
- >> COMMISSIONER SZETELA: I kind of wrote it where someone is unavailable whatever the reason is. I'm agnostic on that and fine writing it if you are not there you missed your turn. I mean if that is what people want. I would love to hear from people what they think about that because you know there are arguments both ways. On one hand, like I said I would not want someone to miss for, you know, going to answer the door. If they have someone at the door. But on the other hand I think if someone is absent then in that circumstance, it might be a pass of a turn.
  - >> COMMISSIONER LANGE: That's all I got, thank you.
  - >> CHAIR EID: Thank you Commissioner Lange, Commissioner Kellom?
- >> COMMISSIONER KELLOM: I just wanted to say that, you know, I know that we are still reviewing those changes. One thing that I just had a particular I guess feeling about is not limiting the time I get for efficiency sake, why that recommendation could have been made and I would not want any Commissioner to feel deterred as I said

before when I said fear or uncertainty I feel like there is a lot of not projecting. There could be some angst when drawing then to think about a time stamp or trying to do it in a particular timeframe might be challenging. Because we don't know everyone's back. I come from an accommodation lens. People could have different styles of learning. Different accommodations needed looking at the screen and trying to draw. So I just wanted to add that piece about a timeframe or I don't think we should limit how long it takes someone to do something.

- >> CHAIR EID: Thank you Commissioner Kellom. Commissioner Lett?
- >> COMMISSIONER LETT: Thank you, Chair. Well, I think as Rebecca started out this is kind of the way we have been doing things. So I view this entire process as a solution looking for a problem. And I don't see a purpose in clogging up our rules in this manner. And so I'm not in favor of changing the rules to put something in writing. We have been doing already collaboratively and without a necessity of having a rule.
  - >> CHAIR EID: Thank you Commissioner Lett. Commissioner Vallette?
- >> COMMISSIONER VALLETTE: So I just wanted to say that I did not realize there was a problem with how we were mapping. I also want to say that I think this is a waste of time. I think we should be mapping. And not trying to rewrite the rules that there is not an issue with right now.
- >> CHAIR EID: Thank you, Commissioner Vallette. I will say my thoughts and then Commissioner Szetela, you can go after that.

I will keep my thoughts to actually like the text of the rules itself. I don't mind many of them. I just for clarity under subsection B, number 3 it says a selected Commissioner may elect to bring in a map or community of interest submitted to the Commission. And I would like clarification on what you mean by bring in. Right now anyone can bring in a map to view or they can draw a map that's on the public comment. I think the discussion last week was more so due to a motion to publish a map that nobody had seen. So I just want to make sure there is a difference between bringing in a map and incorporating the ideas in that map versus publishing a map to either the next step in the process, whether it be VRA review or to the public. So if you can just make sure when you look at, when you are looking at the rules for the next meeting if there is that clarification I would appreciate it.

Then as far as the time constraint goes I'm not sure if time is really the correct measure to use. Time isn't equal for a lot of the Commissioners here. You know, yourself are very quick at drawing maps and that's great. But some people take more time and, you know, I think you or I can do a lot more in an hour than some other folks might be able to do in an hour so that is not necessarily what I would consider to be fair. So those are my thoughts, if you can take that into consideration I would appreciate it. Commissioner Szetela?

>> COMMISSIONER SZETELA: Yeah, I just wanted to respond to both Commissioner Lett and Commissioner Vallette. I'm sure from their perspective they

don't see it's a problem because when it's their turn there isn't. There are other Commissioners who do not feel the rules are applied equally with skipping of turns, with respect to bringing outside maps and other map activity. From their perspective I'm sure it's fine. The reality is this is how we administered the map making process. I can think of at least two distinct occasions where we were told there is a rule when there isn't. And that was in forest against some Commissioners and not others and want to be sure everyone is treated fairly and actually memorializing the rules we have already been following so if there is a dispute we can look to the rule and say this is what the rule says other than it being in discretion of the Chair. Thank you.

- >> CHAIR EID: Commissioner Wagner?
- >> COMMISSIONER WAGNER: I just want to reiterate that my intent in bringing Mr. Scannell's map forward was not to publish immediately. Contrary to misinformation that spilled out of everyone's mouth. It was not to publish immediately. It was to be collaboratively working on it. So that's what I have to say.
  - >> CHAIR EID: Thank you, Commissioner Wagner. Commissioner Andrade?
- >> ELAINE ANDRADE: Yes, just my two cents, I like the clarification of what Commissioner Szetela did. And I think it could down the road streamline any discussions. So we can go ahead with them.

In terms of time limits, I don't think we need to have a time limit because as you said people who are good at mapping and can go and do things and at least, you know, when we started with the Senate we were doing a pretty good job of jumping in and collaboratively doing things. So I don't think a time limit is necessary.

And missing your turn, it could go either way for me. So that's all I have.

>> CHAIR EID: Okay, is there any more discussion on this topic? All right, well, Commissioner Szetela we look forward to seeing your final changes and we will go from there.

Next up on the agenda is item for consideration 5B Commissioner salary review. This was motioned to be put on the agenda by Commissioner Rhonda Lange. So without objection I will ask that she facilitate this item. Is there any objection? Commissioner Lange, the floor is yours.

>> COMMISSIONER LANGE: I'm going to be really brief because I know there is more important things to do. Last week I ran across a lot of public comment about the pay on this Commission. And the fact that sense we started mapping there hasn't been one meeting other than today that we've had a full Commission here. Pretty derogatory comments were made. I also attended a show last weekend. And there were some pretty derogatory comments again. Mind you I don't let people know I'm on this Commission because I know, at least in my area, we are not real popular. So I try and keep my personal out of this Commission. Because there has been some pretty nasty stuff. So it's not something that I go and broadcast.

The reason I brought it up last week is after the first day we mapped last week and then the second day we were still lacking as a whole, you know, we still didn't have a whole Commission. And my intent was not to point out anybody or anything, but I thought as a good faith I would bring it up because I was hearing public comment about it. And hoping that the Commission maybe reconsider what the motion that they made under the circumstances. But I don't plan on putting forth a motion. I don't want anybody to think that I just wanted you guys to be aware. So that's all I've got.

- >> CHAIR EID: Thank you, Commissioner Lange.
- Is there any further discussion on this?
- >> YVONNE YOUNG: Commissioner Curry has her hand up, sir.
- >> CHAIR EID: Yes, I see your hand Commissioner Curry. Please proceed.
- >> COMMISSIONER CURRY: Yes, I assume that you all are talking about that Podcast that we heard with Erin and Rhonda Lange. And I think you all put some damaging stuff out there. And it did not sound so good. Now you want to kind of take it back. But I heard it. And it wasn't nice. What you all were saying.
  - >> CHAIR EID: Let's try to keep this discussion to topic at hand being.
  - >> COMMISSIONER CURRY: They brought it up, they brought it up.
- >> CHAIR EID: But let's try to keep it to this discussion. All right, Commissioner Wagner?
- >> COMMISSIONER WAGNER: Commissioner Lange's hand was ahead of mine, and I just decided to put my hand down, thank you.
  - >> CHAIR EID: Thank you, Commissioner Lange?
- >> COMMISSIONER LANGE: I am going to respond because that was brought up. In that interview I was asked for my opinion. I gave an honest opinion just as I always do. Whether it is a popular opinion, or not. And under the Constitution, I still have a first amendment right as a citizen of this state and of this country and I will use it. Now, I did say it was in my personal opinion. I did not state anything negative as fact. It was under my opinion. And that has nothing to do with the comments that were received when people don't even know that I'm a Commissioner in my area. So the ones that I heard particularly to this area, they would not even know. So I brought up my point that I wanted to make and I'm going to leave it at that. Because I'm not going to get into a pissing match.
  - >> CHAIR EID: All right, there's nothing else, let's see. Commissioner Lett?
- >> COMMISSIONER LETT: I move to end debate or discussion on whatever it is we are doing on this subject.
  - >> COMMISSIONER WEISS: Second.
- >> CHAIR EID: There is a motion to end debate by Commissioner Lett. Seconded by Commissioner Weiss. That motion has no discussion and requires a two thirds vote. Can we have a roll call and I believe it also requires a roll call vote is that correct Department of State?

- >> MEGHAN SCHAAR: That is correct.
- >> CHAIR EID: All right, wonderful. Let's go ahead and take it, please.
- >> YVONNE YOUNG: Commissioners, the motion before you is to end discussion on the current topic. A yes vote means you are ready to end discussion. And would like to end discussion and a no vote means you are not. I will begin alphabetically with Commissioner Andrade?
  - >> ELAINE ANDRADE: Yes.
  - >> YVONNE YOUNG: Commissioner Callaghan?
  - >> DONNA CALLAGHAN: Yes.
  - >> YVONNE YOUNG: Commissioner Curry?
  - >> COMMISSIONER CURRY: Absolutely, yes.
  - >> YVONNE YOUNG: Commissioner Eid?
  - >> CHAIR EID: Yes.
  - >> YVONNE YOUNG: Commissioner Kellom?
  - >> COMMISSIONER KELLOM: Yes.
  - >> YVONNE YOUNG: Commissioner Lange?
  - >> COMMISSIONER LANGE: Yep.
  - >> YVONNE YOUNG: Commissioner Lett?
  - >> COMMISSIONER LETT: Yes.
  - >> YVONNE YOUNG: Commissioner Muldoon?
  - >> MARCUS MULDOON: Yes.
  - >> YVONNE YOUNG: Commissioner Orton?
  - >> CHAIR ORTON: Yes.
  - >> YVONNE YOUNG: Commissioner Szetela?
  - >> COMMISSIONER SZETELA: Yes.
  - >> YVONNE YOUNG: Commissioner Vallette?
  - >> COMMISSIONER VALLETTE: Yes.
  - >> YVONNE YOUNG: Commissioner Wagner?
  - >> COMMISSIONER WAGNER: Sure.
  - >> YVONNE YOUNG: Commissioner Weiss?
  - >> COMMISSIONER WEISS: Yes.
  - >> YVONNE YOUNG: Unanimously, Mr. Chair.
  - >> CHAIR EID: Wonderful. Thank you Department of State.
  - >> YVONNE YOUNG: You're welcome.
- >> CHAIR EID: That concludes items for consideration. Next up on the agenda is collaborative mapping. Without objections I will recall Commissioners to proceed in the collaborative mapping process as is outlined by the Commissioner's rules of procedure and collaborative mapping policies document. Is there any objection? Hearing none, it's decided that we will move forward.

We ended last week or not last week, we ended on Tuesday. I was finishing up some districts. We have Mr. Stigall assisting us from EDS again today. And all right let's get going folks. If we can just open up whatever we were doing last time and finish it. And then we can move on to the next Commissioner.

- >> MR. KENT STIGALL: Unmute. All right hello folks. So we left off with this plan, I believe, Commissioner Eid, you were editing. Is that where we want to pick up?
- >> CHAIR EID: Yes, pick up and it does not need a copy at this time. And I think were we just about done with one District and then there's the final District you can just fill in with the remaining area.
- >> MR. KENT STIGALL: Right. Let's get the display where we want it. Make the number so it's legible. Can everybody see the table here? Read the numbers?
  - >> CHAIR EID: I can read them.
- >> MR. KENT STIGALL: Okay, so we had gotten down, District 3 is left. We are going to change the color so we can better differentiate between 3 and 8. But if I recall right you worked your way down into this area. Let's turn on, get the neighborhoods. 8 is 1.14% so we want to put the rest.
- >> CHAIR EID: Rest of unassigned area put in 3 and the next Commissioner can take it and edit it from there. So this was an attempt to have -- we have one kind of set of maps that has a Down River District that extends up through the Detroit river through bell aisle and through downtown, through midtown, the educational areas. This is a little different. It has, well, it will have three-ish Detroit centered districts. One that is like Down River along with the west side of Detroit. One that is the east side of Detroit. As well as the areas of Warren and southern Macomb Counties and then a third that is a more of an I guess middle or centralized Detroit District that includes the downtown, midtown areas as well as would it include Hamtramck? I can't remember if we put Hamtramck in three, but I think it would also include Hamtramck. And the remaining portions of Detroit. But you know there is a lot of fine tuning that definitely can be done for it to make it better. It's very preliminary at this point and that's why we need to hear from the public so. Commissioner Weiss?
- >> COMMISSIONER WEISS: Yes, while Kent is doing that I have maybe a question or a suggestion. On all the maps that we have done, or let's say finished or filled in I guess would be a better term, would it not be a bad idea in our listing of on Mr. Stigall's computer that the map is finished in a sense that all the districts are filled in? So that we know which ones are not done when we go into do them and if anybody wants to go in and change a map that is already filled in, that's fine. And maybe a map that is filled in completely that we may think we want to turn in as a map that is finished, would it be maybe an idea to give it a different name or some number or something to note that? And maybe easier to find these later? Thank you.
- >> CHAIR EID: I think, you know, having something that says it's like filled in might be a good idea. I hesitate in giving it like a different collaborative name at this point just

because we have not had our first set of public comment yet. So until we have that, I find everything that we are doing to be pretty preliminary. And, you know, I personally just really want to have that first set of public hearings next week, before we enter that part of the process where, you know, folks get maybe a little bit more attached to different maps or mapping families. But I do think having something that says like at least, you know, maps AB and C have the districts all assigned could be a good idea.

- >> COMMISSIONER WEISS: That is what I was thinking, maybe that would help, you know, see what the rest of the Commissioners think about that maybe.
- >> CHAIR EID: Because on this one even though everything is assigned I hope all of you change it, you know. Please. Please. Take a look at it and do work on it collaboratively. Commissioner Szetela?
- >> COMMISSIONER SZETELA: Yeah, I was just going to say out on the website it does designate complete versus not complete, I know that is not exactly what you were referencing but we do kind of have those records available. Maybe just not in the title of the name that our map drawers are using.
- >> CHAIR EID: Wonderful. All right we will wait for Mr. Stigall to finish assigning these. .
- >> MR. KENT STIGALL: Chair, it looks like a little unassigned area here. Can we assume that looks more like it belongs in 8 than anywhere else?
- >> CHAIR EID: That's sure what it looks like to me. You can fix that. Those water blocks around Belle-Isle.
- >> MR. KENT STIGALL: Yes. I will put those in 8 just for appearances. We have a couple little pieces here. It looks like there is a median through there. No, it's not either. Do we have a preference as to it almost looked like this little piece where my pointer is should be in 12, just going by that is Pleasant Street and that is Spindler park. What is the will of the Commission?
- >> CHAIR EID: So I thought the first thing we did was locked 12 in this one. But it does look like that little triangle part and the rest of it should be in 8.
- >> MR. KENT STIGALL: Yeah, this is a Township boundary, that is the blue line. Probably just I don't know if there is any population there. So put that little piece in 12?
  - >> CHAIR EID: Put that in 12 and then put the rest in 8.
- >> MR. KENT STIGALL: You can see it's just a little sliver on the east. Yep. This should cover and I think that is it.
- >> CHAIR EID: Cool, that does it for me. Someone take this or change it or start your own or look into another plethora of maps we have. But that will do it for my turn, Ms. Schaar and Mr. Fink.
- >> MEGHAN SCHAAR: I want to indicate I'm going on the my redistricting website and I will pull which versions you have completed and put that together in a list for you and I can actually match that up to my notes and let you know which Commissioners

worked on those versions. And present that to the Commission a little bit later today. That way you don't have to take mapping time to do so.

- >> CHAIR EID: That would be very helpful. Thank you. Mr. Fink?
- >> NATE FINK: Thank you, Mr. Chairman. I was just going to recommend that perhaps you wanted to run partisan fairness on this completed map. But if not that is fine too. If you are not enthused about this particular map.
  - >> CHAIR EID: I think I will wait for now.
- >> NATE FINK: That is fine, just a suggestion. And just an overall comment with everybody of course just to keep in mind the ranked criteria. And, you know, commenting on those as you go through your mapping process. Thank you.
  - >> CHAIR EID: I just think there is still a lot of work to be done on it, Nate.
  - >> NATE FINK: Just as an overall reminder, thank you.
  - >> CHAIR EID: Commissioner Orton?
- >> CHAIR ORTON: I was thinking that is a good idea when we fill in an entire map so people might know whether this is a good starting point for them, if they want to work only it, or not. It shouldn't take very long.
  - >> CHAIR EID: Would you like to see it, Commissioner Orton?
  - >> CHAIR ORTON: I think it would be good.
  - >> CHAIR EID: Okay, well then we can run it.
  - >> MR. KENT STIGALL: Updated or the most recent?
  - >> CHAIR EID: The updated, please.
- >> MR. KENT STIGALL: Updated. While I have the floor just real quick, should we give this plan another name? Because it has yesterday's date, Tuesday's date on it. And it was uploaded to the website, you know, with the 430 name. Somebody says I've got the wrong field. Screen sharing has stopped. So I got to restart screen share. Yep. I hit the wrong dumb field. So now we have the right fields. Is everybody seeing the share?
  - >> CHAIR EID: Yes, we can see it.
- >> MR. KENT STIGALL: You got it. All right. The lopsided margin advantage favors republican 3.8%. The mean median difference 2.7% republican. The efficiency gap is .7% democrat. And the seats-vote ratio is minus 5.1% republican. The number of seats is 22 democrat, 16 republican.
- >> CHAIR EID: Okay, thank you. It's interesting, those are literally the exact same numbers as the last one we looked at the other day. So interesting even though it's quite a different configuration.
- >> COMMISSIONER SZETELA: Would you repeat those? Kent I did not catch all of them.
- >> MR. KENT STIGALL: Okay, I'll have to go back to it. Did somebody write them down?
  - >> CHAIR EID: It's 3.8, 2.7, 0.7.

- >> COMMISSIONER SZETELA: Anthony can you actually give what the numbers are like lopsided margin.
- >> CHAIR EID: Yes. Lopsided margin is 3.8. Mean median difference 2.7. Efficiency gap 0.7. Seats to votes negative 5.1.
  - >> COMMISSIONER SZETELA: Negative 5.1 with a what 22 Eid to 16.
  - >> COMMISSIONER SZETELA: Thank you.
- >> MR. KENT STIGALL: I have it on the screen now. It should be on the screen anyway.
  - >> CHAIR EID: You are not sharing.
- >> MR. KENT STIGALL: It disconnects whenever it feels like it so get over here. You want to look at these again Rebecca or you got them?
- >> COMMISSIONER SZETELA: If you can click through them quick that would be helpful. There is your lopsided margin.
  - >> COMMISSIONER SZETELA: Yep.
  - >> MR. KENT STIGALL: Mean median.
  - >> COMMISSIONER SZETELA: Okay.
  - >> MR. KENT STIGALL: Efficiency gap.
  - >> COMMISSIONER SZETELA: Okay.
  - >> MR. KENT STIGALL: And then seats to votes.
  - >> COMMISSIONER SZETELA: Okay thank you very much.
- >> MR. KENT STIGALL: It disconnects. It disconnects to share whenever it feels like it.
  - >> COMMISSIONER SZETELA: Uh-huh.
- >> CHAIR EID: All good, okay, that does it for me. We will move on to the next Commissioner.
- >> MR. KENT STIGALL: Excuse me, Chair, do we want -- can I get -- I want to give it today's date because this plan was uploaded as a partial plan and now it is a complete plan.
  - >> CHAIR EID: Sure.
- >> MR. KENT STIGALL: Just so we can't replace what is up there. I don't think we should anyway. So that is what we just did. Okay.
  - >> CHAIR EID: Thank you for the assistance, Mr. Stigall.

Next up is, get the list out, folks, Commissioner Kellom? There are a number of maps now. I'm sure you looked at all of them on the website so you can either work on any of those or start a new one. The floor is yours.

- >> VICE CHAIR KELLOM: Yeah, I have been looking on the website, but I watched, I watched the meetings that I missed. And saw. So for me the easiest thing would just be to start with Linden and punch out the areas I wanted to change and Kent your hand is still raised and I'm sure it's an accident, but I wanted to tell you.
  - >> MR. KENT STIGALL: Yes, you are right. I need to learn how to do that.

- >> VICE CHAIR KELLOM: So if we started with Linden and like just a brand-new situation. It's easier for me to start there. I will say I liked the direction that Commissioner Szetela and while Kent is doing that, and Commissioner Eid were traveling in. So what I'm going to attempt to do. And folks can chime in as they feel comfortable is to use some of that but go a little bit further. I thought Commissioner Eid was going to maybe do that with the map that got abandoned temporarily but that did not happen. So I'm going to start in Detroit and try to maximize making some Detroit centric districts, maybe three or four. And then inevitably just to, I'm giving all this preface, so we are clear about what I'm doing, and Nate likes this kind of stuff so. That will incredibly affect the surrounding districts. My personal opinion is similar to the House maps, I think if we were charged to redraw the maps and do our best job, then that's going to really require some fixing and not just changing minor details. So if we start with Linden and remove the districts that were challenged. Is that 1, 3, 6, 8, 10, 11 I think.
  - >> CHAIR EID: Yep.
- >> MR. KENT STIGALL: So we are just going to delete the districts is that the idea of one?
  - >> COMMISSIONER KELLOM: Yes, please.
  - >> MR. KENT STIGALL: Delete the entire thing?
- >> COMMISSIONER KELLOM: The entire thing. I can't work with just my brain. I have to just have to have it gone and if it ends up being similar to before that is why I need to not see. I can't work inside out.
  - >> MR. KENT STIGALL: So 1, 3, 8, 10.
- >> VICE CHAIR KELLOM: 1, 3, 6, 8, 10. I'm not sure how much 11 will change but 11 too. I know it will.
- >> MR. KENT STIGALL: Oh, yeah, 11 is up there. So 11 erase. Okay, fairly edited it. From where do you want to start?
  - >> COMMISSIONER KELLOM: Can you erase 2, 4 and 5 as well?
  - >> MR. KENT STIGALL: Absolutely. Very clean slate.
- >> VICE CHAIR KELLOM: Then can you now put the neighborhood overlay? 7 and I think 13 are going to have to be adjusted as well but I'm going to start here because I'm starting with the or neighborhood names, I'm sorry, neighborhood names.
  - >> MR. KENT STIGALL: So the neighborhood names are.
  - >> VICE CHAIR KELLOM: It looks like a word scramble.
  - >> MR. KENT STIGALL: It is because we have to Zoom in to some extent.
  - >> VICE CHAIR KELLOM: Okay, so.
  - >> MR. KENT STIGALL: About where do we want to start? North, south, east, west?
- >> COMMISSIONER KELLOM: Want to start on the east side and I will start calling off neighborhoods. I think that would be the easiest way to create this downtown, east side, Down River.

- >> MR. KENT STIGALL: Okay Down River.
- >> VICE CHAIR KELLOM: Go east. I want to start east. So.
- >> MR. KENT STIGALL: Here is Grosse Pointe.
- >> VICE CHAIR KELLOM: Up a little bit more.
- >> MR. KENT STIGALL: You want to go, okay northeast.
- >> VICE CHAIR KELLOM: Okay, yes, I will be more specific. So I want you to select Moross-Morang, then Yorkshire Woods.
  - >> MR. KENT STIGALL: Let me find them.
  - >> VICE CHAIR KELLOM: Cornerstone, East English Village, Morningside.
- >> MR. KENT STIGALL: New selection. So what number do you want? Do you want that to start with one? District 1?
- >> COMMISSIONER KELLOM: Sure, all of that Moross-Morang, Denby, Yorkshire Woods. Down to the river. Not into 12, no, don't go up, no, not that.
  - >> MR. KENT STIGALL: I'm with you and behaving with me.
  - >> VICE CHAIR KELLOM: Take the airport and that is another thing.
  - >> MR. KENT STIGALL: River Bend, Chalmers, Belle-Isle, down in here?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: Remainder of blocks.
- >> VICE CHAIR KELLOM: I don't want you to move too far yet because there are some, Wade, Raven Dale, Chandler Park, select that as well. Come south, yep. And then we are following the curve. There are some that is in the airport and they should not be selected.
- >> MR. KENT STIGALL: Yes and we will have to split them out by blocks I think. That is a precinct.
  - >> VICE CHAIR KELLOM: We will do that later.
  - >> MR. KENT STIGALL: So you want to come down?
  - >> COMMISSIONER KELLOM: Yes, all of that. Gratiot Town, Kettering.
  - >> MR. KENT STIGALL: Okay.

## Next.

- >> VICE CHAIR KELLOM: All of McDougall, Elmwood Park Lafayette Park, Downtown, Greektown.
  - >> MR. KENT STIGALL: Medical center or is that?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: Midtown?
- >> COMMISSIONER KELLOM: Yes, sorry, I feel like I'm so close to my computer but I'm trying to see. It's a weird angle.
  - >> MR. KENT STIGALL: Okay, it looks like I got Wayne state area here.
- >> VICE CHAIR KELLOM: Uh-huh, that's fine. Woodbridge, Core City, North Corktown and Corktown and Northern Rashire.

- >> MR. KENT STIGALL: These precincts run kind of crazy. Like that part. You may want, I guess.
- >> VICE CHAIR KELLOM: Yeah, I don't want Eliza and McCoy, but we can fix that later.
- >> MR. KENT STIGALL: We can trim that out as you go. Let me get to Chadsey-Condon.
  - >> VICE CHAIR KELLOM: Chadsey-Condon.
  - >> MR. KENT STIGALL: Hubbard Richard area?
- >> COMMISSIONER KELLOM: Everything along the Detroit river we are going to take. Spring Wells, Oak wood heights, Carbon Works, I'm sorry.
- >> MR. KENT STIGALL: Yep, I got you. Do we want to go into Carrie town or stay out of that?
  - >> COMMISSIONER KELLOM: Where are you talking I see clay town, yes.
  - >> MR. KENT STIGALL: Grab clay town area?
- >> COMMISSIONER KELLOM: Not all of it. There is like a puzzle piece, yep. And then that little piece in the upper left, upper left corner by the, yep, that little piece.

That's it. That is all we need from that.

>> MR. KENT STIGALL: Okay.

So we go continue Down River?

- >> COMMISSIONER KELLOM: Yes. Melvindale.
- >> MR. KENT STIGALL: Melvindale. Boynton, Ecorse?
- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: I don't think we wanted to go up there, did we?
- >> COMMISSIONER KELLOM: No.
- >> MR. KENT STIGALL: Something like that. That is Melvindale.
- >> COMMISSIONER KELLOM: Yes, that's correct. I don't want all of Ecorse, thank you, because I needed to see.
- >> MR. KENT STIGALL: We are getting down, I can't see the exact number, but 44,000.
- >> VICE CHAIR KELLOM: Can you, that little piece I forget, it squares off at the bottom. It's next to the little piece of Ecorse next to Lincoln Park, can you select that?
  - >> MR. KENT STIGALL: Yes, yes, I see it.
  - >> VICE CHAIR KELLOM: Can we Zoom in?
  - >> MR. KENT STIGALL: There is a little piece of Ecorse as well, I can do Township.
  - >> VICE CHAIR KELLOM: That's what I mean.
- >> MR. KENT STIGALL: So that is Ecorse. So make sure we get all of it in one place.
  - >> VICE CHAIR KELLOM: Okay.

>> MR. KENT STIGALL: So this is all of Lincoln Park.

- >> VICE CHAIR KELLOM: I think I want to take some of Lincoln Park though but only up to Southfield road, so you are going to have to really go to The Street level for that.
- >> MR. KENT STIGALL: I'm headed there. As soon as this thing starts doing what it's supposed to do. That is Southfield road right here.
- >> VICE CHAIR KELLOM: Yep, so I want to take everything Southfield road and above goes into 1.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: Not all of that.
  - >> MR. KENT STIGALL: Yeah, I know. All right, got you. We still have 28,000.
- >> VICE CHAIR KELLOM: Don't Zoom back out but go back in there. I think, go back down to The Street level. I have notes I'm looking at.
  - >> MR. KENT STIGALL: Southfield, 39, Chandler, Ferris.
- >> VICE CHAIR KELLOM: Where is Fort Street, that is what I'm looking for. Southfield.
  - >> MARCUS MULDOON: 85.
  - >> MR. KENT STIGALL: 85 that is Fort Street and that is right there.
- >> VICE CHAIR KELLOM: Right there. So I want that portion of Fort Street down to London avenue. I think that is that little chunk. Right there is London right here.
  - >> MR. KENT STIGALL: Yep right there.
- >> VICE CHAIR KELLOM: Yep. And it continues west, but I want that little piece, please.
- >> MR. KENT STIGALL: So that will get it. And that is wrong because we need to do census blocks I think.
- >> VICE CHAIR KELLOM: Take the chunk out and it's to the left right there, that is a little precinct, to the left of that, no, left London continues on the other side and goes west, yep, that chunk, that little angular chunk, that is the one that I would like. Not that piece.
  - >> MR. KENT STIGALL: This piece?
  - >> COMMISSIONER KELLOM: Yep.
- >> MR. KENT STIGALL: I will get over here and so we have that precinct and you wanted to put into 1, correct?
  - >> COMMISSIONER KELLOM: Yes, and that next little slice over. Yep.
  - >> MR. KENT STIGALL: This piece?
  - >> COMMISSIONER KELLOM: Uh-huh.
  - >> MR. KENT STIGALL: That is only pre...okay.

#### Okay.

- >> VICE CHAIR KELLOM: And then Allen Park.
- >> MR. KENT STIGALL: Allen Park.
- >> VICE CHAIR KELLOM: Yep.
- >> MR. KENT STIGALL: The whole Township?

- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: All right, we will select it.
- >> COMMISSIONER KELLOM: And that should be Pelham.
- >> MR. KENT STIGALL: Okay and that will make it a little too large.
- >> VICE CHAIR KELLOM: I will deselect that later.
- >> MR. KENT STIGALL: You are 6,000 over 2.25 percent but we did have population in Detroit that you wanted to remove because it went into other.
  - >> VICE CHAIR KELLOM: Yeah. I forgot about that.
- >> MR. KENT STIGALL: So if we trim those, you know, off, you know, I don't know how many people it is. But it's going to change. Right now, you know, you are 2.52% high.
  - >> VICE CHAIR KELLOM: Go down a little and Zoom back out slightly.
- >> MR. KENT STIGALL: Like we don't have all of Outer Drive, Hayes, we are missing a piece, but we have all these extra areas, okay.

  Go back down.
- >> VICE CHAIR KELLOM: That is fine and how I want to leave it. Okay, I'm going to take a tour. So I'm now going to go into, do I want to go that way? We can go up. No, I want to come around.
- >> MR. KENT STIGALL: It looks like we impacted 12 in some fashion by doing whole precincts.
  - >> VICE CHAIR KELLOM: Hum.
  - >> MR. KENT STIGALL: We would have to do an overlay, but I'm guessing.
  - >> VICE CHAIR KELLOM: Over there?
- >> MR. KENT STIGALL: Yeah. I mean, like this Township. Yeah, I don't know where it was. But12 was not 2.8% low, was it?
- >> COMMISSIONER KELLOM: I don't remember. Okay, let's keep going for right now.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: So if you Zoom in I mean if you want to clean that little area up, I only wanted to include where it says Grosse Pointe park that should be outer row and if it stops there and I think it's alter row then by River Bend going south River Bend, what is that Jefferson Chalmers That Street close to the number 12 should be alter.
  - >> MR. KENT STIGALL: Okay, yeah, that is Grosse Pointe park there.
  - >> VICE CHAIR KELLOM: And the street should be Alter Road.
  - >> MR. KENT STIGALL: This is Alter here.
  - >> VICE CHAIR KELLOM: Okay, so you can take it back to Alter.
- >> MR. KENT STIGALL: Neighborhood boundary should be in over there, but I don't know how precise that is.
  - >> VICE CHAIR KELLOM: It's okay.

# Let's move on.

- >> MR. KENT STIGALL: Do you want to put this over into 12?
- >> COMMISSIONER KELLOM: Uh-huh. It's not going to make a huge difference, but.
- >> MR. KENT STIGALL: Yes, see, did we want to unassign these or wait until you do the districts.
- >> VICE CHAIR KELLOM: You can unassign them now if you like, but the next District will be the one right next to it so.
- >> MR. KENT STIGALL: All at one time, unassigning and reassigning them. This part of, this part, should that be in 1.
  - >> VICE CHAIR KELLOM: Yes.
  - >> MR. KENT STIGALL: Okav.

# That is not right.

- >> COMMISSIONER KELLOM: The little parts in Eden garden assigned to one will be assigned to whatever we number that District.
  - >> MR. KENT STIGALL: Okay do you want to do that now?
  - >> COMMISSIONER KELLOM: Sure.
  - >> MR. KENT STIGALL: You want to call it two or three?
- >> COMMISSIONER KELLOM: It does not matter. Two is fine. Three is fine.

## Whatever.

- >> MR. KENT STIGALL: I'm just going straight to two because that is where we are at.
  - >> VICE CHAIR KELLOM: Okay.
  - >> MR. KENT STIGALL: All this is also two?
- >> COMMISSIONER KELLOM: That little part that juts out, the long, it's not a rectangular part but that can be included in one but that little square you can keep in one.
  - >> MR. KENT STIGALL: This in one?
- >> COMMISSIONER KELLOM: That should not be in one. That trapezoid looking thing, Rhombus I don't know Trig that well. That does not go into one. Kent, wait, wait.
  - >> MR. KENT STIGALL: I'm just highlighting it.
- >> VICE CHAIR KELLOM: The piece to the left can stay into one. The piece that goes along the curve needs to be unassigned.
  - >> MR. KENT STIGALL: Okay.

## So this area right here.

- >> VICE CHAIR KELLOM: Unassign that piece only.
- >> MR. KENT STIGALL: And this piece right here.
- >> VICE CHAIR KELLOM: Leave it alone for right now.

- >> MR. KENT STIGALL: Okay, unassign is slow compared to just putting it in a District.
- >> VICE CHAIR KELLOM: I'm going to have to go back and fix the area because I just told you the wrong area and want to go to another District. It really should be assigned I think. I know where the error is. I don't think it is, it's something in that area and down by Allen Park that I need to fix. But put that into one, the little triangle you put into one and I will fix the population later into one. Yep, all of that put into one.
  - >> MR. KENT STIGALL: That clears it up, what I was trying to get at.
  - >> VICE CHAIR KELLOM: Uh-huh.
- >> MR. KENT STIGALL: My guess is that is just a clover leaf around that intersection.
  - >> VICE CHAIR KELLOM: Okay.
  - >> MR. KENT STIGALL: Yes.
- >> VICE CHAIR KELLOM: Some parts that need to be de or unselected or unassigned are in the but the Outer Drive Hayes area. But I will do that later. Let's go on to District 2.
  - >> MR. KENT STIGALL: Okay, where is that going to be located?
  - >> COMMISSIONER KELLOM: Right next to District 1, the part you have green.
  - >> MR. KENT STIGALL: Okay, we will start right there.
  - >> VICE CHAIR KELLOM: Yep. So you can select.
  - >> MR. KENT STIGALL: Airport?
- >> COMMISSIONER KELLOM: Yes and Maple ridge. Von Steuben, Franklin, Connor Creek.
- >> MR. KENT STIGALL: Kind of takes all and didn't solve. We have to come back and like I said we started doing blocks to really get it right.
  - >> VICE CHAIR KELLOM: Okay.

Connor creek, no leave regent park and Mohegan empty.

- >> MR. KENT STIGALL: Pulaski.
- >> VICE CHAIR KELLOM: Yes and all of Connor creek, Nor town.
- >> MR. KENT STIGALL: Okay.
- >> CHAIR EID: Commissioner Kellom, I would just suggest picking a different number just for consistency with the other drafts. Two and all of the other ones is.
  - >> VICE CHAIR KELLOM: Kent don't select Sherwood.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: Okay what were you saying?
- >> CHAIR EID: Saying you might want to pick a different number other than two to be consistent with the other drafts.
  - >> VICE CHAIR KELLOM: Okay.
- >> CHAIR EID: Two is I think in all the other ones the Dearborn area. This area is in all the other drafts either 8 or 11.

- >> VICE CHAIR KELLOM: Sure, whatever suggestion. You all are free to help. I'm just trying to nail down the shape of these districts and the neighborhoods. So whatever fine tuning in terms of numbers or that type of thing, I fully expect and accept and receive other Commissioners to catch those things.
  - >> MR. KENT STIGALL: I think I renumbered it eight if I did it correctly.
- >> VICE CHAIR KELLOM: Okay, yep, so now we are dealing with 8 up in this region. So we got, you know, most of nor wood and start getting into doing census blocs census blocs, you know, the little pieces.
- >> VICE CHAIR KELLOM: That little area will be fixed at the top, so Grant, Davison, Buffalo Charles, Krainz Woods, Conant Gardens, all of that needs to be selected, all the way up to 8 Mile. But around -- so let me be specific here so I don't have to clean up everything. You see far well there is a little piece in the upper right corner of far well you will leave unassigned.
  - >> MR. KENT STIGALL: That piece up here or over there?
- >> COMMISSIONER KELLOM: Over there is the upper right corner you will leave that little piece unassigned.
  - >> MR. KENT STIGALL: All of Sherwood unassigned?
- >> COMMISSIONER KELLOM: Yes. There needs to be more that is assigned to 8 but there needs to be more unassigned that is assigned to that top part of eight, but I will fix that later.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: I will fix that in the next District.
- >> MR. KENT STIGALL: So we come right across here. Assign selected. And then, yeah, this little precinct here goes all the way into North Campau do we want to do that?
  - >> COMMISSIONER KELLOM: Yes, all of that into eight.
  - >> MR. KENT STIGALL: All that into eight.
- >> COMMISSIONER KELLOM: Go back up to far well, not that piece but the piece that is to the left that needs to be assigned. I think you can do it at the block level.
  - >> MR. KENT STIGALL: Something like that?
- >> COMMISSIONER KELLOM: Yes. And the lower part -- leave that literal square unassigned, yep. Uh-huh.
  - >> MR. KENT STIGALL: What about this Persian, Connick Garden.
  - >> VICE CHAIR KELLOM: All of that to the left should be assigned to eight.
- >> MR. KENT STIGALL: Okay, I think this goes over. Do you want the northeast Central to go?
- >> COMMISSIONER KELLOM: Zoom out so I can see where we are going but District 8 is going to go all the way over, if you wanted to use A Street, a part of the western border is going to be greenfield.
  - >> MR. KENT STIGALL: Okay so State Fair, Penrose, Hawthorne, all those?
  - >> COMMISSIONER KELLOM: Uh-huh, yes.

>> MR. KENT STIGALL: Okay.

What about Highland Park? Bangla Town and Highland Park?

- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: Okay Hamtramck?
- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: Something like that Hamtramck, Highland Park, all that?
- >> COMMISSIONER KELLOM: Uh-huh.
- >> MR. KENT STIGALL: Green acres Palmer Woods?
- >> COMMISSIONER KELLOM: You can go down there and select into 8, the boundary for eight is right against one.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: So that curving line is one and that is the Ford or 94 freeway, yep, all of that.
  - >> MR. KENT STIGALL: Okay.

I will assign that date because there is less of that, Goldberg, northwest.

- >> VICE CHAIR KELLOM: Yes and then you can go back up because I need to see.
- >> MR. KENT STIGALL: Yeah, this little piece is supposed to be in one.
- >> VICE CHAIR KELLOM: Yeah.
- >> MR. KENT STIGALL: I will do that how and fix it. All right, blocks.
- >> COMMISSIONER KELLOM: Can you Zoom out a little? Okay, thank you, where was I?
- >> MR. KENT STIGALL: Detroit, I'm assuming this little piece I have the cursor on should be eight?
  - >> COMMISSIONER KELLOM: Yes and the little piece unassigned in green acres.
  - >> MR. KENT STIGALL: Right, okay.

This District.

- >> VICE CHAIR KELLOM: All the way to greenfield, if you wanted to go west to greenfield and that is the boundary, greenfield road, not that neighborhood greenfield to be clear.
  - >> MR. KENT STIGALL: I don't know where green field road is but we will find it.
- >> VICE CHAIR KELLOM: It's just the freeway, the lodge that you just crossed that is the line.
  - >> MR. KENT STIGALL: This is greenfield right here, where my cursor is.
  - >> VICE CHAIR KELLOM: Green field road?
  - >> MR. KENT STIGALL: Yes.
  - >> VICE CHAIR KELLOM: That is right.
  - >> MR. KENT STIGALL: So, yeah, greenfield is here.
- >> VICE CHAIR KELLOM: We are going to select all of that. But the southern border of this little chunk is going to be 6 mile. So any way win ship.

- >> MR. KENT STIGALL: Up here next to 7 what do you want to do with this? This is in 7. Do you want to edit 7?
- >> COMMISSIONER KELLOM: Yes, 7 is going to be edited. So that should be selected. And put into 8. Keep selecting yes, that piece and the piece under E 7-Mile lodge and San Bernardo, that all goes into 8. Okay.

And go south or scroll down. No, no, stay in that little what do I want to call that, the northwest corner. So that is that Fitzgerald and Mary Grove, where is that? There. Can you select that and put that into 8? Chalfont goes into 8 and Davison, Schoolcraft, Pilgrim Village, Martin Park and Dexter-Finkle. To the right like everything to the right.

- >> MR. KENT STIGALL: I see it, yeah. I guess Martin park and Pilgrim village.
- >> VICE CHAIR KELLOM: Uh-huh. Okay, wait a minute. McFarland. You can select Dexter Linwood.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: And Nardin Park.
  - >> MR. KENT STIGALL: Jamison and Windermere and down in this area.
- >> VICE CHAIR KELLOM: Right against District 1, all of that is selected. Midwest, that little stair, upside down stair step next to clay town that should be in District 8 as well.
  - >> MR. KENT STIGALL: This you want to put all this in 8?
  - >> COMMISSIONER KELLOM: Yes, Midwest. And then.
  - >> MR. KENT STIGALL: Kind of split clay town a little bit right here.
- >> VICE CHAIR KELLOM: I see that, and a piece of Barton McFarland goes, uh-huh. Yes.
- >> MR. KENT STIGALL: When you say a little piece do you mean like a precinct or two like that?
  - >> COMMISSIONER KELLOM: Or four.
  - >> MR. KENT STIGALL: Okay then we have up here?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: And here?
  - >> COMMISSIONER KELLOM: Yes. And that final little sliver.
  - >> MR. KENT STIGALL: This?
- >> COMMISSIONER KELLOM: Yes and that top piece. No, not that. That is still in Barton McFarland.
- >> MR. KENT STIGALL: Like that so we may have to use blocks because it goes across.
- >> COMMISSIONER KELLOM: The piece unassigned should go into be 8 and the neighborhood boundary.
  - >> MR. KENT STIGALL: This Section here should be in 8.
  - >> VICE CHAIR KELLOM: Yes and the left portion that is unassigned.
  - >> MR. KENT STIGALL: Okay, like this?

- >> COMMISSIONER KELLOM: Uh-huh.
- >> MR. KENT STIGALL: That should all go to 8?
- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: Is that correct?
- >> COMMISSIONER KELLOM: Can you go north a little? Yes, that is correct. Grand River should go into 8.
  - >> MR. KENT STIGALL: Grand River or this little piece of Littlefield?
  - >> COMMISSIONER KELLOM: That little piece of Grand River.
  - >> MR. KENT STIGALL: This area like this part?
  - >> COMMISSIONER KELLOM: Uh-huh.
  - >> MR. KENT STIGALL: Into 8.
  - >> VICE CHAIR KELLOM: I'm sorry I should not have said that. That is wrong.
  - >> MR. KENT STIGALL: That is all right. We will undo it and move along.
- >> VICE CHAIR KELLOM: It's the part above, you were right, it's the part above that goes into 8.
  - >> MR. KENT STIGALL: Like this little piece right here.
  - >> VICE CHAIR KELLOM: Yes and the piece to the left of it, the precincts to the left.
  - >> MR. KENT STIGALL: Okay.

Do we come up and get these triangular pieces?

- >> COMMISSIONER KELLOM: And yes and the pieces of that because we will get northwest community and when we split Happy Homes. But and go north, please.
- >> MR. KENT STIGALL: Wait for it to catch up. And I'm saving because I don't want to have to do this multiple times.
  - >> VICE CHAIR KELLOM: That piece of northwest that we didn't get.
  - >> MR. KENT STIGALL: Did we get all of it.
- >> VICE CHAIR KELLOM: Myers That Street to the left by the Happy Homes boundary, I want to see that.
  - >> MR. KENT STIGALL: That is Myers, yes.
- >> VICE CHAIR KELLOM: Okay, great. Thank you, Jesus. Sorry but I'm not sorry. And then go Myers all the way up to 6 mile should be selected. Into 8. So it's probably that little piece.
  - >> MR. KENT STIGALL: So where is 8 Mile up? That is all the way up.
- >> VICE CHAIR KELLOM: No, up to 6-mile, West McNichols and 6 mile and West McNichols are the same thing.
  - >> MR. KENT STIGALL: Is that 6 mile right here?
- >> COMMISSIONER KELLOM: It should be. Because that is under Schultz and try point so it should be 6 mile, it is.
  - >> MR. KENT STIGALL: Yes, it is with 8 Mile right up there.
  - >> MR. KENT STIGALL: District 8 is 5700 high at this point.
  - >> VICE CHAIR KELLOM: Okay.

- >> MR. KENT STIGALL: And one is 57, also 5700 high. But, you know, you are only talking about a couple or half a precinct or half.
- >> VICE CHAIR KELLOM: So the piece we have on Barton McFarland there is another piece I can fix. We can -- that needs to be assigned to another District, that little cut out that I painstakingly had you select. My apologies.
  - >> MR. KENT STIGALL: So where are you saying.
  - >> VICE CHAIR KELLOM: Unassign that. Yes, that goes into the District next to it.
  - >> MR. KENT STIGALL: Okay, I'm not doing this on purpose, it's kind of...
  - >> VICE CHAIR KELLOM: That is fine unassign that chunk and we can fix Sherwood.
- >> MR. KENT STIGALL: Wonder if they will let me assign by precincts. I don't know that it will but...yes it does you want to unassign the precinct.
  - >> VICE CHAIR KELLOM: The Barton McFarland piece.

It goes somewhere else. Leave that little curve into 8 but that little chunk there, you can unassign that.

- >> MR. KENT STIGALL: You want to unassign this?
- >> COMMISSIONER KELLOM: Nope, you can leave that. It was just that little piece.
- >> MR. KENT STIGALL: Okay.

8 now is within 1% total pop.

- >> VICE CHAIR KELLOM: Still go back to Sherwood, that is close to 8 Mile.
- >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: So more northeast. That little piece Sherwood and far well let's try to clean that up.
  - >> MR. KENT STIGALL: In what way? Do you want to assign it or?
- >> COMMISSIONER KELLOM: No, let me see. Sherwood, so that piece that is assigned to 8 that's the left half of nor town can you unassign that? Right where your cursor just was. That piece right there, yep. Can you unassign that? And can you verify that That Street is 7-Mile, it should be, east.
  - >> MR. KENT STIGALL: Yeah, east 7-Mile is right here where my cursor is.
- >> VICE CHAIR KELLOM: Then if you continue to go east that piece should stop Ativan dyke is that next to Van Dyke? It is.
  - >> MR. KENT STIGALL: It says route 53.
  - >> VICE CHAIR KELLOM: So come up and can you Zoom in, please?
  - >> MR. KENT STIGALL: Am I in the right area?
- >> COMMISSIONER KELLOM: That is not bliss, I can't because it's right down on the line so go south. Unassign that little precinct right underneath the number 8 where it says playground, unassign -- I'm sorry keep that unassign was above, above that.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: Sorry, I misspoke.
- >> MR. KENT STIGALL: We are good. We will get it. Hold on a second. So assign north of this area?

- >> COMMISSIONER KELLOM: Yes, that piece. No not too much. Do chunk by chunk precinct by precinct.
  - >> MR. KENT STIGALL: That was a precinct right there.
  - >> VICE CHAIR KELLOM: Okay.
  - >> MR. KENT STIGALL: Yes.
  - >> VICE CHAIR KELLOM: I don't want that to be like that.
  - >> MR. KENT STIGALL: Outer bank and royal Vance.
- >> VICE CHAIR KELLOM: That is fine. What is that over there? I'm sorry, I'm getting close to is that east Outer Drive?
  - >> MR. KENT STIGALL: Where do we want to be?
  - >> COMMISSIONER KELLOM: The other side of Sherwood is that east Outer Drive?
  - >> MR. KENT STIGALL: This?
  - >> COMMISSIONER KELLOM: To the right.
  - >> MR. KENT STIGALL: Slide over, that is Connor right here.
  - >> VICE CHAIR KELLOM: And what is that?
  - >> MR. KENT STIGALL: Savage across the top.
- >> VICE CHAIR KELLOM: Running perpendicular. So that is Sherwood, I'm talking about where it says Connor creek, I can't see the name.
  - >> MR. KENT STIGALL: This is Norbank Street.
  - >> VICE CHAIR KELLOM: Running north and south what is That Street.
- >> MR. KENT STIGALL: Says route 53 Without A Street name so if someone can weigh in on what 53 is, it would be helpful.
  - >> VICE CHAIR KELLOM: I'm looking for Outer Drive. I'm sorry, I'm limited by.
- >> MR. KENT STIGALL: Outer Drive is this right here, is that Black line. So I went out and it's still on my pointer. So Outer Drive is right across here. East-west, right in the middle of your screen.
- >> VICE CHAIR KELLOM: It should, Outer Drive also runs...Van Dyke, next to Outer Drive and it runs down, it dips down.
  - >> MR. KENT STIGALL: My cursor the pointer is on Outer Drive going.
  - >> VICE CHAIR KELLOM: Okay.

## So that little.

- >> MR. KENT STIGALL: This is Outer Drive right up all the way around.
- >> VICE CHAIR KELLOM: See the yellow line the precinct line can you unassign, no, above that, can you unassign that? Yep, okay, let's go to the next District.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: I want to go to Taylor.
  - >> MR. KENT STIGALL: Taylor is down south near Dearborn.
  - >> VICE CHAIR KELLOM: Yeah.
  - >> MR. KENT STIGALL: You are going to start with just all of Taylor?
  - >> COMMISSIONER KELLOM: Yep, you good it dude.

- >> MR. KENT STIGALL: Two has been down in this area I believe.
- >> VICE CHAIR KELLOM: I will depend on one of my....
- >> MR. KENT STIGALL: I believe two has been down, no, I know it has been down around 1, Melvin, this area.
- >> VICE CHAIR KELLOM: And, wait, okay, Zoom back in. Because I'm going to do a detail first. Zoom in right where you were with Taylor.
  - >> MR. KENT STIGALL: Here is Southgate.
- >> VICE CHAIR KELLOM: I see that, but I need the top part of two, need to see the top part of two, not that area. The little precincts I want to get while we are there. That square right on top of two.
  - >> MR. KENT STIGALL: Like right across here?
- >> COMMISSIONER KELLOM: I don't need all of it though. So let's just take off to make it easy the two, what is that east, the two eastern squares, leave those empty. Just that. Yep.
  - >> MR. KENT STIGALL: Assign those.
- >> VICE CHAIR KELLOM: Yep, that is going to be in another District. Yep. Now we can go to where you were, where our boundary is going to be Inkster road here. Yes, South Gate, Wyandotte, wood Haven is going to be in there.
  - >> MR. KENT STIGALL: So we will do the whole.
  - >> VICE CHAIR KELLOM: Yeah, and that part I guess I can use this to cleanup 1.
  - >> MR. KENT STIGALL: This is Lincoln Park. Half of Lincoln Park.
  - >> VICE CHAIR KELLOM: So that little chunk I don't really want to be in there.

That's fine. That little chunk that is out you can put into two, assign.

- >> MR. KENT STIGALL: These precincts?
- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: And let's Zoom in to that Section.
- >> MR. KENT STIGALL: When you say that Section, right here?
- >> COMMISSIONER KELLOM: Yes I'm looking for 94, Fisher freeway is what is going to be named. Not that far. Not that close. I still need to be able to see one.
  - >> MR. KENT STIGALL: This is 85 right up here.
  - >> VICE CHAIR KELLOM: I think 94 is east.
  - >> MARCUS MULDOON: West.
  - >> VICE CHAIR KELLOM: Thank you, west.
  - >> MR. KENT STIGALL: Dix highway?
  - >> MARCUS MULDOON: A little bit west.
  - >> VICE CHAIR KELLOM: I meant to say west.
  - >> COMMISSIONER SZETELA: I would say northwest.
  - >> VICE CHAIR KELLOM: Thank you, Commissioner Szetela.
  - >> COMMISSIONER SZETELA: Up higher.

- >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: Like warmer, colder. Wait, wait, wait.
- >> COMMISSIONER SZETELA: There it is right there.
- >> VICE CHAIR KELLOM: Thank you, thank you. Okay can you give me, can you Zoom in so I can See Street, please? It's right underneath Allen Park is what I need to see so go south a little or scroll down, however you want to think about it, yep. And there is a little cut out that I need to go into two that is in one. Needs to be assigned into one. But I need the street level so I'm looking for.
  - >> MR. KENT STIGALL: Here is Goddard Road. This is.
  - >> VICE CHAIR KELLOM: Pelham I think that is Pelham right there.
  - >> MR. KENT STIGALL: Pelham.
- >> VICE CHAIR KELLOM: Pelham to Wick Road needs to be assigned. Pelham, wick.
- >> MR. KENT STIGALL: Where is wick, is wick down in this neighborhood? That turns into Allen. Here is Wick Road right here.
  - >> VICE CHAIR KELLOM: Okay.
  - >> MR. KENT STIGALL: So this is the intersection of Pelham and wick right here.
  - >> VICE CHAIR KELLOM: Can you assign it to two?
  - >> MR. KENT STIGALL: A precinct like that?
  - >> COMMISSIONER KELLOM: Let me see. No, I need underneath. So unassign it.
  - >> MR. KENT STIGALL: I have not assigned.
- >> VICE CHAIR KELLOM: The area between wick and Goddard needs to be assigned to two.
- >> MR. KENT STIGALL: This is Goddard, and this is wick, and this is Pelham so all of those? Or pieces.
- >> VICE CHAIR KELLOM: That is fine for right now. It's pieces but I was trying to use 94 as the boundary or Fisher freeway as the boundary so I will know where to stop. So what is that three precincts right there? You could assign it to.
  - >> MR. KENT STIGALL: That is Ecorse river running through here.
  - >> VICE CHAIR KELLOM: Okay, that is fine for right now.
  - >> MR. KENT STIGALL: So assign that to two?
  - >> COMMISSIONER KELLOM: Two, uh-huh.
- >> MR. KENT STIGALL: And if we Zoom it on this Section, that is Nalon, Moore and that is Wick right there. That is a Township boundary.
- >> VICE CHAIR KELLOM: Okay I will fix that later. That is not quite right but it's a little better than what it was before. Wick.
- >> MR. KENT STIGALL: Well numbers wise, population wise District 1 you know, is right around.

- >> VICE CHAIR KELLOM: I see what needs to happen. The little rectangular piece assigned to two that follows the precinct link the southern piece can you assign it to two?
  - >> MR. KENT STIGALL: Like, let me clear that. But this.
  - >> VICE CHAIR KELLOM: Uh-huh.
  - >> MR. KENT STIGALL: And this one?
- >> COMMISSIONER KELLOM: Yes, yep. Okay, let's get out of those woods. Okay. And also Taylor, Southgate, Woodhaven, Trenton, Wyandotte, Grosse IIe, all should go into two.
  - >> MR. KENT STIGALL: Here?
  - >> VICE CHAIR KELLOM: You may need a different color because 16 is green.
- >> MR. KENT STIGALL: Yeah. I will be right back. It does not go as fast as -- and we will change the colors so we can see it. It's a subtle difference but it will be an obvious difference here in a minute.
  - >> MR. KENT STIGALL: So two population-wise is at a good number.
- >> VICE CHAIR KELLOM: Take along southern piece of two along telegraph road, what do I want to say the southwest corner. No, yeah, that little triangle right there.
  - >> MR. KENT STIGALL: The Flatrock area.
- >> VICE CHAIR KELLOM: No, on the other side, on the other side of it. Not that side the other side, move your cursor. No, no, no go back to where we just were. Okay I'm pointing, you cannot see me right there, that little area, can you unassign?
  - >> MR. KENT STIGALL: This area where my cursor is?
  - >> COMMISSIONER KELLOM: Yes but not that big. You see the word Flatrock.
  - >> MR. KENT STIGALL: Yes.
- >> VICE CHAIR KELLOM: The upper corner of that, right there, that needs to be unassigned, that little area, yep, that is right against telegraph road. That is going to go into the neighboring District.
  - >> MR. KENT STIGALL: The whole precinct or just the census bloc?
  - >> COMMISSIONER KELLOM: Just the census bloc I think it's going to be.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: I don't know what shape that would be, but go across and all the way across Telegraph and even that little Section right there, where the point of your mouse is. Not over there. Go up a little bit. Right there. That needs to be unassigned and then you can continue to come down using Telegraph as the border.
  - >> MR. KENT STIGALL: All of this?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: That is the precinct.
  - >> VICE CHAIR KELLOM: I'm sorry I'm like that is a precinct.
  - >> MR. KENT STIGALL: It's hard to see these things.
  - >> VICE CHAIR KELLOM: Yeah, I was not sure. My apologies.

- >> MR. KENT STIGALL: We are good. We got it now.
- >> VICE CHAIR KELLOM: Thank you. Thank you for not beating me up, Kent. Let's do the neighboring District, choose a block and I don't care what it is.
  - >> MR. KENT STIGALL: So this area in here?
- >> COMMISSIONER KELLOM: Yes and it should be untouched and really kind of what is left but I need to see what is the northern part of that because I have not drawn.
- >> MR. KENT STIGALL: We split a lot of districts use 3, 4, 5, 6. I don't know, I can't recall, we looked at so many plans.
- >> VICE CHAIR KELLOM: I want to box it off so go to the top of that. Yeah so we will stop at Joy Road, which I think is right underneath 13.
  - >> MR. KENT STIGALL: That's.
  - >> VICE CHAIR KELLOM: I think it's more north, that is van born.
  - >> MR. KENT STIGALL: Michigan Avenue Sherry hill road.
  - >> VICE CHAIR KELLOM: Maybe easier to have you go from the bottom up.
  - >> COMMISSIONER SZETELA: What are you looking for.
- >> VICE CHAIR KELLOM: Cap off at Joy Road and fill in everything south of that. But upon further inspection let's start from the bottom and go up. All of that can be assigned.
  - >> MR. KENT STIGALL: What number?
  - >> COMMISSIONER KELLOM: I don't know, friends. Help me out.
  - >> MR. KENT STIGALL: I mean, we can always come back and change it.
- >> VICE CHAIR KELLOM: I'm not going to get caught up on that detail right now. I'm not saying it's not important.
- >> MR. KENT STIGALL: We will do three because it's in sequence and I'm sure somebody will point it out if that one needs to be.
- >> VICE CHAIR KELLOM: We will be careful when we get around Westland because we need to be...Romulus, those, both those large squares I guess assign. Wait a minute.
  - >> MR. KENT STIGALL: You still have half a District to draw.
  - >> VICE CHAIR KELLOM: I'm aware. Antenna is going to be included in that.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: So where is...so.
  - >> MR. KENT STIGALL: Wayne Township?
  - >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: Three still needs approximately 60,000. Is Inkster going to be in it?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: Inkster, I'm unclear.
  - >> VICE CHAIR KELLOM: Because I was actually correct.
  - >> MR. KENT STIGALL: Put all of west land in three?

- >> COMMISSIONER KELLOM: I don't know if I want to do it like that. We will go around Inkster.
  - >> MR. KENT STIGALL: So these are precincts I'm highlighting.
  - >> VICE CHAIR KELLOM: Yes. And then Westland going around Garden City.
  - >> MR. KENT STIGALL: So all that into three?
  - >> COMMISSIONER KELLOM: Westland around Garden City.
  - >> MR. KENT STIGALL: All the way around so all of Westland?
  - >> COMMISSIONER KELLOM: I don't think so, no. Unassign what you just assigned.
  - >> MR. KENT STIGALL: You can see the numbers jumped way up.
  - >> VICE CHAIR KELLOM: Yep.
  - >> MR. KENT STIGALL: Right now three just needs 9,000.
  - >> VICE CHAIR KELLOM: Of course it does.
  - >> MR. KENT STIGALL: Zoom in right here?
- >> COMMISSIONER KELLOM: Yeah, What Street is that? It should be Colin road and right next to Ann-Arbor trail.
  - >> COMMISSIONER SZETELA: Heinz.
  - >> MR. KENT STIGALL: Heinz and the Township boundary is here at Joy Road.
  - >> VICE CHAIR KELLOM: So.
  - >> MR. KENT STIGALL: Joy Road is the Township boundary.
  - >> VICE CHAIR KELLOM: I wonder do I want that in there?
  - >> MR. KENT STIGALL: This precinct butts right up against.
  - >> VICE CHAIR KELLOM: I don't want that.
  - >> MR. KENT STIGALL: This precinct runs all the way around Garden City.
- >> VICE CHAIR KELLOM: Okay, can you Zoom if on that little edge of three, that eastern edge of three?
  - >> MR. KENT STIGALL: Sure. So this is the Township boundary right here.
  - >> VICE CHAIR KELLOM: That is Lanois Road.
  - >> MR. KENT STIGALL: That is Warren Road here.
  - >> VICE CHAIR KELLOM: Going north and south.
  - >> MR. KENT STIGALL: Going north and south is Lanois Road.
- >> VICE CHAIR KELLOM: It goes around to Cohn or should, that little curve, no, not that way. I'm still talking about the eastern edge. I'm looking at the edge to make sure, yeah, I'm going to leave that how it is for right now. I'm sorry go ahead, Kent, my apologies.
  - >> MR. KENT STIGALL: This is Lanois road.
  - >> VICE CHAIR KELLOM: Go south and keep along that eastern edge. Go south.
  - >> MR. KENT STIGALL: All Township boundary.
- >> VICE CHAIR KELLOM: I can't see because of the selection matrix. Okay can you Zoom in on that? I want to make sure...not right there. Go back to that little cut out area. I'm just looking at the boundaries for right now.

- >> MR. KENT STIGALL: This is Radcliffe, and this is Wildwood Section right here.
- >> VICE CHAIR KELLOM: Okay, great. Okay, keep going south.
- >> MR. KENT STIGALL: So this continues. It's a Township boundary so it's not a road boundary.
- >> VICE CHAIR KELLOM: So we are at Marquette. Go up a little. Go north along the boundary.
  - >> MR. KENT STIGALL: That is Roz.
- >> VICE CHAIR KELLOM: Right underneath, no, Marquette is right there. So at Cherry hill, the only part that should be in three is Marquette to Cherry hill and then there is a part that should be probably unassigned. So if that is Marquette at the top, right there, that is Marquette, go south slowly, please.
  - >> MR. KENT STIGALL: Okay Roslyn, Florence, Allen, Cherry hill is right here.
- >> VICE CHAIR KELLOM: Okay that little piece I don't want to be in three. That needs to be in another District. Scroll down, please.
  - >> MR. KENT STIGALL: Okay.

So what part? This piece right here?

- >> COMMISSIONER KELLOM: No, the part that is right to the number three.
- >> MR. KENT STIGALL: Okay.

That is Cherry hill right here.

- >> VICE CHAIR KELLOM: Yeah, so, okay, go west. I'm going to try to tell you to do this another way. Go west. That is Cherry Hill. Stay on Cherry Hill. No, wait, wait, wait. Don't go down Cherry Hill. I'm trying to locate it. So go back to that little cut out. Go east to the cut out, right there, go south, where is Avondale avenue.
- >> MR. KENT STIGALL: There is Palmer, that is Palmer. That is Avondale right here.
- >> VICE CHAIR KELLOM: So from Cherry Hill to Avon Dale I want you to unassign, but you have to stay in that little area where we just were. Yeah. So from Cherry Hill to Avon Dale I want you to unassign.
  - >> MR. KENT STIGALL: This piece.
- >> VICE CHAIR KELLOM: If the lower part is Cherry Hill yes, go ahead and unassign.
- >> MR. KENT STIGALL: Cherry Hill. So we got to put it back in there because I did whole precinct. That is Avon Dale so I'm going to step out a little bit. That is Cherry Hill where the cursor is. Township boundary. That is Avon Dale right there.
  - >> VICE CHAIR KELLOM: Okay and what is right below? Palmer?
  - >> MR. KENT STIGALL: Yes.
- >> VICE CHAIR KELLOM: Okay so everything to the right of the unassigned area needs to be unassigned, all those precincts.
  - >> MR. KENT STIGALL: We will do them one at a time.

- >> VICE CHAIR KELLOM: That boundary right there should be Henry rough road, that blue line to the right, right there, what is that?
  - >> MR. KENT STIGALL: Yes Henry rough road.
- >> VICE CHAIR KELLOM: Stay there I want to make sure that is right. We should have Taylor at the top, but I can't see because of all of the matrix.
  - >> MR. KENT STIGALL: Okay we are getting there. That is Inkster right there.
- >> VICE CHAIR KELLOM: That is why I was not assure if I wanted that to be assigned to three. Okay and then it meets up with Taylor, the District that purple District, yep. Okay.
  - >> MR. KENT STIGALL: Yes.
- >> VICE CHAIR KELLOM: All right, can you Zoom out a little and let me see the way that looks.
  - >> MR. KENT STIGALL: Want me to Zoom out more?
  - >> COMMISSIONER KELLOM: Yes, I want to be able to see all of number three.
  - >> MR. KENT STIGALL: Just a nice almost square.
  - >> VICE CHAIR KELLOM: Okay, that is fine. Okay, we can go to the next District.
  - >> MR. KENT STIGALL: Okay and where will that be?
- >> COMMISSIONER KELLOM: Next to Westland and fill that in Garden City, Inkster, Dearborn, Dearborn Heights.
  - >> MR. KENT STIGALL: We can do it with whole townships.
- >> VICE CHAIR KELLOM: We are not going to select, my brain just stopped, you see where it says far west and Detroit, we are not going to select that. It will be like a piece of that.
- >> MR. KENT STIGALL: Okay so let's put these precincts into four, all up here. And all of Dearborn Heights.
  - >> VICE CHAIR KELLOM: In Dearborn.
- >> MR. KENT STIGALL: In Dearborn. So that's where we take some from two. So let me clear that selection. I'm sorry. That was just a little piece of it. Now we have Dearborn.
- >> VICE CHAIR KELLOM: Select the pieces under far West Detroit and select Warren Dale after you get that little bottom piece next to two together.
  - >> MR. KENT STIGALL: Warren Dale, Warren avenue.
- >> VICE CHAIR KELLOM: Uh-huh. Not all of Warren Dale, I don't think we will be able to take all of that.
- >> MR. KENT STIGALL: Four needs 20 some thousand people. Far West Detroit. Warren avenue.
  - >> VICE CHAIR KELLOM: Hazelman to far West Detroit, that little area so I can see.
  - >> MR. KENT STIGALL: This is Warren Street.
  - >> VICE CHAIR KELLOM: What is the street west of that, west of far west?
  - >> MR. KENT STIGALL: That is, this is Parkway right here and Hazelton here.

- >> VICE CHAIR KELLOM: So that part Hazelton is the boundary. So that little piece, those blocks are going to have to be unassigned. Everything, stopping at Hazelton. So if Hazelton is right here I want you to unassign the blocks that are going into far west.
- >> MR. KENT STIGALL: Okay because far west is going into another District is that what you are saying?
- >> COMMISSIONER KELLOM: Correct use Hazelton as the western boundary. And unassign those blocks that are right against Hazelton Street. And don't Zoom out and unassign those and we are going to go slowly east. No, no, no don't go south. Just scroll over. I need to, okay?

Now scroll up. I need to be able to see Joy Road. No, no, no. Scroll down a little bit. That is the sweet spot. So Zoom out just a little bit, Kent. Thank you. Far west, that area, okay, so that block, that precinct, those two presents across, that can be selected but we are going to stop at garden view.

- >> MR. KENT STIGALL: These are at precincts.
- >> VICE CHAIR KELLOM: No, not all of that.
- >> MR. KENT STIGALL: I got you.
- >> VICE CHAIR KELLOM: I'm not talking to you. I'm talking to the computer.
- >> MR. KENT STIGALL: So I'm just going to move it up a little bit. This part of Warren Dale.
  - >> VICE CHAIR KELLOM: Yes.
  - >> MR. KENT STIGALL: Put that in four.
- >> VICE CHAIR KELLOM: Stop at that little chunk should stop at Stalk Street close to far west. Zoom in right there where your cursor is.
  - >> MR. KENT STIGALL: That Street name I can't read it but.
  - >> VICE CHAIR KELLOM: I definitely can't read it. That just like made it.
  - >> MR. KENT STIGALL: Pierson. Something like Pierson.
  - >> VICE CHAIR KELLOM: Pierson goes into another District.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: So Pierson, Braile, Fielding, Stout, stop at Stout Street, that goes north, yes. No, don't select that, unassign that. From Stout over gets assigned to four.
  - >> MR. KENT STIGALL: Stout to the right gets assigned to four, correct?
- >> COMMISSIONER KELLOM: Yes. Can you see what the north, that Little Street is before you continue?
  - >> MR. KENT STIGALL: Yes.
  - >> VICE CHAIR KELLOM: Is that Tireman?
  - >> MR. KENT STIGALL: This is Tireman, yes.
- >> VICE CHAIR KELLOM: Don't go above. Then that Other Street is Evergreen. So you're going to select everything to the right and then you're going to go up but not going past Evergreen.

- >> MR. KENT STIGALL: Here is Evergreen coming down.
- >> VICE CHAIR KELLOM: That little piece we have that says rouge is fine but go up and select things against Evergreen.
  - >> MR. KENT STIGALL: What about Warren Dale?
- >> COMMISSIONER KELLOM: Yes, that gets selected. I guess put it into four. And Southfield road, stop at Southfield road over there. All of that up until Joy Road goes into four. Joy is at the top.
- >> MR. KENT STIGALL: I'm doing precincts so it's doing a little bit more. Here is Tireman.
- >> VICE CHAIR KELLOM: Keep going. The northern, the northern boundary is Joy Road for that Section.
  - >> MR. KENT STIGALL: That is Joy Road right up in here.
- >> VICE CHAIR KELLOM: But you can't go past Evergreen. Yep. Great. Yep, that is correct.
  - >> MR. KENT STIGALL: Let me cut some off of here.
  - >> VICE CHAIR KELLOM: No, that is fine, leave it how it is.
  - >> MR. KENT STIGALL: That is Evergreen right here.
- >> VICE CHAIR KELLOM: Yes, I know. The western boundary should look just like that. Okay, yep, yep, yep. Everything else should be good. Tireman. Goes up. Okay, can we fill that precinct right there Warren avenue and above that gets into four. Nope. Not that. I don't know what that was that you just...yep, that piece right there. No, not that, unassign that.
  - >> MR. KENT STIGALL: I have not assigned it yet. Just highlighting it.
  - >> VICE CHAIR KELLOM: That gets assigned into four.
  - >> MR. KENT STIGALL: Okay are these blocks going into four?
  - >> COMMISSIONER KELLOM: No.
  - >> MR. KENT STIGALL: Okay should that one little block be in four?
  - >> COMMISSIONER KELLOM: No.
  - >> MR. KENT STIGALL: So that should be unassigned.
- >> VICE CHAIR KELLOM: I'm sorry, yes, it should be. I'm sorry. That should be exactly how it is.
  - >> MR. KENT STIGALL: Okay, you're going to leave it just like that, okay.
- >> VICE CHAIR KELLOM: Fishkorn. Can you Zoom out, please? Four and eight are really close.
- >> MR. KENT STIGALL: Yeah, I can change those. That is going to be somebody else's problem.
  - >> VICE CHAIR KELLOM: How far were the areas to Janey? Does four need more?
- >> MR. KENT STIGALL: Four needs approximately 16,000, 12, 14,000 gets it within, you know, percent.

- >> VICE CHAIR KELLOM: That little part should be assigned right above Garden City, to the left, no, no, going west.
  - >> MR. KENT STIGALL: This piece here.
  - >> VICE CHAIR KELLOM: That should be Joy Road so that should be assigned.
- >> MR. KENT STIGALL: I think that is all of that is a large number of people. But let's look at it. We will just select it by precinct. And.
- >> VICE CHAIR KELLOM: Okay Kent just going to do the selection of this area. And that area is -- actually no, you are right.
  - >> VICE CHAIR KELLOM: Shouldn't be selected.
- >> MR. KENT STIGALL: We will assign it in four. When we put it in three it was way too many is what I was thinking. So your four is .32%. Three is at .06%. Two is at .08%. One is at .84%. So very close, 1234.
- >> VICE CHAIR KELLOM: Okay let's draw the District on top of four. Can you Zoom out, please? Okay, so the boundary for, what are we going to name this, five?
  - >> MR. KENT STIGALL: Sound good.
  - >> VICE CHAIR KELLOM: Western boundary for five is going to be Haggerty Road.
  - >> MR. KENT STIGALL: So, okay, Livonia is that all in one -- gosh.
- >> VICE CHAIR KELLOM: Yeah and we are not crossing 8 Mile, yes, all of Livonia is selected.
- >> MR. KENT STIGALL: So all Livonia we will put into five. So Farmington and Farmington Hills, is that part of five?
- >> COMMISSIONER KELLOM: Let me go slow to go fast. So for right now, no. I'm going to say no because we are not crossing 8 Mile.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: And that piece up until 7-Mile, 7-Mile is the western boundary for that, and 6 mile is, I'm sorry, yeah, no, 7-Mile is the eastern boundary even though it runs east and west. That little piece you can select. Where is 7-Mile? Reference right here.
  - >> MR. KENT STIGALL: That is 5 mile.
  - >> VICE CHAIR KELLOM: So go up.
- >> MR. KENT STIGALL: 6, 7-Mile, that is 6 mile right there. So there is 7-Mile where my cursor is.
- >> VICE CHAIR KELLOM: Where is five points probably against the neighbors five points that should be that right there. Can you scroll? Is that five points?
  - >> MR. KENT STIGALL: Yes.
- >> VICE CHAIR KELLOM: Okay great everything to the left of that goes into District
- 5. That should be included. And again not crossing 8 Mile. And Zoom out, please.
  - >> MR. KENT STIGALL: So.
  - >> VICE CHAIR KELLOM: Assigning the area.
  - >> MR. KENT STIGALL: Are we going all the way to 8 Mile?

- >> VICE CHAIR KELLOM: Yes, but do not cross, yes.
- >> MR. KENT STIGALL: Yep.
- >> COMMISSIONER KELLOM: The stopping point is 6 mile or McNichols.
- >> MR. KENT STIGALL: 6 mile right here.
- >> VICE CHAIR KELLOM: Yep.
- >> MR. KENT STIGALL: Half a precinct I guess.
- >> VICE CHAIR KELLOM: So I mean you're going to select that area below but I'm trying to chunk out, yeah. That's fine. When you Zoom in I get a little lost. But you can assign that area.
  - >> MR. KENT STIGALL: So this is 6 mile right there.
  - >> VICE CHAIR KELLOM: That is fine. Just keep going south.
- >> MR. KENT STIGALL: Zoom out a little bit so I can keep up with it as soon as the computer catches up.
  - >> VICE CHAIR KELLOM: This District is stacked right on top of four.
  - >> MR. KENT STIGALL: It will hit south all the way.
- >> VICE CHAIR KELLOM: Correct, but I want to make sure that right half that we just used, 6 mile is the stopping point. So like south of 6 Miller Grove, Riverdale, all of that goes into five.
  - >> MR. KENT STIGALL: So this is 6 mile right here.
  - >> VICE CHAIR KELLOM: South of six neighborhood goes into five.
- >> MR. KENT STIGALL: So I'm going to select them and if something doesn't look like and just doing it by precinct and, you know, when it does what it's supposed to do. Commissioner Szetela says it's time for lunch. This is why she wants a timeframe. She wants it to be quick.
- >> CHAIR EID: It is 12:30 Commissioners. And we do have a scheduled lunch from 12:30.
- >> COMMISSIONER SZETELA: It's more about giving the interpreters a break that they are supposed to have.
  - >> CHAIR EID: I think we all need a break.
  - >> VICE CHAIR KELLOM: Just a sense of humor, a little levity.
  - >> I did message the Chair to ask when we were taking lunch as everyone else.
  - >> VICE CHAIR KELLOM: Thank you Bethany.
- >> CHAIR EID: We appreciate the language translation and the sign language services. It's not an easy job. With that said, it is 12:30. We will hit the pause button for now and come back. All those in favor, well, actually we need a motion. Is there a motion to recess until 1:30?
  - >> COMMISSIONER LETT: So moved.
  - >> COMMISSIONER WEISS:

- >> CHAIR EID: A motion and a second to recess until 1:30, is there discussion? Seeing none we will vote, all those in favor of the motion please raise your hand and say aye.
  - >> Aye.
- >> CHAIR EID: Any opposed? The ayes have it. We will recess until 1:30. See you all then. Get some lunch everyone.

- >> CHAIR EID: Welcome back everyone. Can you guys hear me okay?
- >> YVONNE YOUNG: Yes.
- >> COMMISSIONER VALLETTE: I can hear you.
- >> CHAIR EID: Wonderful. Well, as Chair of the Commission I will now call this meeting back to order at 1:31 p.m. Can we take another roll call, please?
- >> YVONNE YOUNG: Yes, sir. Good afternoon Commissioners. Please say present when I call your name. Because this is the same continuation of this morning's meeting, if your location has changed please share that, if it has not changed then we will not need that information. Will we just forward that from this morning's meeting. Please say present when I call your name going in alphabetical order, Commissioner Andrade?
  - >> ELAINE ANDRADE: Present.
- >> YVONNE YOUNG: Commissioner Callaghan? Commissioner Curry? Commissioner Eid?
  - >> CHAIR EID: Present.
  - >> YVONNE YOUNG: Commissioner Kellom?
  - >> COMMISSIONER KELLOM: Present.
  - >> YVONNE YOUNG: Commissioner Lange?
  - >> COMMISSIONER LANGE: Present.
  - >> YVONNE YOUNG: Commissioner Lett?
  - >> COMMISSIONER LETT: Present.
  - >> YVONNE YOUNG: Commissioner Muldoon?
  - >> MARCUS MULDOON: Present.
  - >> YVONNE YOUNG: Commissioner Orton?
  - >> CHAIR ORTON: Present.
  - >> YVONNE YOUNG: Commissioner Szetela? Commissioner Vallette?
  - >> COMMISSIONER VALLETTE: Present.
  - >> YVONNE YOUNG: Commissioner Wagner?
  - >> COMMISSIONER WAGNER: Present.
  - >> YVONNE YOUNG: Commissioner Weiss?
  - >> COMMISSIONER WEISS: Present.
- >> YVONNE YOUNG: We can go back to Commissioner Szetela. Mr. Chair you have ten Commissioners present. You do have a quorum.

- >> CHAIR EID: Thank you Ms. Young.
- >> YVONNE YOUNG: You're welcome sir.
- >> CHAIR EID: We will resume mapping. Is Mr. Stigall with us?
- >> MR. KENT STIGALL: Yes, I'm right here. Can everybody see my screen at this point?
  - >> CHAIR EID: Yeah, we can see it.
  - >> MR. KENT STIGALL: Okay.
- Is Brittini, Commissioner is Brittini coming back on?
- >> COMMISSIONER KELLOM: I'm here, I'm going to work a little bit on this one and probably pause to make sure everyone has a turn. Yes.
  - >> MR. KENT STIGALL: We were.
  - >> VICE CHAIR KELLOM: At five. Yes.
- >> MR. KENT STIGALL: And I guess we were going to continue with this south, this area I have here.
  - >> VICE CHAIR KELLOM: Yes.
  - >> MR. KENT STIGALL: Like all the way down to four, is that the idea?
- >> COMMISSIONER KELLOM: Correct. Can you put the neighborhood names back on, please, when you get a chance?
  - >> MR. KENT STIGALL: Yes. All right.
- >> YVONNE YOUNG: Mr. Chair for the record I would like to acknowledge Commissioner Szetela.
  - >> COMMISSIONER SZETELA: Thank you, Ms. Young.
  - >> YVONNE YOUNG: You're welcome.
- >> MR. KENT STIGALL: We are down here at far West Detroit. West Outer Drive, Rouge park.
  - >> VICE CHAIR KELLOM: Pardon me?
  - >> MR. KENT STIGALL: Does that go to five or a new District?
- >> COMMISSIONER KELLOM: Where are you saying the lower half, yes, that goes to five.
- >> MR. KENT STIGALL: Okay, got to get this done. And all of Rouge park, west Outer Drive?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: Next Franklin park?
  - >> COMMISSIONER KELLOM: Yes. You are in the lower half.
  - >> MR. KENT STIGALL: Just kind of going along four. Five coming down in here?
- >> COMMISSIONER KELLOM: We will have to go back up but that is fine for you to put that in there now.
  - >> MR. KENT STIGALL: So that all goes to.
  - >> VICE CHAIR KELLOM: Five.
  - >> MR. KENT STIGALL: Yep. All of Joy?

- >> COMMISSIONER KELLOM: Yes.
- >> MR. KENT STIGALL: And we care. Okay.
- >> VICE CHAIR KELLOM: And that Plymouth, Hubble, pride area.
- >> MR. KENT STIGALL: Okay, so pretty much all the way across here.
- >> VICE CHAIR KELLOM: Yes using eight as the boundary and also extends north so Plymouth, I96, Southfield, Plymouth, yep, yes. Yes.
  - >> MR. KENT STIGALL: That part?
  - >> COMMISSIONER KELLOM: Correct.
  - >> Besides eight?
  - >> COMMISSIONER KELLOM: Yes, west McNichols road.
  - >> MR. KENT STIGALL: Something like that?
- >> COMMISSIONER KELLOM: Yes. That top line of Hubble Puritan and harmony should be 6 mile or west McNichols just to be clear. Yes, it is.
  - >> MR. KENT STIGALL: That is the northern border, is that what you're saying?
- >> COMMISSIONER KELLOM: Correct. So let's be careful. Don't cross that 6-mile border. And then we will have to do some adjusting. So go ahead.
  - >> MR. KENT STIGALL: Castle Rouge, Brightmoor, all of this?
- >> COMMISSIONER KELLOM: Correct, but don't go past...so where is Miller Grove, that little part, yes. So south of six, Riverdale that gets put into five as well. Evergreen, Outer Drive that is assigned, that should not be assigned to five.
  - >> MR. KENT STIGALL: Okay.

So what District? What District is this going to be? I'm just going to go ahead I guess.

- >> VICE CHAIR KELLOM: It gets assigned to another District, but....
- >> MR. KENT STIGALL: So six is the only District left?
- >> COMMISSIONER KELLOM: Uh-huh.
- >> MR. KENT STIGALL: What about the I?
- >> COMMISSIONER KELLOM: That is untouched. All of that part is fine. I want to make sure I didn't just lie to you.
  - >> MR. KENT STIGALL: I guess 7 is going to get an ugly edit.
  - >> VICE CHAIR KELLOM: Probably but not during my turn. I'm just trying to....
  - >> MR. KENT STIGALL: Let me Zoom out.
- >> VICE CHAIR KELLOM: The part assigned to Evergreen and Outer Drive that is ugly to look at. Can you unassign that area?
  - >> MR. KENT STIGALL: Yes.
- >> VICE CHAIR KELLOM: Thank you. And then don't move, but after you unassign it stay right there. That piece of, okay, after you unassign that unassign McNichols Evergreen area. That gets put into another District.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: That triangle, yep, and the top half of North Rosedale Park.

- >> MR. KENT STIGALL: This part up here.
- >> VICE CHAIR KELLOM: Going west to east, that gets unassigned.
- >> MR. KENT STIGALL: Is that unassigned?
- >> COMMISSIONER KELLOM: Yes, yes. And, yup, unassign and unassign, yep.
- >> MR. KENT STIGALL: That is all unassigned.
- >> VICE CHAIR KELLOM: Zoom out a bit. I want to see what is left and 7 gets edited. Can you Zoom out some more? Or go west, I'm sorry go east, I want to see eight.
- >> MR. KENT STIGALL: Right now Farmington, forming ton hills unassigned and a piece in here.
- >> VICE CHAIR KELLOM: Uh-huh, that piece is unassigned to the left of 7 you can unassign that to 7 for right now.
  - >> MR. KENT STIGALL: Okay all of this?
  - >> COMMISSIONER KELLOM: Yes.
  - >> MR. KENT STIGALL: 57,000.
- >> VICE CHAIR KELLOM: That piece and the bottom part of 7 you can unassign that is in between 5, 7, 8 that unassigned area goes to 7. That little empty spot Evergreen, Outer Drive, all of that goes into 7. Excuse me. I don't love I'm splitting North Rosedale, but for right now I'm going to leave that how it is. Let's go to that unassigned area in 8 goes into another District. But can you Zoom out? Because I want to give time to someone else. Well, that might be. Let me see.
- >> MR. KENT STIGALL: You have District 6 and basically 50%, well 30% of 7 needs to change.
- >> VICE CHAIR KELLOM: Yeah. 7 and 9 will have to change some more. But I'm going to stop to give somebody else a turn.
  - >> MR. KENT STIGALL: Okay.
  - >> VICE CHAIR KELLOM: That is it for right now.
- >> CHAIR EID: Can we just change the names of some of these, Kent, real quick? The numbers I mean? Is that quick for you to do?
  - >> MR. KENT STIGALL: Yeah. We just so what do you want to change?
  - >> CHAIR EID: Make District 5, make that District 6.
  - >> MR. KENT STIGALL: Okay, yeah.
  - >> CHAIR EID: Excuse me, pal. The cat says hi, everyone.
  - >> MR. KENT STIGALL: Okay, next one?
  - >> CHAIR EID: Can you go lower?
  - >> MR. KENT STIGALL: Okay.
  - >> CHAIR EID: Turn four into two.
  - >> MR. KENT STIGALL: We have to kind of do five.
  - >> COMMISSIONER SZETELA: Three should be five.
  - >> CHAIR EID: Three should be five, four should be two and then two should be four.

- >> MR. KENT STIGALL: Three should be five. What should be number three, two? Or four? Aye Eid two should be, they need to be swapped, two and four.
  - >> MR. KENT STIGALL: Okay, so where does three belong?
  - >> CHAIR EID: Three is not drawn yet.
- >> MR. KENT STIGALL: Okay so it's two and four need to be, okay, we will do two to three. I have to kind of get there.
- >> VICE CHAIR KELLOM: You can take the neighborhood overlay if that will help you be seeing things a little bit more clearly.
  - >> MR. KENT STIGALL: And in four goes to two. And now what we can do.
  - >> CHAIR EID: Three goes to four, yep.
- >> MR. KENT STIGALL: Three goes to four, yep. And I will turn off the neighborhood layers so you can see where we are at overall. This is just dis-contiguous because of the water blocks.
  - >> CHAIR EID: That did it and that is good.
- >> VICE CHAIR KELLOM: I will pause and basically there are three more districts, the suburban districts I need to adjust. But like I said, I'm going to stop so someone else could have a turn because, because.
  - >> CHAIR EID: Okay thank you Commissioner Kellom.
- >> YVONNE YOUNG: I would like to acknowledge Commissioner Curry is with us. Thank you, Commissioner Curry. May you say present? If she can.
  - >> COMMISSIONER CURRY: Yeah, present.
  - >> YVONNE YOUNG: Thank you.
- >> CHAIR EID: Wonderful. Welcome back Commissioner Curry and thank you Ms. Young. Okay, next up on the list is Commissioner Lange.
- >> COMMISSIONER LANGE: Yeah, I don't need to map today. I created two maps yesterday. And I will present those next week. So I don't think it's necessary to do it today, thank you.
  - >> CHAIR EID: Okay, look forward to seeing those. Next up is Commissioner.
  - >> COMMISSIONER LETT: Lett Mr. Chairman, I take a pass today.
  - >> CHAIR EID: Okay, Commissioner Muldoon?
- >> MARCUS MULDOON: I guess we will keep working on this one. The one Brittini was working on. Brittini, if you don't mind helping.
  - >> CHAIR EID: All right.
- >> MARCUS MULDOON: I don't want to screw up what you started but I figured keep making the districts and the population right, you know.
- >> VICE CHAIR KELLOM: And I'm trying not to talk at the same time. Basically it's the three sur bush ban so Warren and Centerline and Troy and Royal Oak and Utica.
- >> MARCUS MULDOON: Start at the north to get population where it's supposed to be. Get all the districts in.

- >> VICE CHAIR KELLOM: I might have to transfer my Zoom because my laptop, this laptop is dying. But so if I exit, I'm coming back. What I would say though Commissioner Muldoon is to leave the little etched cut outs in 8, leave those alone. I mean so to speak, we don't need them yet, okay.
- >> MARCUS MULDOON: We will start at the north here and start building population to close all that off. So I will start up in Macomb.
  - >> MR. KENT STIGALL: Yeah, Macomb.
  - >> MARCUS MULDOON: Yes.
  - >> MR. KENT STIGALL: This would be District 3 I guess.
  - >> MARCUS MULDOON:
  - >> CHAIR EID: I think it will be 11, Mr. Stigall.
  - >> MR. KENT STIGALL: Yes, 11, that is what it is.
  - >> CHAIR EID: Are y'all changing nine in this configuration?
- >> COMMISSIONER KELLOM: It would have to, 7, 9, 24 will have to be adjusted and maybe pulling some out of 12, I'm not sure.
  - >> CHAIR EID: Just wondering. Thanks.
- >> MR. KENT STIGALL: I changed the colors here so we can see 11. So do we want to continue.
  - >> MARCUS MULDOON: Continue south with Sterling Heights.
  - >> MR. KENT STIGALL: Okay.
  - >> MARCUS MULDOON: Yep.
  - >> MR. KENT STIGALL: I guess all of this area in...
  - >> MARCUS MULDOON: Yes. Yep, on the west side there.
- >> MR. KENT STIGALL: If you see something I shouldn't be doing, you know, just say no.
  - >> MARCUS MULDOON: Go ahead, Brittini.
  - >> MR. KENT STIGALL: Do we want to come all the way down through Roseville?
  - >> MARCUS MULDOON: At Warren.
  - >> MR. KENT STIGALL: 11 is over.
  - >> VICE CHAIR KELLOM: 11 is over.
  - >> MARCUS MULDOON: Yes.
- >> VICE CHAIR KELLOM: How would...with 11 and Hayes is the boundary, that is where I was thinking for 11, the eastern boundary. And then even it out between 11 and 12. So some of 11juts out into 12 so I would clinically.
  - >> MARCUS MULDOON: If you Zoom in, it would be that little, yeah, and 12.
  - >> VICE CHAIR KELLOM: I don't know if we should go that far into Roseville.
  - >> MR. KENT STIGALL: 12 is still 1.5% low. Okay, so.
- >> MARCUS MULDOON: Go north of that, of where you just assigned, if you Zoom in, I will say to the right of that a little bit. I don't know if it will be all of that.
  - >> MR. KENT STIGALL: And that goes where, 12?

- >> MARCUS MULDOON: It would have to go to 12. Is that what you are talking about Brittini?
- >> COMMISSIONER KELLOM: The whole eastern side I would use Hayes as a boundary and the north-boundary Hall Road and curve around Utica and come around. Does that make sense?
  - >> MARCUS MULDOON: I can't see the roads and I'm not real familiar with the area.
  - >> VICE CHAIR KELLOM: I'm the same familiar.
  - >> MR. KENT STIGALL: Was that three, Gratiot?
  - >> MARCUS MULDOON: Gratiot.
  - >> VICE CHAIR KELLOM: Yes. So Hayes road, Kent, runs north and south.
  - >> MR. KENT STIGALL: That is Beacon and Paris.
- >> VICE CHAIR KELLOM: Go to the top and try to find it on the top of 11 and work our way down. I don't know though.
  - >> MR. KENT STIGALL: That is Canadian. That is a railroad there.
  - >> VICE CHAIR KELLOM: Go north on 11.
  - >> MR. KENT STIGALL: That is hall road right here.
- >> VICE CHAIR KELLOM: I would stop at hall. I would not select above hall road. And then I will come down, if that is hall going east and west then Hayes, I can't -- that is not zoomed in enough.
  - >> MR. KENT STIGALL: All right, Hayes is north-south?
  - >> COMMISSIONER KELLOM: Yep.
  - >> MR. KENT STIGALL: That is Romeo plank road.
  - >> VICE CHAIR KELLOM: I can see the east.
  - >> MR. KENT STIGALL: That is Pane, right?
  - >> COMMISSIONER KELLOM: Nope.
  - >> MR. KENT STIGALL: This little road here.
  - >> VICE CHAIR KELLOM: Is that Hayes?
  - >> MR. KENT STIGALL: This is 97. This is Rose.
  - >> MARCUS MULDOON: Hayes is, just had Romeo. It's just west of Romeo plank.
- >> MR. KENT STIGALL: Okay so it's west. It's over here somewhere. That is Romeo plank right there.
- >> MARCUS MULDOON: Yeah, so it runs, it's the Next Street west it looks like. It's one more block west is Hayes. One more, yep, go one more block. Next road should be Hayes.
  - >> VICE CHAIR KELLOM: I'm sorry.
  - >> MR. KENT STIGALL: It's that corner right there.
- >> VICE CHAIR KELLOM: Just that sliver of Sterling Heights should be the top of 11. Then you have more to play with 12 and 24. It does not become there so I would unassign everything to the right of Hayes. And distribute it between 12 and 4. Does that make sense? 12 and 24, excuse me.

- >> MR. KENT STIGALL: That is just a lot of population.
- >> COMMISSIONER CURRY: Can I ask a question?
- >> COMMISSIONER KELLOM: Figure this out later.
- >> CHAIR EID: Go ahead Commissioner Curry?
- >> COMMISSIONER CURRY: All I see is lines. Do you all have words on your map?
- >> COMMISSIONER KELLOM: No.
- >> COMMISSIONER CURRY: Okay so no letters? No nothing?
- >> COMMISSIONER KELLOM: I can see Sterling Heights Clinton Township, mount Clemens but no overlays Commissioner Curry.
  - >> COMMISSIONER CURRY: I have nothing on mine that I can see.
- >> VICE CHAIR KELLOM: It's not very clear unless you zoomed all the way in. Like he zoomed in can you see mount Clemens now like a green area?
  - >> COMMISSIONER CURRY: Yeah, vaguely I see that now.
  - >> VICE CHAIR KELLOM: Yeah.
- >> MR. KENT STIGALL: So this area I have highlighted on top of 11 is roughly 74,000 people.
  - >> VICE CHAIR KELLOM: Okay.
  - >> MARCUS MULDOON: Split it between 24 and 12?
  - >> COMMISSIONER KELLOM: For right now. I mean.
- >> MARCUS MULDOON: I was more looking at the population, trying to and it. I mean I don't know the area that well.
- >> CHAIR EID: I would say, you know, get the general configuration of the District, right? And then just make the edits after they are already on paper. It will be a lot easier to do after you know.
- >> MARCUS MULDOON: You can move people from one side to the other or move one District.
- >> CHAIR EID: Exactly. If I were you I would keep going south. Approximately the type of District that you want and then figure the rest out, you know, later.
  - >> MARCUS MULDOON: Right.
  - >> VICE CHAIR KELLOM: Okay.
- >> MARCUS MULDOON: We are 15,000 over. But if we are going to be trying to move into 12 we -- can you unselect that for a second, see where we can split it if we can move to 12 and I see where you are thinking where 12 is not so long. So if you were to move that to 12, then you could take population from the bottom and move.
- >> VICE CHAIR KELLOM: 7 and 9 are going to change that is why I'm not really worried. I was trying to assist in getting 11 in a better configuration. And then that will help you with the Troy, Royal Oak, Utica area. We will worry about the population later. But that is the way that I draw. So I don't want to...
  - >> MARCUS MULDOON: Done more than I have.
  - >> VICE CHAIR KELLOM: What is that?

- >> MARCUS MULDOON: Done more than I have. I look at the population the easiest for me and adjust the population. You know the areas better or know the cities of interest better so if something had to be adjusted one way or the other.
  - >> COMMISSIONER KELLOM: Warren, Centerline.
- >> MARCUS MULDOON: Took Warren out at population. It probably would be low then.
- >> VICE CHAIR KELLOM: I don't know. I'm not saying take it out. In my notes I don't have Fraser in there so that is why I was trying to.
  - >> MARCUS MULDOON: That is 33.
  - >> VICE CHAIR KELLOM: And Royal Oak is not in that District at all.
  - >> MARCUS MULDOON: Right.
- >> VICE CHAIR KELLOM: That little area to work in so if you start going over now, I mean.
- >> MARCUS MULDOON: Well, if we went and made Royal Oak and started the other District over and ran them to each other and see where they need to be.
- >> VICE CHAIR KELLOM: It's totally up to you. I would have finished with 7 and then came around to 11.
  - >> MARCUS MULDOON: 7 population is still low.
  - >> MR. KENT STIGALL: 7 has additional 85,000 people.
  - >> MARCUS MULDOON: Has too many.
  - >> MR. KENT STIGALL: Yes, a third of the District roughly.
- >> VICE CHAIR KELLOM: It shouldn't be that many, the northern part of 7 which will go into 9.
- >> MR. KENT STIGALL: So say you unassigned Warren and left 11 like that and come back and start dealing with 7 and kind of make them come together.
  - >> MARCUS MULDOON: Yeah.
- >> MR. KENT STIGALL: Because 12, you know, we are not allowed to get anybody out of Cannon, so we are stuck there.
  - >> VICE CHAIR KELLOM: So go back to 7 then.
  - >> MR. KENT STIGALL: And kind of do it and make that work.
- >> VICE CHAIR KELLOM: Sorry, make the northern border of 7, 14 Mile Road. Because I'm still trying to keep communities of interest together for what I know about these.
  - >> MARCUS MULDOON: Right.
- >> VICE CHAIR KELLOM: So for me that 11, when you start to chunk out Warren and I don't want to touch, I will go back because we are splitting things. People should not be apart.
  - >> MARCUS MULDOON: Sure.

- >> VICE CHAIR KELLOM: So seven then the northern border, you will have to Zoom in to find 14, which is right at that blue line right where the 7 splits the number 7 l bet you that is 14 Mile Road.
  - >> MR. KENT STIGALL: That is 14 Mile Road.
- >> VICE CHAIR KELLOM: Okay, so I would -- everything above that will be in another District. I will unassign that area above seven.
  - >> MR. KENT STIGALL: Well, so what if we took, hum.
  - >> MARCUS MULDOON: If we took everything.
  - >> MR. KENT STIGALL: Farmington and Southfield and all down through here.
  - >> MARCUS MULDOON: Make that a new District or three?
  - >> MR. KENT STIGALL: Yeah.
  - >> MARCUS MULDOON: Yeah.
  - >> VICE CHAIR KELLOM: What are you saying?
- >> MARCUS MULDOON: Take 14 south of 7 and make a new District whereas you look at splitting the District up.
  - >> VICE CHAIR KELLOM: Yeah.
  - >> MARCUS MULDOON: That makes sense.
- >> MR. KENT STIGALL: Tying Southfield into Royal Oak kind of like this? The new District would be working this way.
  - >> MARCUS MULDOON: That way.
- >> VICE CHAIR KELLOM: The little part so you can see what I'm talking about. That little corner, no. Well, okay.
  - >> MR. KENT STIGALL: I was trying to get an idea like if you took something like.
  - >> VICE CHAIR KELLOM: Right along that diagonal which is Woodward avenue.
  - >> MR. KENT STIGALL: And this down south next to six.
  - >> VICE CHAIR KELLOM: Yes, that is supposed to be in a District together.
  - >> MR. KENT STIGALL: And kind of give it a District number.
  - >> MARCUS MULDOON: Right.
- >> MR. KENT STIGALL: That would take, well it's actually taking too many away from seven.
  - >> MARCUS MULDOON: But seven is going to go over. Yep.
- >> MR. KENT STIGALL: So if we Zoom in something like this and said that is District whatever number y'all want to use should it be ten or I don't know? Or three.
  - >> MARCUS MULDOON: Sounds good.
- >> MR. KENT STIGALL: Let's just call it three. Just to get started is all I'm saying. You know that will be it. Assign that and then just start working, I mean I guess this almost has to be included.
  - >> VICE CHAIR KELLOM: It is, yep.
  - >> MARCUS MULDOON: Yeah.
  - >> VICE CHAIR KELLOM: And it goes all the way up until 14 Mile Road.

- >> MR. KENT STIGALL: I'm kind of getting the pieces we know we have to get because we cannot isolate them.
  - >> MARCUS MULDOON: Two little spots down by six.
- >> MR. KENT STIGALL: So seven now is under populated, yeah, I got to go down here and get these guys.
  - >> MARCUS MULDOON: Then go.
  - >> MR. KENT STIGALL: So seven is under populated.
  - >> MARCUS MULDOON: Right.
  - >> MR. KENT STIGALL: I don't mean to go in and out like that.
  - >> MARCUS MULDOON: Carry three up to 14 Mile Road. Take it from seven.
  - >> VICE CHAIR KELLOM: Yes.
- >> MARCUS MULDOON: From 14 mile south, yep, so Beverly Hills would go into three.
- >> COMMISSIONER KELLOM: Uh-huh. Sorry, it was an echo. And that little part, you see that blue line is right at the right corner of that square? So right underneath Berkeley, take, not that piece but where Berkeley is, that should be taken in to three. And following that blue boundary.
  - >> MR. KENT STIGALL: Down this way?
  - >> COMMISSIONER KELLOM: Yes, going south.
  - >> MR. KENT STIGALL: Okay Oak Park.
- >> VICE CHAIR KELLOM: Yep. All right. I had my lunch so now I'm not even speaking with any sort of specificity. In the top little corner of Oak Park too.
- >> MR. KENT STIGALL: Three is, you know, three is pretty much there as far as numbers, total numbers. So three right there.
  - >> MARCUS MULDOON: Is good.
  - >> VICE CHAIR KELLOM: That is good.
- >> MR. KENT STIGALL: I don't mean to Zoom in and out, my mouse button rolls like that. It kind of...so what you are looking at is seven heavily under populated. Of course nine has not been messed with so it's fine. 11 is a little over -- some overpopulated, a little actually. And that would leave all this white area as your team.
- >> VICE CHAIR KELLOM: Not all of it. So we can work on seven, leaving that little puzzle piece cut out like it is. Seven is going to wrap into.
  - >> MARCUS MULDOON: Between three and nine?
- >> COMMISSIONER KELLOM: Yeah, I mean it will wrap into nine and then probably take some, uh-huh, I'm saying uh-huh to myself. Y'all don't know.
- >> CHAIR EID: What you have there is Birmingham. Where is Birmingham to what you want to draw, 7, 9 or 10?
  - >> MARCUS MULDOON: This will be in 7.
- >> VICE CHAIR KELLOM: It will be nine, it will be nine Royal Oak, Birmingham, Troy, a piece of Troy, yeah.

- >> CHAIR EID: Commissioner Orton?
- >> CHAIR ORTON: I'm just wondering are you trying to draw the districts more horizontal rather than vertical?
  - >> COMMISSIONER KELLOM: Right.
  - >> COMMISSIONER ORTON: 7 and 9.
- >> VICE CHAIR KELLOM: These districts go a little bit more vertical and kind of Tetris into each other. But I think now we just have different drawing styles that's all. I'm not worried about the empty chunk down there. What I'm trying to do is get 7 and 9 together and then that will give the empty space for 11. Does that make sense?
  - >> MARCUS MULDOON: Yeah.
- >> VICE CHAIR KELLOM: Okay, if we get 7 and 9 together, then you'll know what to assign for 11.
  - >> MARCUS MULDOON: Got it.
- >> MR. KENT STIGALL: You could take the few precincts right here, Roseville out of 11 and 11 number wise, you know, total number.
  - >> MARCUS MULDOON: Be good.
- >> VICE CHAIR KELLOM: All of that would be ultimately unassigned but it just depends how you want to approach it. Like either we can keep going to the direction that we were going in and worry about 11 in a minute. Or I don't know. I just whatever you want to do, Commissioner.
- >> MARCUS MULDOON: No, we can continue with seven otherwise I don't want to screw it up over.
  - >> MR. KENT STIGALL: So am I hearing say put Birmingham.
  - >> MARCUS MULDOON: Birmingham is going to end up in nine.
  - >> VICE CHAIR KELLOM: It is, yeah.
  - >> MR. KENT STIGALL: In nine. What about this little piece of seven I guess?
  - >> COMMISSIONER KELLOM: No, that stays where it is. For right now.
- >> MR. KENT STIGALL: Okay, what I'm saying is this -- these are two pieces of seven, so this either has to be in, let me just do it like I'm talking about, so you are saying put this in nine.
  - >> VICE CHAIR KELLOM: Yes.
  - >> MARCUS MULDOON: Yes.
  - >> MR. KENT STIGALL: Not that.
- >> VICE CHAIR KELLOM: Right, put that into that empty or assign that piece into nine.
- >> MR. KENT STIGALL: Okay, all right. So when I do that, at this point this little piece has to go into nine with this piece has to go into seven or we can split them. Because that precinct makes seven dis-contiguous. I guess I'm getting ahead.
- >> VICE CHAIR KELLOM: I just want to get the shape. We can clean it up. If it makes you feel better sure.

- >> MARCUS MULDOON: It's something you have to deal with.
- >> MARCUS MULDOON: Put it in seven for right now, we can always adjust it.
- >> MR. KENT STIGALL: So that splits Birmingham but anyway and some little idiot, me, had that highlighted. I will put that back in 11 where it was.
  - >> VICE CHAIR KELLOM: So can you Zoom in?
  - >> MR. KENT STIGALL: What area?
  - >> COMMISSIONER KELLOM: No, the empty space that is at the bottom of nine.
  - >> MR. KENT STIGALL: Okay that is Clawson.
- >> VICE CHAIR KELLOM: I need A Street so Hazel bark is in with nine, at the bottom of nine, I need it more, yep.
  - >> MR. KENT STIGALL: You want to bring that all the way down to here now?
  - >> COMMISSIONER KELLOM: Yes, 8 Mile is the southern border of nine.
  - >> MR. KENT STIGALL: Basically run it.
  - >> VICE CHAIR KELLOM: All of that, yes.
  - >> MR. KENT STIGALL: To nine.
- >> VICE CHAIR KELLOM: I wanted to make sure the eastern border was west end and 696.
  - >> MR. KENT STIGALL: This eastern border is a Township boundary.
- >> VICE CHAIR KELLOM: Uh-huh, that should be industry, but it doesn't look like it either.
  - >> MR. KENT STIGALL: Dequindre. Is Hazel Park?
- >> VICE CHAIR KELLOM: That is too much, that is too much into nine so the pointer should be left out and go on to another District, same thing with John R.
  - >> MR. KENT STIGALL: Okay, what should I be doing now?
  - >> COMMISSIONER KELLOM: Okay, Zoom back in.
  - >> MR. KENT STIGALL: All right.
- >> VICE CHAIR KELLOM: Zoom in some more. You can select that bottom half closest to 8 Mile, the bottom portion right next to Oak Park, select that into nine. Not that other piece of Hazel Park. You know, I know.
  - >> MR. KENT STIGALL: Just this part.
  - >> MARCUS MULDOON: Where the blue line is cutoff.
  - >> VICE CHAIR KELLOM: Exactly keep going north and that piece of Royal Oak.
  - >> MR. KENT STIGALL: Something like that?
- >> COMMISSIONER KELLOM: Yes and the next piece going north. No, not that, yes, to the left, to the left of the blue line, yep, all of that.
  - >> MR. KENT STIGALL: That?
- >> COMMISSIONER KELLOM: Yes and those bottom pieces of nine, leave that little jut out the way that it is, just to the left, but that little cut out is in nine. And the one to the left of it is.
  - >> MR. KENT STIGALL: Put those in nine?

- >> COMMISSIONER KELLOM: Yes, please. Can you Zoom out? I can't see the blue matrix is blocking what I need to see. Okay.
- Can you Zoom back out to the western piece of nine? And go north, scroll up to the corner, can you Zoom in again? No, not that north. Go back south. Okay, right there. Can you go west, please? That blue line, is that Long Lake?
- >> MR. KENT STIGALL: South Boulevard right there where the cursor is, south Boulevard.
- >> VICE CHAIR KELLOM: Okay so south of south Boulevard should be Long Lake, west Long Lake, just south of south Boulevard. It's going to be one of the main streets. I think you went too far.
  - >> MR. KENT STIGALL: Is that 75?
- >> VICE CHAIR KELLOM: What is the blue line right there where your mouse is, the point of your mouse?
  - >> MR. KENT STIGALL: South Boulevard.
  - >> VICE CHAIR KELLOM: So keep going south, it should be the next Major Street.
  - >> MR. KENT STIGALL: It's labeled 75, route 75 or is it way down here?
  - >> COMMISSIONER KELLOM: Keep going.
  - >> MR. KENT STIGALL: That is Long Lake.
- >> VICE CHAIR KELLOM: That is Long Lake. Okay, so that -- see what does it look like a lobster claw, that line going north to west Long Lake, that should be selected but nothing above that. That western boundary, right there, if you travel up to Long Lake, right there, yes.
  - >> MR. KENT STIGALL: Okay.
- >> VICE CHAIR KELLOM: So I would unassign that small, exactly where your mouse is, the tip of it. I would unassign that little jig saw and go across using Long Lake as the boundary.
- >> MR. KENT STIGALL: So I'm just going to select it here. What I heard was unassign along here.
- >> VICE CHAIR KELLOM: Yes, along Long Lake, yep, in that little weird piece right there.
- >> MR. KENT STIGALL: Trying to get mine so unassign this. Or put it in seven, I don't know.
- >> VICE CHAIR KELLOM: Yeah, you can just say put it in seven for right now. I think you might unassign too much.
- >> MR. KENT STIGALL: I have not done anything. Just looking at it. So this is Long Lake across here. So if we just try and get an idea. So you are saying.
  - >> VICE CHAIR KELLOM: Right there and then stop, uh-huh.
  - >> MR. KENT STIGALL: Put those in seven.
  - >> VICE CHAIR KELLOM: Yes.
  - >> MR. KENT STIGALL: There is your marker for Long Lake.

- >> COMMISSIONER KELLOM: Thank you. Okay, so that top half of nine should go into seven.
- >> MR. KENT STIGALL: I'm just highlighting it. I'm not going to assign anything until...so that is 100,000 people.
  - >> MARCUS MULDOON: It should make seven right.
- >> MR. KENT STIGALL: Very close, assign it. So seven now still needs some. Could it need like that or something?
  - >> COMMISSIONER KELLOM: That is exactly what it is. You got it, Kent.
  - >> MR. KENT STIGALL: I got the idea, all the way across or just right here?
- >> COMMISSIONER KELLOM: All the...I don't think it's all the way across. What is That Street? That is Long Lake.
  - >> MR. KENT STIGALL: This is Long Lake down here.
  - >> VICE CHAIR KELLOM: It should be square Lake right there yep.
  - >> MR. KENT STIGALL: That goes into seven?
- >> COMMISSIONER KELLOM: Leave that, the part you have assigned sorry I thought you were talking where your mouse is the part you selected that goes into seven. The stopping point.
  - >> MR. KENT STIGALL: This is Emerald Lake. This is Long Lake down here.
  - >> VICE CHAIR KELLOM: Long Lake goes to Dequindre.
  - >> MR. KENT STIGALL: As far as your numbers.
  - >> VICE CHAIR KELLOM: The two precincts will probably go into seven.
  - >> MR. KENT STIGALL: These two?
  - >> COMMISSIONER KELLOM: Yep. Yes, rather.
  - >> MR. KENT STIGALL: Okay.

## Number wise it's close to ideal.

- >> VICE CHAIR KELLOM: Let's leave it right where it is.
- >> MARCUS MULDOON: Then.
- >> MR. KENT STIGALL: Now, is this area down in here going to be ten? Is that what I'm...or do you intend to bring 11 down?
- >> COMMISSIONER KELLOM: I'm trying to sign in over here because my computer is about to die.
  - >> MR. KENT STIGALL: Because there is East Point.
  - >> MARCUS MULDOON: How many people is left unassigned?
  - >> MR. KENT STIGALL: 240 which means.
- >> MARCUS MULDOON: So we can take all the unassigned and make it ten so we have all the districts in, and the population will all be close.
  - >> MR. KENT STIGALL: Well, and then.
  - >> MARCUS MULDOON: There is going to be some adjustment.
  - >> MR. KENT STIGALL: Take some out of 11 and put it into 10.
  - >> MARCUS MULDOON: Yeah, let's do that.

- >> MR. KENT STIGALL: And maybe a little bit more. So if you kind of just kind of got it.
- >> MR. KENT STIGALL: This is with four, this is the funny cut out here. In the other plans, we ran into it but...this is the Township boundary and looks like this little census block should be in 12.
  - >> MARCUS MULDOON: Yeah.
- >> MR. KENT STIGALL: Just because of the way it's sitting there. And how you do the others I'm guessing the rest of them into in ten. Ten is missing quite a few, 11 has extra, nine is missing some. Earlier we had moved these two precincts. Didn't mean to do that. Earlier we had moved these two precincts into 12. Mainly, so.
  - >> MARCUS MULDOON: I will stop there and let someone else adjust it from there.
- >> VICE CHAIR KELLOM: Yeah, what I will say is that 10 and 11 is supposed to be like a reverse boot around nine with Hayes being the stopping point, which is that blue line that is going north and south. And then there will be room too and the population.
- >> MARCUS MULDOON: Someone else can adjust it. I was looking at the population signed into a District, and they just got to adjust it a little bit.
- >> VICE CHAIR KELLOM: Totally, I was just saying and just giving some conversation to it.
  - >> MR. KENT STIGALL: I think you just need to spread some population.
  - >> MARCUS MULDOON: Good, Commissioner Eid.
  - >> MR. KENT STIGALL: So just...
- >> CHAIR EID: Okay, making progress, folks, making progress. Can you just Zoom out on this one for a moment?
  - >> MR. KENT STIGALL: More so?
  - >> CHAIR EID: No, that is perfectly fine.
  - >> MR. KENT STIGALL: So well we did 1, 2, 4, all the way around.
  - >> CHAIR EID: Yeah, I see it.
  - >> MR. KENT STIGALL: 12 didn't change much.
  - >> CHAIR EID: Yeah.
- >> VICE CHAIR KELLOM: It has some population from ten in the corner. I think too much was assigned to that little portion of ten.
- >> CHAIR EID: I just can you go up to seven? I just want to see what it is. So it's looking like Pontiac, Rochester Hills essentially. And parts of, no, Birmingham is in nine. Pontiac and Auburn Hills and Rochester Hills. All right, thank you folks. Does that conclude your turn, Mr. Muldoon?
  - >> MARCUS MULDOON: Yes.
  - >> CHAIR EID: All right.
- >> MR. KENT STIGALL: Excuse me should I run the checks on this and clean it up so that it's not -- so it's accurate? What I'm saying is there are pieces missing like right there.

- >> VICE CHAIR KELLOM: You can but it's not finished at all. If it was what I was going for this would not be it. So I wouldn't run any numbers on this map because it's not finished, it's not configured correctly.
- >> CHAIR EID: Let's wait on that so other folks can edit it and once all that is done you can run all the checks.
  - >> MR. KENT STIGALL: Okay, just want to make note that it's incomplete.
- >> CHAIR EID: Yep, all right Commissioner Orton, you are up next. We have about 15 or so more minutes of mapping time. But we can start up with you at the next meeting if you don't finish.
- >> COMMISSIONER ORTON: Okay. I don't have Commissioner Kellom's vision on that so I don't want to finish that map but there is one that needs to be finished from the other day 042924 version 3, I think.
- >> MR. KENT STIGALL: We can take a quick look at it. So I think this was an incomplete map. Yes, it's missing three districts. So, yep, there it is. So.
  - >> COMMISSIONER ORTON: Okay.
- >> CHAIR EID: I thought we completed this, didn't we complete it in version four in the same day?
  - >> COMMISSIONER ORTON: There is a version four.
  - >> CHAIR EID: Ms. Schaar, I see your hand.
- >> MEGHAN SCHAAR: That is correct. So Commissioner Vallette finished working on what was 42924 version 3. When Commissioner Weiss picked up. It was resaved as a new version number even though it was a continuation. He did not like delete out anything. So that became 42924 version 4. And that did end as a completed map.
  - >> COMMISSIONER ORTON: Okay.
  - >> MEGHAN SCHAAR: For what it's worth.
  - >> MR. KENT STIGALL: Excuse me?
  - >> CHAIR ORTON: Could we see version four then of this map?
- >> CHAIR EID: You could still take that one and move in a different direction if you want to, Commissioner Orton. I don't want to steal your thunder there.
  - >> MR. KENT STIGALL: 3 and 7, 8, 11 and 10 were drawn.
  - >> MR. KENT STIGALL: This 11 is similar to what was just done.
- >> COMMISSIONER ORTON: Okay, well, I think do I want to start a new one? I want us to have options. I like some of this. I like some of lots of different pieces. So let's open a new one that is Linden with the districts the six Districts that we have to change removed. I don't know if you already have it saved that way or if we just go in.
- >> MR. KENT STIGALL: I just made a copy of Linden right here. And give it today's date. Is this number four I guess today? Should it be four or three?
  - >> COMMISSIONER ORTON: I don't know.
- >> MR. KENT STIGALL: We are going to make it four. Should have been three but that is okay.

I will rename. I don't want to get.

- >> COMMISSIONER ORTON: You are changing it to three?
- >> MR. KENT STIGALL: Huh? Yes.
- >> COMMISSIONER ORTON: Are you?
- >> MR. KENT STIGALL: Yes. Changing it though. There we go. We will go in here and just delete the districts, affected districts. And that's delete.
  - >> COMMISSIONER ORTON: One, three.
  - >> MR. KENT STIGALL: Yeah.
  - >> COMMISSIONER ORTON: Six. Eight.
  - >> MR. KENT STIGALL: Eight and ten.
  - >> COMMISSIONER ORTON: And 11.
  - >> MR. KENT STIGALL: You going to leave all the others as is? I mean or all those?
  - >> CHAIR ORTON: Yeah, let me just look at it a minute. Okay.
- >> MR. KENT STIGALL: Now do you want to lock any districts, so we don't edit them?
  - >> CHAIR ORTON: I think delete District 2.
  - >> MR. KENT STIGALL: Erase it is that what you said?
  - >> CHAIR ORTON: Yeah, yeah. And then you can lock all of them except for seven.
  - >> MR. KENT STIGALL: All the surrounding 4, 5, 13 and 12.
  - >> COMMISSIONER ORTON: Yeah, that is fine.
  - >> MR. KENT STIGALL: Okay, all right.
  - >> COMMISSIONER ORTON: Okay.
- >> CHAIR EID: Mr. Stigall, I'm having a little bit of trouble hearing you. I don't know if anybody else is having that problem. But.
  - >> MR. KENT STIGALL: Maybe I'm not talking very loudly probably. All right.
- >> COMMISSIONER ORTON: So I like, let's see, I think the Detroit District from I think it was the one that Commissioner Muldoon and Commissioner Kellom were just working on, that Detroit District, the very bottom one. Can we put that as an overlay?
- >> MR. KENT STIGALL: If I can remember how to do it. I took expert shape file, let me see here. Just a second. Yeah, we can because of the way I have done this well, the ones they did today I don't know I would have to go in there and export and bring them in. If you have a minute I can do it. But I have to close this, bring those in.
  - >> COMMISSIONER ORTON: Okay, well, we can probably just.
- >> MR. KENT STIGALL: Or do you want to start somewhere else and pick it up tomorrow?
- >> COMMISSIONER ORTON: Yeah, that would work. We can work on that. So Commissioner Kellom, when you did -- how far down did you go? I liked how it did not come very, how do I describe this, I like how it was pretty narrow down in Detroit, you know, it did not go way up but I don't know how far you came down into like Down River. Do you remember?

- >> COMMISSIONER KELLOM: Allen Park, Lincoln Park, E cores, River Rouge part of Melvindale and curve around Dearborn and east side of Detroit, Morningside all the way, and it did not include Taylor obviously. I should not say obviously but it did not include.
- >> COMMISSIONER ORTON: Okay, so okay let's do a District 2. Do I want to start here? Maybe not, hold on the neighborhoods are good. But scroll up and let me see up at the top.
  - >> MR. KENT STIGALL: Further up?
- >> CHAIR ORTON: Yeah, right there is fine on my screen I might be lagging behind and just seeing at the top so.
  - >> MR. KENT STIGALL: Warren, Sterling Heights, Royal Oak.
- >> COMMISSIONER ORTON: I see that, okay, fine, we will just start here and see what this looks like. Please select all of the unassigned down to like Warren, just to get population started. And that can be District 11.
  - >> MR. KENT STIGALL: Right.
  - >> COMMISSIONER ORTON: I don't know if you locked 24.
- >> MR. KENT STIGALL: I don't know if I did but pretty sure we will use whole presents right through here so we should be all right.
  - >> COMMISSIONER ORTON: You changed the color. 11 is always an issue.
  - >> MR. KENT STIGALL: Yes, 11.
  - >> COMMISSIONER ORTON: Choose the Sterling Heights over there.
  - >> MR. KENT STIGALL: All of Fraser? All of Fraser?
  - >> CHAIR ORTON: Yes, please. Okay, Roseville. And East Point probably.
  - >> MR. KENT STIGALL: Well, yeah, that is going to go over right there.
  - >> COMMISSIONER ORTON: Oh, it is.
  - >> MR. KENT STIGALL: Without even getting.
- >> COMMISSIONER ORTON: We always get to a point where we have to split something right here.
  - >> MR. KENT STIGALL: 26,000 over.
- >> COMMISSIONER ORTON: Yeah, okay so I see a horizontal line there in Roseville.
  - >> MR. KENT STIGALL: Yes.
- >> COMMISSIONER ORTON: I don't know how to describe it. That one about where your cursor is.
  - >> MR. KENT STIGALL: 12 mile.
- >> COMMISSIONER ORTON: Okay great can you choose everything you put in 11 south of that and just see how much that population is?
- >> MR. KENT STIGALL: That chunk right there is 30,000. So 20 more thousand and change. So you are close.
  - >> COMMISSIONER ORTON: So unassign that or put it in District 10.

- >> MR. KENT STIGALL: Okay,11 is 1.16% low.
- >> COMMISSIONER ORTON: So, actually, up in 11, it looks like we grabbed part of Warren.
  - >> MR. KENT STIGALL: Yes.
  - >> COMMISSIONER ORTON: So can you unassign that?
  - >> MR. KENT STIGALL: Yes.
  - >> COMMISSIONER ORTON: And maybe we will go lower in Roseville.
  - >> MR. KENT STIGALL: Yep so you have a significant chunk more.
- >> COMMISSIONER ORTON: So go down to that next line, yeah. Probably not that much. Half of that.
  - >> MR. KENT STIGALL: Something like that?
  - >> CHAIR ORTON: That's what I was thinking.
- >> MR. KENT STIGALL: That will work. And not that. So your 11 number is .54% within.
  - >> COMMISSIONER ORTON: Great. Okay.

So then 10 we will take Warren, Centerline and East Point. Wait, but not that part of 11. You can lock 11 if it makes it easier.

- >> MR. KENT STIGALL: So this is going to go to ten. Okay, I'm sorry.
- >> COMMISSIONER ORTON: Let me see to the west. Okay, so how much, well, grab that little piece, yeah, that piece right there, so it will be assigned.
  - >> MR. KENT STIGALL: It could probably be in nine.
- >> COMMISSIONER ORTON: We haven't changed nine yet so let's just leave it there. Grab Madison Heights to see how much the population is.
  - >> MR. KENT STIGALL: Hazel Park that is 29,000.
- >> COMMISSIONER ORTON: Okay, add that in. And then add Clawson and probably Royal Oak. Oak Park.
  - >> MR. KENT STIGALL: 22000 I guess. So that is 15,000. And you want that?
- >> CHAIR ORTON: Yes, please. Can you scroll a little bit to the northwest so I can just see the rest of unassigned area?
  - >> MR. KENT STIGALL: It goes to Birmingham.
  - >> COMMISSIONER ORTON: Right.
  - >> MR. KENT STIGALL: And down into Wayne County.
- >> COMMISSIONER ORTON: And we need just a little more. Okay so just take those three precincts right there, no, not those. Down, yes, where your cursor just was.
  - >> MR. KENT STIGALL: I a cross here?
  - >> CHAIR ORTON: Yes.
  - >> MR. KENT STIGALL: And that should do it.
- >> COMMISSIONER ORTON: Okay, so I don't know Royal Oak, but I would have preferred to keep it together. And I don't know if it should go with this area, with

Madison Heights or if it would be better going with like with Oak Park. So does anyone have an opinion?

- >> CHAIR EID: With can you repeat what you're asking again Commissioner?
- >> CHAIR ORTON: So Royal Oak I took a part of Royal Oak for population. But I don't know if I took a good part or if that part should be more with the things that are south of it.
  - >> CHAIR EID: Ten is full right now?
  - >> CHAIR ORTON: Ten is good, yeah. It can lose a little bit.
- >> CHAIR EID: I probably would try to take all of Royal Oak out of it and stopping Clawson, Madison Heights then you could do Royal Oak with Birmingham, Oak Park, Berkeley but it could go the other way too. Commissioner Andrade?
  - >> ELAINE ANDRADE:
  - >> CHAIR EID: Commissioner Andrade, did you have something to add?
  - >> ELAINE ANDRADE: Just wondering if you wanted to take ten south of 8 Mile.
  - >> COMMISSIONER ORTON: Maybe.
- >> ELAINE ANDRADE: Because they talked about a community of interest spanning that line into Warren.
  - >> COMMISSIONER ORTON: Okay if you can help me know where.
  - >> ELAINE ANDRADE: Yeah.
  - >> COMMISSIONER ORTON: Go ahead.
- >> ELAINE ANDRADE: No, I was going to say maybe Commissioner Kellom would be better at the exact neighborhoods. But I would say that like up there Berkeley, Royal Oak, that would go together with Oak Park.
  - >> COMMISSIONER ORTON: Yeah, that is what I was thinking.
  - >> ELAINE ANDRADE: Yeah.
- >> COMMISSIONER ORTON: I don't know what is easier unassign or create another number to take out Royal Oak and probably Clayton too.
- >> MR. KENT STIGALL: Yeah or we can just put it in eight because I think that is kind of where it's distinct and there is nothing in eight.
  - >> COMMISSIONER ORTON: That is fine.
  - >> MR. KENT STIGALL: We will just assign it to eight for now and Clawson.
  - >> COMMISSIONER ORTON: Yes.
  - >> MR. KENT STIGALL: And you got.
  - >> COMMISSIONER ORTON: Yeah, that little piece.
- >> MR. KENT STIGALL: I don't know, I guess that goes more up there. So now ten is, you know, you can put 35,000 people into 10. If I remember right and Commissioner Kellom can point this out I think Sherwood was one that went north. No, I shouldn't.
- >> COMMISSIONER ORTON: How much population is it if you kind of just take that top row where there is kind of a straight line there? Which is obviously a road.

- >> MR. KENT STIGALL: That area of neighborhoods of course you want to get the rest of the neighborhoods I guess.
  - >> COMMISSIONER ORTON: Yeah.
  - >> MR. KENT STIGALL: It's 34,000 and 10 is missing 34,000 so.
  - >> COMMISSIONER ORTON: Okay, well, let's do that for now. Assign that.
- >> MR. KENT STIGALL: Of course we need to go in and clean up the little pieces to make it more neighborhood friendly.
- >> COMMISSIONER ORTON: Yeah, let's do that. I would like to follow the neighborhood lines.
  - >> MR. KENT STIGALL: Okay so we will go to blocks.
  - >> CHAIR EID: And this might be a good place to pause for today.
- >> COMMISSIONER ORTON: Can I just instruct Kent to clean that up, so it all follows the neighborhoods?
- >> MR. KENT STIGALL: Right here, yes, I will do that. And can I stop sharing my screen at this time?
- >> CHAIR EID: Yeah, go ahead, Mr. Stigall. Thanks for your assistance today. And we will continue with Commissioner Orton when we resume on Tuesday.

That concludes this afternoon's mapping session. We will move on to the next thing on the agenda, which are approval of the minutes from April 29th and April 30th. The draft minutes have been provided to the Commission before this meeting and have been posted on the website. I will now entertain a motion to approve the minutes.

- >> COMMISSIONER LETT: So moved.
- >> COMMISSIONER WEISS: Second.
- >> CHAIR EID: We have a motion and a second to approve the minutes from April 29th and April 30th. Is there any discussion, any edits to the minutes? Anything like that? Seeing none, we will move to vote. All those in favor of the motion to adopt the minutes from April 29th and April 30th please raise your hand and say aye.
  - >> Aye.
  - >> CHAIR EID: Any opposed? The ayes have it and the minutes are adopted.

Next up on the agenda is the Executive Director's report. We do have a report today. So without objection I will ask MICRC Executive Director Edward Woods III to provide his report. Is there any objection? We will move on then. The floor is yours, Mr. Woods.

>> MR. EDWARD WOODS: Thank you, Commissioner Eid. And members of the Commission. Just want you to know that we are meeting with the state budget office with regards to our fiscal year 24 supplemental request. Want to thank Commissioner Orton for assisting with regards to that project. Very much. And just want to share with you, I provided you with a copy of the quarterly report with regards to March. We did receive this last night and I had a chance to review it from our insights three financial group. We are at currently is everybody able to see the screen? I just want you to

know we have as of March 31, once again as of March 31st 465,867.16. I want to repeat I want to repeat for the rest of the fiscal year and want to make sure everyone is clear for the remaining six months we have 465,867.16. I expect us to run out of money in June sometime. So we are really trying to push this supplemental. And I'm meeting with the state budget department as well as the Senate appropriations Chair and their staff. So I just wanted to make sure everyone understands how serious our situation is as relates to this. Because as you know we still have the month of April that we need to pay. And then we are doing public hearings in May. And public hearings in June. Plus all the legal costs. So once again all of this is the result of litigation, our increased costs, increased costs as a result of litigation. And you can see that with regards to facilities. You know we were only planning to do remote meetings. We were never planning to do in-person meetings. And so you see an increase there. And obviously, which is related to litigation. And then obviously again with regards to the consultant, our line drawing, litigation, litigation counsel, local counsel, our promotional in terms of getting the word out about our meetings is all related to litigation and our VRA counsel. So just wanted to make sure everyone understands this is all related to litigation. The event planning contract that we had with Taylor planning is related to litigation as well.

So just kind of wanted to share with you where we are. What we are doing with regards to this. And our request is in for 3,331,200 to cover our costs is what the Commission voted. We sent a letter, February 23rd, with regards to that. And so they are saying stuff it gets moving in June, so we are just hoping that things move quick enough so that we have funds to continue the work in meeting our obligations to the Court as a result of litigation.

If there is any questions with regards to the report, the state budget office, the Senate appropriations Chair, I have also stopped and knocked on the door of the House appropriations Chair as well. And I have not received a call just yet. So hopefully things will be moving quite quickly with regards to this request.

If there is any questions, I can take them. All right, if not, we will go to the next item. And this is dealing with our public hearings next week. We are at the Warren community center May 7th from 10-12:30, 1:30 and 3-7 at Pearl event from 10-12:30, 1:30 to 3 and 4 to 7 and last but not least Wayne state University student center from 10-12:30, 1:30 to 3 and 4 to 7. We want to encourage the public to come out and show up and speak up and raise your voice in trying to assist the Commission to draw the maps to ensure your community of interest is represented. Once again to ensure that your community of interest is represented. So we really want to encourage people to come out. You can also, if you want more information go to our website www.Michigan.gov/MICRC. Or if you have questions you can call us at 1-866-627-3247. That's 1-866 map fair, map fair being 866-627-3247 to answer any questions you may have and also wanted you to know we will have someone that can assist anyone with mapping. If you don't know how to map your community of interest

or you want to make sure that your community of interest is represented, come to the public hearings and we will have someone able to assist you during that time. I want to thank all the Commissioners that have gone out and done public outreach whether it's in person or virtual. It is greatly appreciated and getting the word out. I shared with you the interview that both Commissioner Anthony Eid and Brittini Kellom did yesterday from CBS Detroit. So thank you. We will be out in the newspapers this weekend as well. And there are some other additional outreach activities that are being done. Our social media, our PR firms are saying if you can, those of you on social media, please share our Facebook Page, please share our Instagram Page, please share from your social media accounts the work that's going on with the Commission so that we can get as much citizen participation as possible. Whether it's in person or virtual or online through our public comment portal or mapping portal. Thank you so much. And I am finished, Commissioner Eid, with my report.

- >> CHAIR EID: Thanks. Commissioner Szetela, I see your hand, do you have something to add?
- >> COMMISSIONER SZETELA: Yeah I have a question about next week are we still mapping next week? Because it's a public hearing or are we not mapping next week?
- >> MR. EDWARD WOODS: You are doing both, Commissioner Szetela. If there is you know one to provide public comment you are mapping next week.
  - >> COMMISSIONER SZETELA: Thank you.
- >> CHAIR EID: Okay, thank you, Executive Director Woods. Are there any announcements or acknowledgments? Commissioner Szetela, do you have something new or is that the previous hand?
  - >> COMMISSIONER SZETELA: Oh, sorry.
- >> CHAIR EID: All good. Just want to thank everyone for a good week especially today. Today I thought went quite well. We are out here trying to get the job done and working collaboratively and that's what I like to see. So thanks to all of you. And I hope everyone has a good weekend. Any other announcements? With that said, the items on the agenda are complete and the Commission has no further business. A motion to adjourn is in order.

- >> CHAIR EID: You know I think Commissioner Orton beat you to the punch that day, Commissioner Lett. We have a motion from Commissioner Orton and I don't think we had a second yet. Anyone?

- >> CHAIR EID: And a second from Commissioner Vallette. Is there any discussion on the motion? Seeing none we will move to vote. All those in favor of the motion to adjourn please raise your hand and say aye.
