Please give the City of Midland a congressional district that puts Midland County back together and in a separate district than Flint. You have provided alternative maps in areas where you have received multiple competing comments. You have not done this for Midland. This commission has shown partisan bias by putting forth maps that local Democrats have asked for. Midland and Flint are vastly different communities. Midland's population is 40,000, Flint's is nearly 100,000. Midland is focused on dam repair and flood damage repair to homes, businesses, and infrastructure, Flint is on its water crisis. There is no good reason for slicing it up. Many community programs run county-wide and could be negatively impacted by the division of representation.

The separation of Midland County from Gladwin County is also a concern. Both of these counties share similar interests related to the restoration and maintenance of the dam/lake system of the Tittabawassee River watershed. Dear Commissioner Szetela:

I write on behalf of *The Detroit News* regarding the Michigan Independent Citizens Redistricting Commission's decision to hold a closed-door session to discuss voting rights issues with legal counsel during the Commission's meeting on October 27, 2021. It has been brought to my attention that the Commission intends to again meet behind closed doors, perhaps as soon as Monday, November 8, 2021. I write to ask that the Commission reconsider this decision and conduct all of its meetings in open session, as required by the Constitution and by general principles of fairness and transparency. I also request that the Commission release any documents discussed and minutes taken during the closed session on October 27, 2021.

The Commission's decision to act in secrecy is deeply concerning. As an initial matter, the Commission's actions appear to be unconstitutional. The Michigan Constitution provides that "[t]he commission shall conduct *all of its business* at open meetings." Art IV § 6(10) (emphasis added). This language is unconditional: it does not permit the Commission to meet for any reason in closed session. More fundamentally, the Commission's actions contradict its own public commitments to conduct a transparent process. To meet in secret to discuss issues of such vital importance—including historic discrimination in voting in Michigan and compliance with the Voting Rights Act—threatens to erode public confidence in the Commission's crucial assignment.

The Commission's efforts are of grave importance to the citizens of this State, and they should be undertaken in public and under the observation of Michigan's press and other concerned observers. I have reached out to additional media entities and other organizations who share *The News*'s concerns to discuss potential avenues to challenge the Commission's actions, and I intend to continue these efforts. *The News* hopes that the Commission will conduct all further business in open meetings, as the Constitution requires. If it does not, *The News* will consider all appropriate legal options to ensure transparency.
