Hello Anthony,

My name is Amer Zahr and I'm a resident of Dearborn, a political activist, and a law professor. I'm also a member of Dearborn-based AAPAC, the Arab American Political Action Committee.

I'm writing to you about the redistricting process. I'm extremely concerned with the latest State House maps published by the MICRC as they relate to Dearborn and the Arab American community. The latest maps split Dearborn down the middle and greatly dilute the Arab American vote.

I presented to the commission on September 7 in Lansing about the concerns of the Arab American community. In that presentation, I expressed support for the Fair Maps map as it related to Dearborn. Also, I cautioned the commission on using raw numbers for VRA purposes in the Dearborn area, as Arab Americans are still incorrectly counted as white by the Census Bureau, when we are clearly a marginalized community of color.

The maps that include most of East Dearborn in a State House district that also includes Detroit dilutes our vote. The maps that you have published for the State House now have no districts that are majority Arab American, in the US state that has the highest concentration of Arab Americans in the nation. Dearborn, further, is informally known as the Arab American capital and is home to the only Arab American National Museum.

The AFL Fair Maps project proposed a map that accurately reflected Dearborn as a community of interest. That map took into account the concentrated Arab American community in Dearborn, and proposed a district that was entirely located in the city, only excluding a few non-Arab neighborhoods to achieve the required population numbers.

Finally, while we are counted as White on the census, a number of court cases have recognized the Arab American community's ability to sue under federal law as a racial minority. In fact, a 1987 Supreme Court case established this principle. In other words, the courts see our community as one that could sue under the VRA, even though we are incorrectly counted as White.

I urge you all to modify the State House districts to create a Dearborn district that more accurately reflects our community. The AFL Fair Maps project does a great job of this. If you don't remedy this, the Arab American community in Michigan will likely be left with no representation in Lansing, a disastrous outcome indeed.

As I study and teach these exact subjects, I'm happy to provide any more information or testimony as needed.

Redistricting is important because the new legislative maps will determine the political landscape in Michigan for the next 10 years. Dear Chair Szetela and MICRC Commissioners,

I write to you today as an individual member of the Midland County Board of Commissioners to make sure the residents of our community's voices are heard. We have a duty and responsibility to represent our constituents to the best of our ability and to promote the interests of our City and County. Providing basic services, such as maintaining a reliable water supply, ensuring safe transit systems, and encouraging investment in our City and County are core responsibilities for us. More recently, our mission has expanded to ensure the complete recovery from both the global pandemic as well as the dam failures and subsequent flooding that occurred in May of 2020 in our area's Tittabawassee watershed.

We have been able to make significant advancements in all these areas with the help of our unified representation in Lansing and Washington, D.C. In Lansing, our representation has been able to advocate for:

- PPE supplies for area residents and businesses in need throughout the pandemic
- More than \$200 million in funds to help rebuild the four dams along the Tittabawassee River as well as resources for flood mitigation

In Washington, D.C. as a unified county, there's been no confusion on our area's representation. As a result, the Midland community has benefited from:

- A federal disaster declaration opening the door to federal resources during and after the flooding.
- More than \$100 million in direct federal disaster assistance, through FEMA, USDA Rural Development, SBA, USDOT, and many other agencies.
- SBA disaster loans EIDL and PPP to address businesses' needs during this ongoing pandemic.

Unfortunately, your efforts threaten to undermine how far we have come as a community. The City of Midland has been sliced and diced, and separated completely from the rest of the county in almost all iterations of your State House and Congressional maps and in the State Senate map we have no version that represents our community.

I, the undersigned, advocate for the following: State House, State Senate and US Congressional maps that keep together the entirety of Midland County as well as keep Midland County with Gladwin County. Please reject any State House map that removes the City of Midland from the rest of the county. The current map that is referred to as a "robot arm" is particularly egregious. We ask that you move forward a State House map that puts Midland County with Gladwin County. We ask that you edit your current State Senate maps to maintain the same priority - making sure Midland and Gladwin remain together. Similarly, on the US Congressional

map we ask you to keep the City of Midland with the rest of the county and keep our county connected with Gladwin.

Lastly, I ask you to honor the will of the people. They voted by a 61 percent majority on November 6, 2018, to create the exact Commission on which you are serving. A Commission who has the responsibility to remove gerrymandering and create districts that reflect Communities of Interest.

Hello. I live at the outer edge of District 6, in Laketown Township, Allegan Co., but with a Holland,49423 address, at 6657 Tall Tree Lane. We are in the Holland Public School District, and that, I believe is a community of interest. I'm equidistant from Holland and Saugatuck, Saugatuck being in District 6.

Our local,downtown Holland bookstore does not carry the Allegan or Kalamazoo newspapers, and I feel that Holland and District 2 are my home. So I, and neighbors I have spoken with, wish that we could vote in District 2.

Holland, Saugatuck and Douglas are all lakeshore communities that cater to tourists. The City of Holland, Saugatuck and Douglas have consistently voted for the Democratic candidate for President, yet we have not had a voice in Congress, ever.

While our District 6 U.S. Representative, Fred Upton, narrowly won against a Democratic challenger in 2020, the neighboring District 2 has been winning with over 60% of the vote for Republicans for many years, if not always. I feel that District 2 is drawn in such a way as to disproportionately favor the Republican candidate. We have had good Democratic candidates, a Hope College history professor, an ER doctor from Grand Haven, another lakeshore, tourist community, and a nondenominational pastor. Yet none of these candidates achieved better than 35% of the vote.

I also feel that District 2 Republicans are unfairly advantaged by the billionaire DeVos and VanAndel families, heirs to the Amway business, who own mansions in Holland and attended Holland Christian Schools. Adding Laketown Township, Saugatuck and Douglas might help dilute the funding advantage to Republican candidates in District 2.

If adding the suggested communities to District 2 would give it too many voters, I suggest trimming some of the rural, inland towns in the north part of District 2.

Dear Commissioners,

On October 11, 2021, The Kingsley Village Council assigned me in my capacity as Village Manager to communicate to your Commission (MICRC) that the Kingsley Village Council is unanimously and adamantly opposed to the most recently proposed redistricting maps impacting Grand Traverse County Michigan State and Congressional boundaries.

Grand Traverse County is an economic engine of the North. The Village of Kingsley and Traverse City have embraced an extremely productive symbiotic intergovernmental relationship for many years that contributes greatly to the "lodestar" role that Grand Traverse County occupies as a Northern Michigan local governmental leader. On a daily basis, Kingsley and Traverse City residents live out a seamless exchange between their respective communities for work, school, commerce, worship, recreation, and social interaction.

Even though ideological and background differences exist between the two communities as is the case for most intergovernmental relationships between City and Rural communities, the residents of the two communities have embraced and thrived upon those sources of sociological and even political diversity as a primary ingredient of collective vitality and strength for Grand Traverse County.

But now, the current MICRC proposed maps for Grand Traverse County State and Congressional boundaries reflect that the knife has been drawn to sever South Grand Traverse County from North Grand Traverse County, and the rationale for that separation, understood by Kingsley Village Council members to this point, is to enable South Grand Traverse County voters to be grouped with neighboring voters in Benzie County and further west who think and vote more like the voters of South Grand Traverse County. In other words, Kingsley Village Council members can only interpret that proposed action on the part of the MICRC to send the message that diversity just doesn't matter any more.

Essentially, the message that the Village of Kingsley Council members believe they are receiving from the MICRC is that even though Kingsley residents will continue to live their lives in Grand Traverse County, experiencing life on a daily basis in commerce, worship, recreation, and

education with the wonderful up north city of Traverse City; the votes that Kingsley residents cast will now matter in another wonderful up north city......Frankfort.

The aforementioned dilemma for South Grand Traverse County residents potentially "losing a collective voice" where it matters is exemplified even more poignantly by proposed MICRC maps that suggest that the current system of the collective voters of Grand Traverse County being availed of a singular voice by one State Representative, may be replaced by a system of representation where the voice of the voters of Grand Traverse County may be split between as many as three State Representatives.

In these times of many challenges, voters look to Leaders for Leadership that makes sense. Unfortunately, for the reasons cited above, the MICRC redistricting proposal available for review to voters thus far, just does not make sense.

JOINT RESOLUTION of the Downriver Community Conference Board of Directors and the Southern Wayne County Regional Chamber June 24, 2021 WORKING IN UNIFICATION TO SUPPORT LEGISLATIVE REDISTRICTING

- WHEREAS, the Downriver Community Conference (DCC), a consortium of twenty Downriver communities in Wayne County whose total population exceeds 500,000, has joined in an effort to improve local government and enhance the quality of life for area residents through municipal cooperation; and
- WHEREAS, the Southern Wayne County Regional Chamber (SWCRC), representing 21 communities in most of the same DCC area, works in cooperation with DCC on legislation that affects this entire region; and
- WHEREAS, DCC & SWCRC have been working together as a united voice to get our regional economy restarted and on track while protecting the health and safety of our citizens. In addition to our representatives in Lansing and Washington working to provide critical resources for our region, we will need to focus on strong and effective initiatives to encompass the 'whole' of our area; and
- WHEREAS, we share common bonds linked to public policy issues or identities that may be affected by legislation; likely to result in a desire to share a united regional congressional district, and equally established state legislative districts within the region in order to secure more effective representation; and
- WHEREAS, the Downriver Mutual Aid (DMA) was created more than 50 years ago, in 1967, in order to formalize the cooperative relationships that already existed between and among police and fire departments throughout the region, for Public Safety. DCC serves as the Administrator for DMA.

For generations, communities had assisted each other when a neighbor called for help; providing backup when police officers were stretched thin during a crisis or sending additional firefighters to battle blazes that threatened a community. But with the creation of the DMA, that help grew to include a number of more sophisticated services that no single department or city could offer, such as creating a regional SWAT Team, a Crisis Negotiations Team, an Underwater Search & Recovery Team (Dive Team), Drug Enforcement Team, the Downriver Auto Theft Team (DRATT) and a Uniformed Police Task Force. Other efforts of DMA include DMA 911 and Radio Communication Services; and

WHEREAS, DCC and SWCRC share historical economic interests associated with a contiguous area on a map, together representing communities along the Detroit River from River Rouge and along the southeastern border to Rockwood, and westerly from Dearborn, Huron Township, Van Buren Township, and Belleville down to the Wayne/Monroe County line; and

- WHEREAS, Congressional and state legislative district boundaries must be drawn according to existing municipal boundaries, and shall not divide municipalities and their constituents into separate districts of representation; and
- WHEREAS, it is our priority, along with the unification of Downriver and the 21 Southern Wayne County communities into one congressional district, to support efforts to realign/redistrict our area to the strength of bringing all these communities together to benefit the region as a whole.

NOW THEREFORE BE IT RESOLVED, that the DCC Board of Directors, working in unification with the SWCRC, supports the Congressional Redistricting to encompass this region with the same representation.
