# AMENDING RULES OF PROCEDURES



Section 14.2: Amendments. These rules may be amended, with prior notice of such amendment, by a majority vote of the members present at any regular or special meeting. The prior notice requirement may be satisfied by inclusion of the initial proposed amendment(s) on the agenda and included in the Agenda package or posted to the Commission website at least three (3) days prior to the meeting at which formal action to amend is taken.

# AMENDING RULES OF PROCEDURES



Every amendment must identify the specific existing or new sections of these rules that are subject to revision or inclusion by the amendment. By adopting subsequent amendments to these Rules pursuant to this Section, the Commission ratifies all prior actions taken by the Commission.



# CANCELLATION OF MEETINGS



Section 5.4: Cancellation of Meetings. If any meeting or public hearing of the Commission must be cancelled, a notice of cancellation shall be posted on the Commission website as soon as practicable prior to the cancelled meeting or public hearing.



# SPECIAL MEETING



Section 6.2.4: Special Meetings. Special Meetings of the Commission may be scheduled by majority vote of the Commission during a meeting or may be called by the Chairperson, Vice Chairperson or the Executive Director with not less than a five (5) hour notice. The location of a special meeting shall be a place and time designated in the special meeting notice. All official actions taken at a Special Meeting shall have the same force and effect as those taken at a Regular Meeting of the Commission.



# CANCELLATION OF A MEETING



Section 5.4: Cancellation of a Meeting. The Commission may cancel a meeting by majority vote of the Commission during a meeting or by the Chairperson, Vice Chairperson or the Executive Director.



# CANCELLATION OF A MEETING NOTIFICATION



Section 5.4.1: Cancellation of a Meeting Notification. If any meeting or public hearing of the Commission must be cancelled, a notice of cancellation shall be posted on the Commission website.
